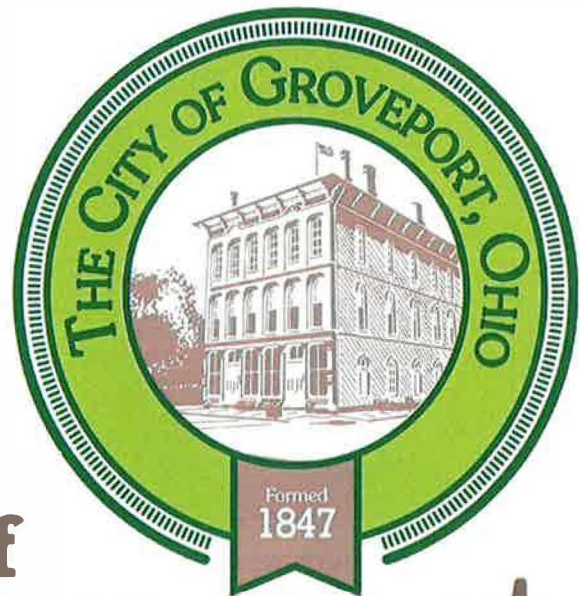

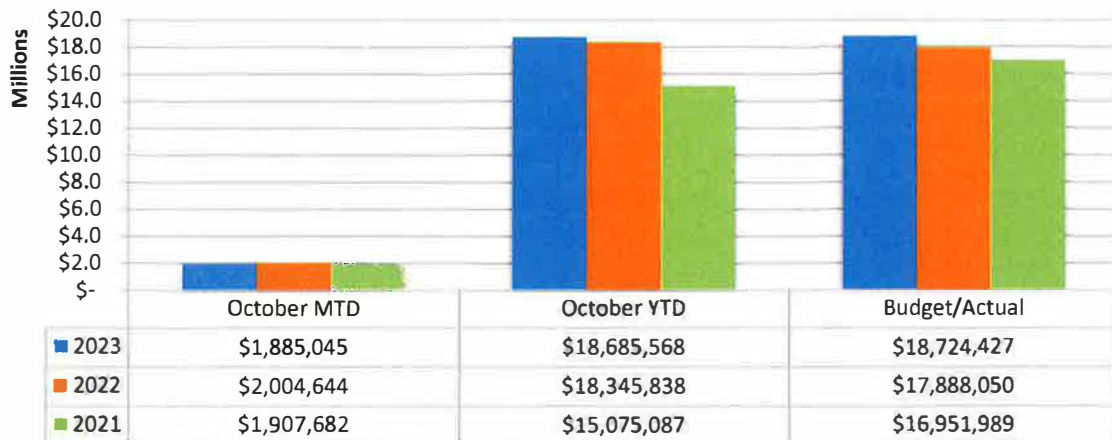

The following is a summary of financial activity for the year-to-date (YTD) October 31, 2023:

FINANCIAL SUMMARY

- General Fund balance was \$14,804,933 at October 31, 2023, or \$5,712,137 higher than October 31, 2022.
- The Recreation & Aquatic Fund balance was (\$408,549), or \$893,020 lower than October 2022 based on the timing of transfers from the General Fund;
- The Storm Water Fund balance was lower by \$5,562 lower when compared to October 2022 and is primarily attributed to the proportionate share of public works employees' salaries and benefits and higher maintenance and repair costs and lower receipts;
- The Sewer Fund balance was \$11,700 lower from October 2022 as receipts and expenses are consistent between years. No salaries and benefits were allocated to the Sewer Fund beginning in September 2023.

INCOME TAX COLLECTIONS – ALL FUNDS



Income tax collections for the year-to-date October 31, 2023 were \$18,685,568, or 99% of the 2023 budget and were \$339,730, or 2% higher when compared to the prior year. Income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$15,773,933, \$125,000, \$927,878 and \$1,855,757, respectively.

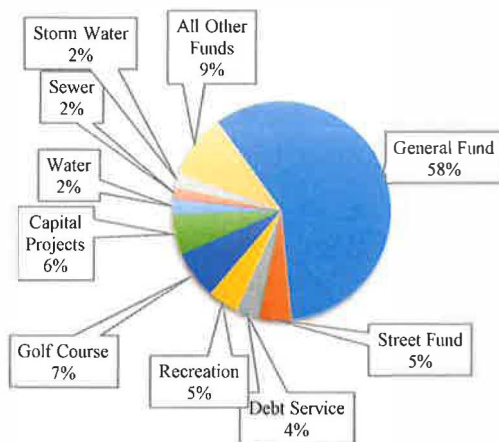

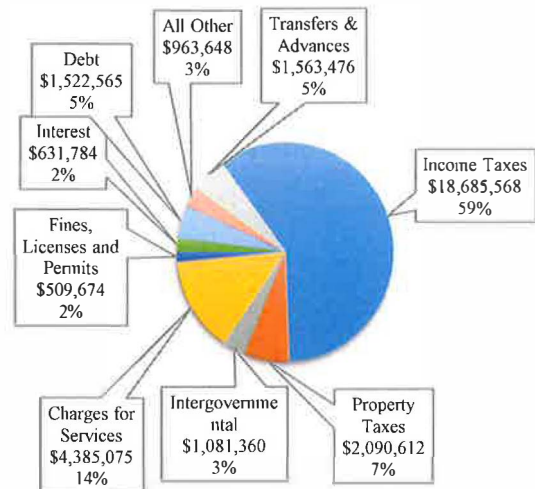
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 59% of all revenues. Revenues were \$1,805,458 lower when compared to YTD October 2022 primarily attributed to the timing of transfers/advances between funds.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

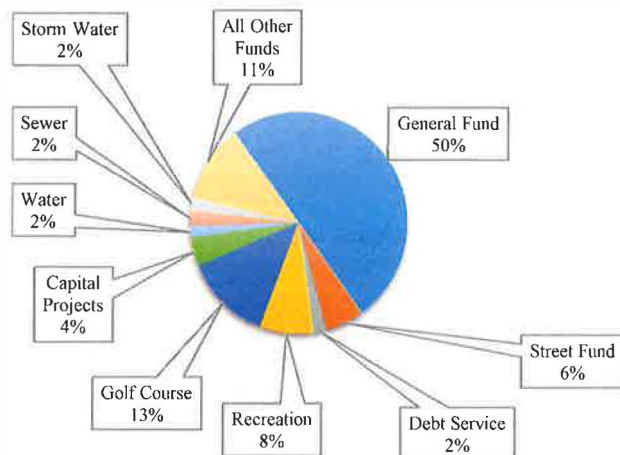


TOTAL YTD REVENUES BY TYPE

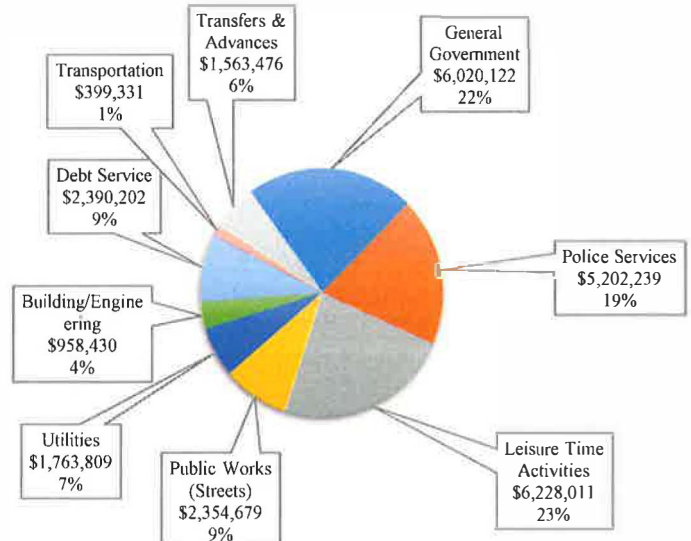


EXPENDITURES

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



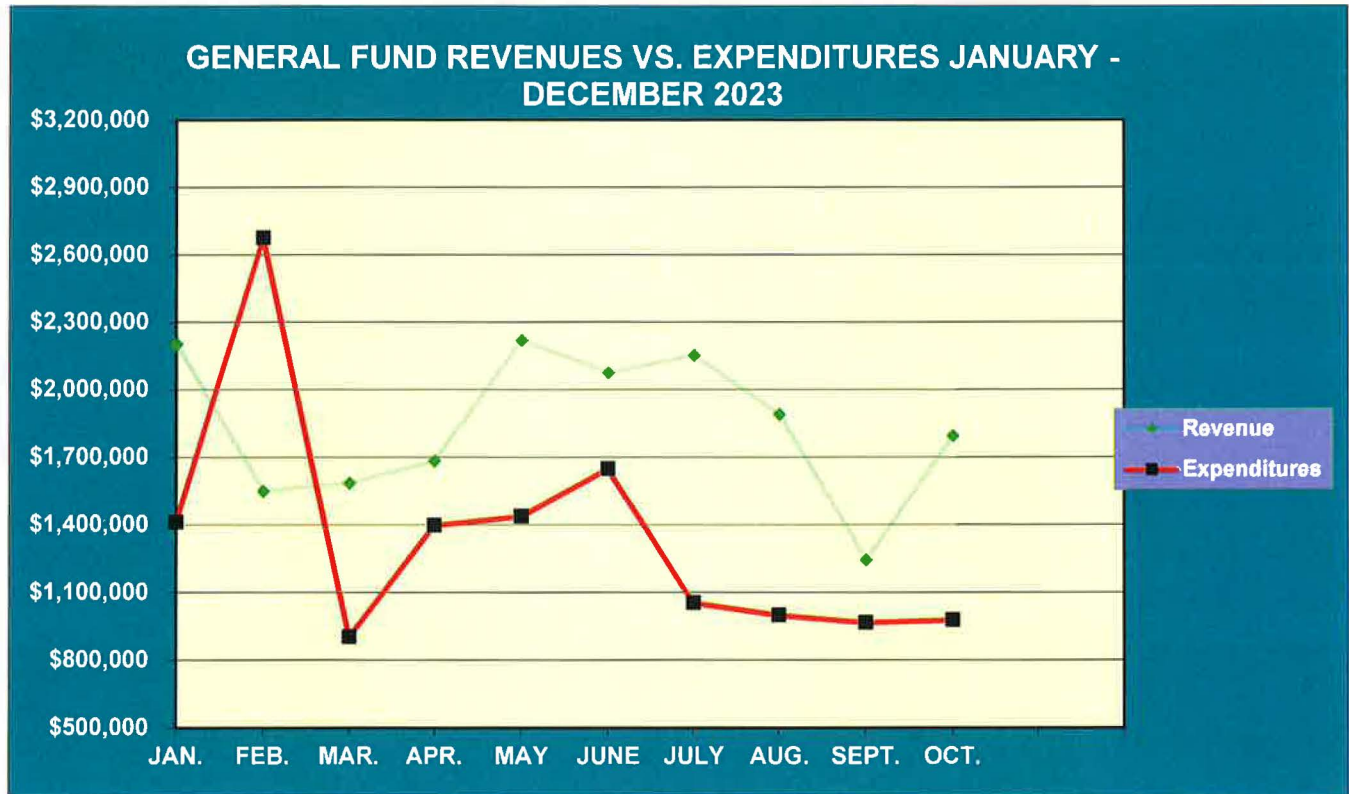
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$2,451,416 lower when compared to YTD October 2022 which was primarily attributed to the timing of the bond anticipation note principal and interest payment from the Golf Course, Debt Service and Street Funds of \$1,849,500 as well as transfers between funds of \$1,400,000 recorded in October 2022 not reflected in October 2023. Increases also attributed to higher capital project costs, such as the purchase of new truck for public works and street maintenance paving project costs. The City had lower economic incentive payments, construction costs associated with the Rarey's Port and Wert's Grove Buildings.

GENERAL FUND

Through October 2023, General Fund revenues were \$164,922 higher while expenditures were \$1,590,780 lower when compared to YTD October 2022.



General Fund balance was \$14,804,933 at October 31, 2023, or \$5,712,137 higher than October 31, 2022. Unencumbered cash (cash less outstanding encumbrances) was \$13,743,365.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2023:

The Recreation Fund and Golf Course have historically operated at losses. In order to “break-even” annual transfers from the General Fund are necessary. Through the YTD October 2023, Recreation Fund operational receipts were higher by \$66,555.73 and Golf Course Fund operational receipts were higher by \$120,683.66 when compared to the prior year.
