On 9/15, Officers were dispatched to Glendening Elementary for a panic alarm. Once on scene it was determined to be accidental. The alarm was tripped at the secretary desk by the VP. I assisted with alarm reset. **Party(s) Advised**

On 9/15, Mutual Aid was provided for Madison Twp. PD regarding a female juvenile. I conducted a search on the female juvenile, yielding no findings. **Report Taken** (Mutual Aid form completed)

On 9/16 at MSC a student from the special need's unit was being physically aggressive with the teachers and damaged the TV inside the Principals office. Cost of damage is approx. \$2,659.50. Student was emergency removed from school. Prosecution declined. **Report Taken**

On 9/17 at MSS, a student passed out during class and came to shortly after. Medics were called and the student was evaluated. Parents refused transported and later sought medical attention. **Party(s) Advised**

On 9/17 at MSS, a student was reported missing, last seen at dismissal walking with an unknown person. This student is not assigned a bus. Parent arrived to pick up student and student wasn't at parent pick up designated area and alerted staff. Student was located approx. 1.5 later. **Party(s) Advised**

On 9/22 at MSS, a special needs student passed out and was non- concussion for approx. 5 mins. Medics were requested, arrived and evaluated the student. Parents declined transport but later picked up by his parents. **Party(s) Advised**

On 9/22 at MSS, a female student pushed another female student and she fell into the lunchroom table. The female student suffered a bruised rib after seeking medical attention. Prosecution declined. Student disciplined by school admin. **Report Taken**

On 9/23 at MSS, two male students fought inside a classroom. The fight was deemed as a mutual incident between the two. Students disciplined by school admin. **Party(s) Advised**

On 9/23, at MSC an assault occurred on the staircase with a female and male student. Female student was seen aggressively, repeatedly hitting the male student, whom did not attempt to hit the female. Charges were requested. Student disciplined by school staff. **Report Taken**

On 9/24, at MSS a special needs kid brought a kitchen knife to school to attempted to fix his computer. School staff retrieved the knife without incident. Knife submitted into evidence. Charges requested. Student was disciplined by school admin. **Report Taken**

On 9/25, at MSS a student made a threat towards another student, stating that he was going kill him and his family pets. The student also took his laptop, simulated holding a gun and shooting the student. Possible Charges. Student disciplined by school admin. **Report Taken**

On 9/26, a Groveport Elementary student ran from school and towards the Rec Center. I requested assistance from patrol officers to help locate. Descriptors were provided, student was located and returned to school. While inside officers de-escalated and calm the student down from destroying the classroom and inflicting harm to himself by banging his head into the wall. Student was disciplined and released to parent. Prosecution declined. **Party(s) Advised**

On 9/30 at MSS a female student picked up a chair and threw it at another student, 2 times. The student suffered bumps, bruises and possibly a concussion. Victim was first seen/evaluated by school nurse and then by the Medics. Student was sent home and victim was released to parent. Student disciplined by school admin. Charges are requested. **Report Taken**

September Activities-

The Groveport Police Department participated in multiple events during the month of September. On September 6th, the Groveport Police Department displayed our current equipment during the annual Kids Fest at the Groveport Recreation Center. Our staff provided Community Policing interaction with the residents and visitors who attended the event, along with providing security/traffic control as vehicles entered the event area. We were advised during the event that a potential Protection Order Violation was occurring during the event, where the individual was unaware of the protected party being at the event, and the named subject was escorted off the Recreation Center property to gain compliance with the Protection Order language.

The Groveport Police Department also attended and participated in the annual 9-11 Ceremony at the Motts Military Museum. Our staff not only attended and stood with other first responders during this annual event, but we also provided our personnel to conduct the Honor Guard 21-Gun Salute during this highly emotional annual event for our country and first responders. Our agency is honored to be part of this annual event and look forward to next year's ceremony that will mark 25 years since the terrorist attack on our country.

The third week of September marked a new era for the Groveport Police Department, as Sgt. Mathew Poffenbarger and Sgt. Forrest Benner were sworn-in and have assumed their new roles as leaders for our organization. I am very excited to have these two new Patrol Sergeants, and over the next several weeks, both individuals will be receiving Field Training Program. It is my intent to have these new Sergeants on their new assignment shifts by early November after working with Lt. Josh Short, Captain Kurt Blevins, Sgt. John Westhoven and myself on their assigned duties. I will also be holding an "All Supervisors Round Table Meeting" on November 4th to ensure there is a clear direction of these leaders and their shifts, and giving the supervisors an opportunity to voice any concerns or questions with the new duties of their positions.

Training-

The Groveport worked in conjunction with Madison Township Police Department to complete the remainder of the 2025 Continuing Policing Training when it comes to Legal Updates. Madison Township Police Department hosted our agency on September 5th, and we hosted the training on September 19th. We also hosted the new Breath Testing Machine for OVI Drivers during the month and September, and it is expected to have compliance by the end of October.

SEPTEMBER POLICY REPORT:

No updated or new policies in September

Executive Summary

An audit was conducted at the direction of **Chief Adams** to assess departmental compliance with Lexipol policy acknowledgments and Daily Training Bulletin (DTB) participation. Covering the period from January 1 through September 30, 2025, the findings reflect a department-wide culture of diligence, professionalism, and commitment to continuous training. The results support internal oversight, reinforce accountability, and provide transparency for council and our community.

This report summarizes the Groveport Police Department's performance in two key areas of operational accountability: **Lexipol Policy Acknowledgment** and **Daily Training Bulletin (DTB) Completion**. The audit period spans January 1 through September 30, 2025. The findings reflect a department-wide culture of diligence, professionalism, and commitment to continuous training.

1. Lexipol Policy Acknowledgment Audit

Scope: 169 active policies across 25 established personnel (excluding one recent hire) **Platform:** Lexipol

Highlights

- **92% of personnel** acknowledged all active policies—demonstrating strong engagement and procedural integrity.
- **Command staff and supervisors** are fully compliant.
- **No systemic issues** were identified; acknowledgment gaps were isolated and minor.

Noted Exceptions

- Three officers had 1–3 outstanding acknowledgments, likely due to recent updates or timing delays.
- One recent hire was excluded from the audit to ensure fairness and accuracy.

Recommendation

Supervisory follow-up is underway to close minor gaps and reinforce acknowledgment protocols.

2. Daily Training Bulletin (DTB) Audit

Scope: 273 DTBs issued to 25 officers Expected Completions: 6,825 Actual Completions: 6,817
Compliance Rate: 99.88%

Highlights

- Near-perfect completion rate reflects exceptional commitment to ongoing training.
- The only discrepancy—a single DTB missed by 8 officers—was due to a clerical error through Lexipol and will be promptly corrected.
- Supervisors have been reminded to monitor bulletins for full crew coverage.

Observations

- The Groveport Police Department continues to demonstrate **high operational integrity** and **training accountability**.
- Minor gaps are procedural, not behavioral, and are being addressed proactively.
- Exclusion of recent hires from compliance metrics ensures transparency and fairness.
- These results position the department favorably for external review, accreditation, and public trust.

700.3	Personal Property	Members must submit a written request to carry personal equipment, including description, reason, and duration.
427.5	Vehicles and Personal Property	Officers may review documents in civil disputes but should not take enforcement action unless a crime is apparent.

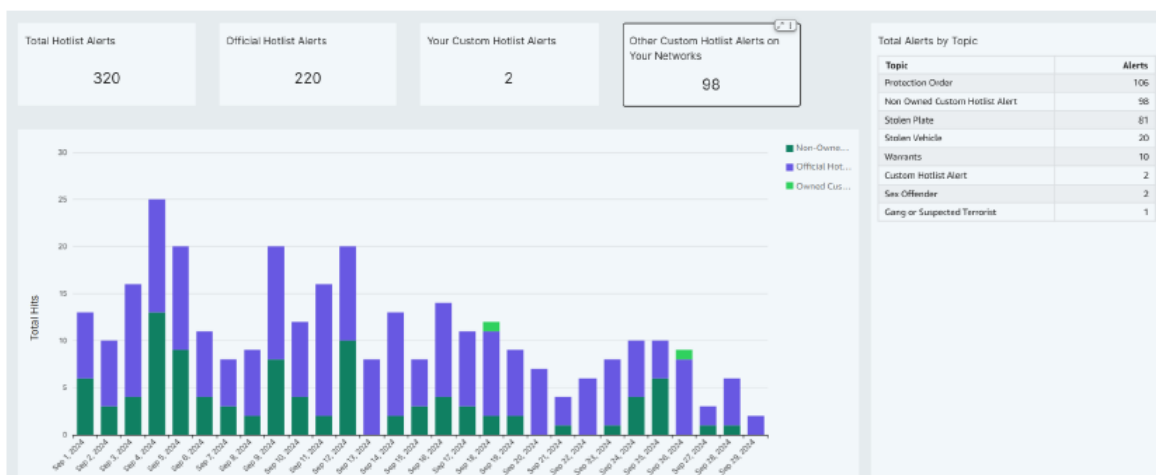

Flock Cameras:

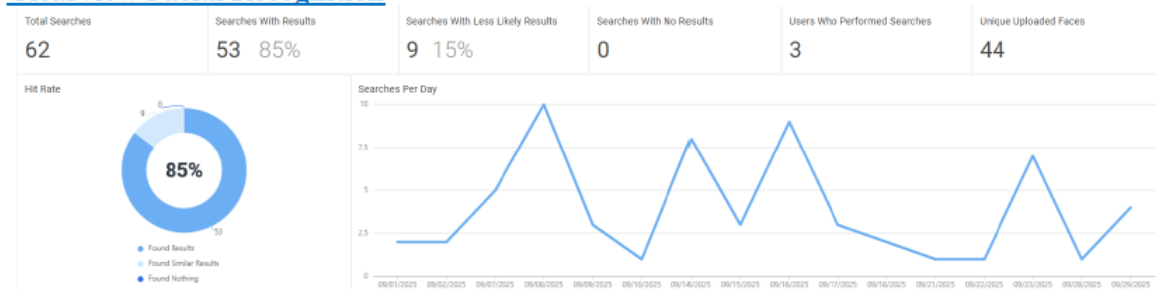

Not only does Flock give us information on individuals that come into the City, but here is where we see individuals that are associated with a vehicle that has come into the City and if they have warrants, be a stolen vehicle, associated with a BOLO, missing person, ect..

The City of Groveport owns 13-Flock cameras currently, but as a part of Flock we currently have access to 22,726 cameras nationwide.

Clearview Facial Recognition Scans

- Currently we have 5-users on the department using facial recognition. Someone from each shift on the department has capabilities to perform searches. 5-users is what our plan allows with Clearview.
- The more experience the Bureau continues to gain with the Clearview utility, the more we are able to help ourselves as well as other Police Departments adjacent to ours with their investigations.

Detective Bureau Monthly Review:

The Bank Robbery was a long and extensive investigation handled by the Bureau. Myself and Detective Fairman for the month of September had few investigations for the Police Department, most if not all were handled by Patrol and we assisted them in any way we could. Detective Fairman continues to help the US Marshals with fugitive targets as well as assist other agencies with their investigations. I, Detective Amabile, have helped Patrol with their investigations as well as iron out our camera systems utilized by the City and the PD. We have individually had several minor cases that typical cases that we see in the form of Theft or Fraud.

A tip that was passed on to Patrol of a suspicious person at the Rec Center resulted in an investigation that continued in North Carolina, where the suspicious individual was suspected of having sexual intentions with juveniles. Due to this cooperation between all parties the individual was eventually arrested for Crimes against Children.

Criminal Activity Trends

Over the summer months we typically see a rise in car break-ins. This summer season we had some but less than previous years. I believe that the utilization our City's mobile camera trailers and pro-active patrol routines contributed to less car break-ins within our sub-divisions. The Bureau has seen typical investigations involving Fraud or Theft.

Training

Detectives completed the mandatory legal updated provided by the City. Detectives have upcoming training for the month of October to include Drone Training and Photo II.

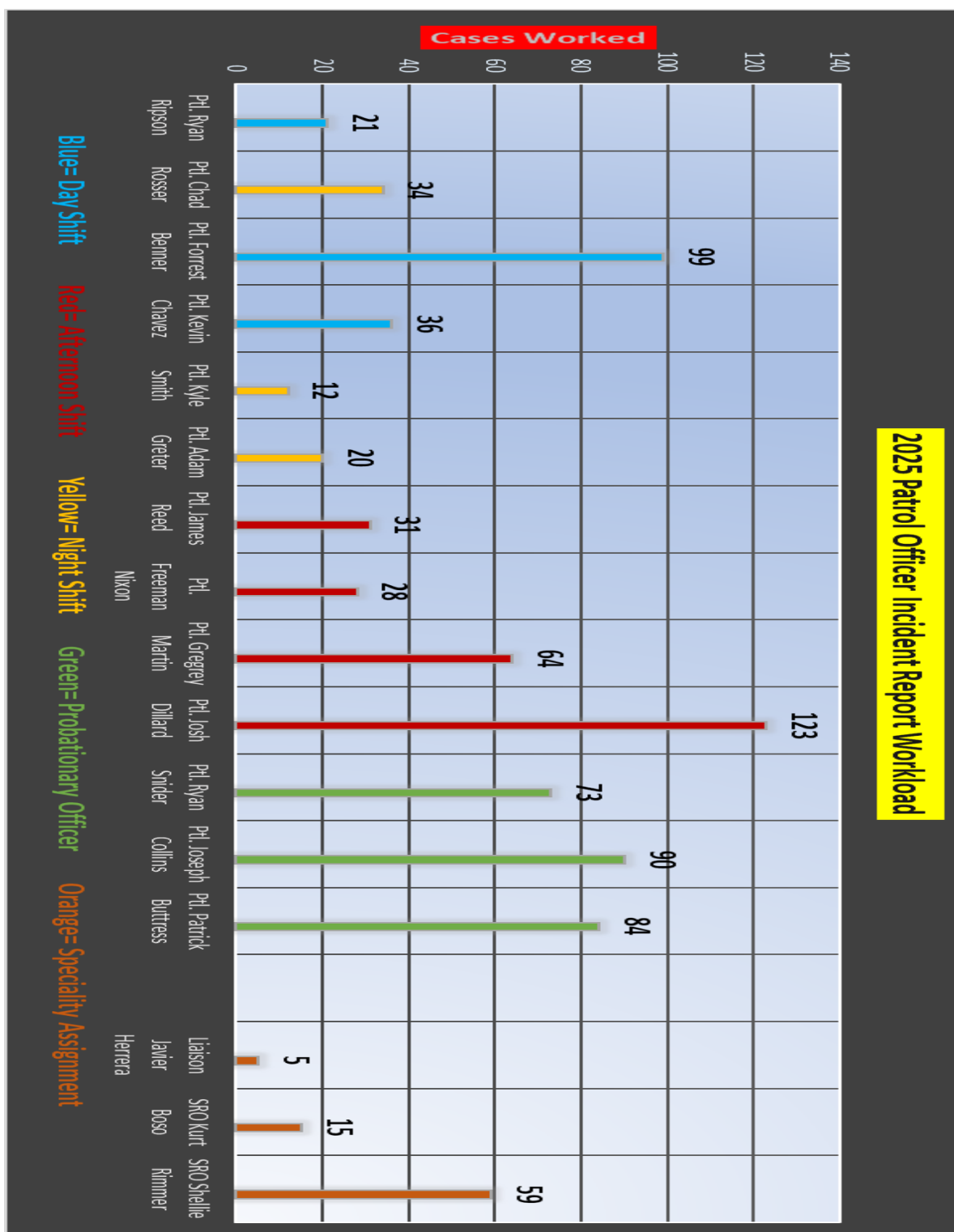
