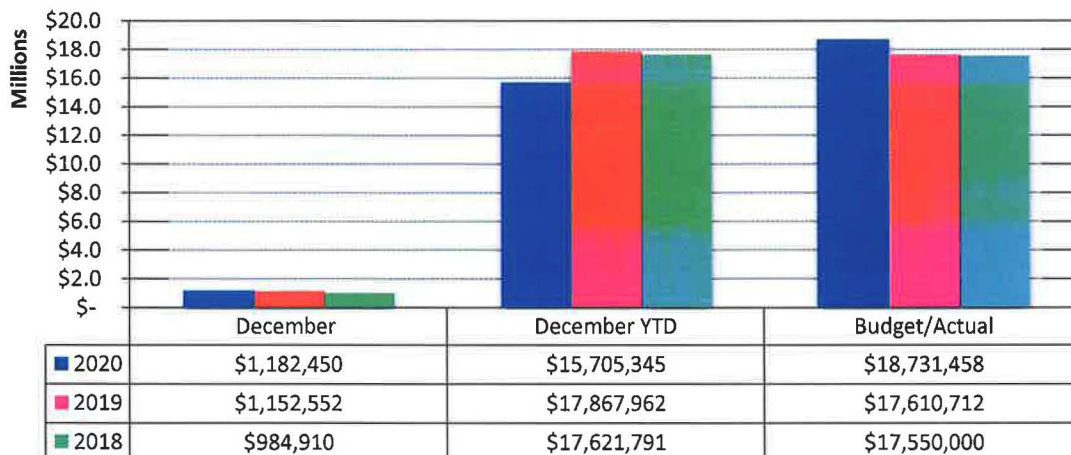

The following is a summary of financial activity for the year-to-date (YTD) December 31, 2020 highlighting the City's total and most significant funds.

FINANCIAL SUMMARY

The following is a summary of the City's financial activity year-to-date December 31, 2020. Total fund balances through December 31, 2020 totaled \$15,929,970, a decrease of \$445,469 from November 30, 2020. The City has collected 84.17% of total budgeted revenue and expended 67.56% of budgeted expenditures. Our current investment portfolio yield is 1.06% and duration is 1.87 years.

INCOME TAX COLLECTIONS – ALL FUNDS



Reconciled gross income tax collections for the year-to-date December 31, 2020 were \$15,705,345, or 83.84% of the 2020 income tax budget and were \$2,162,617, or 12.1% lower when compared to the prior year. Gross income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$12,444,276, \$150,000, \$1,555,535 and \$1,555,534, respectively.

The change from the prior month is primarily attributed to a decrease in net profit payments. The breakdown of collections is as follows:

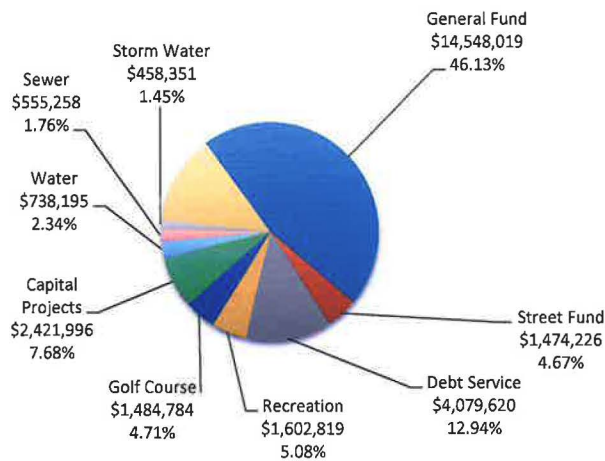

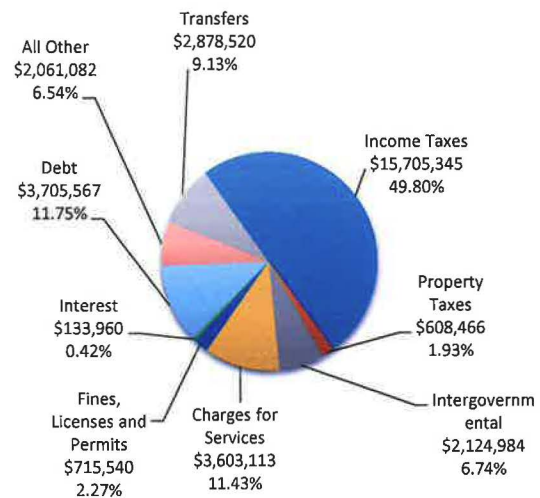
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 49.80% of all revenues. Revenues were \$679,067 higher when compared to YTD December 2019 primarily attributed to refunding debt proceeds issued.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

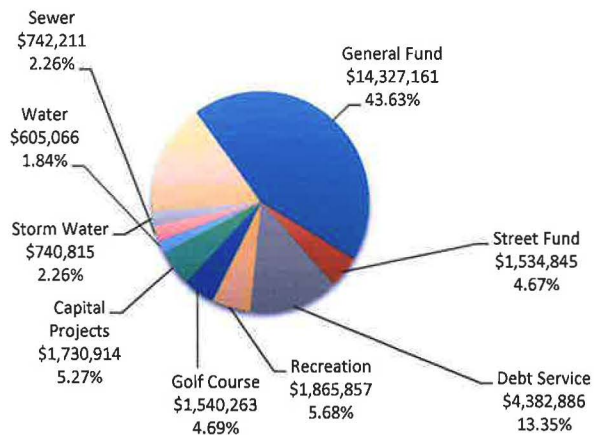


TOTAL YTD REVENUES BY TYPE

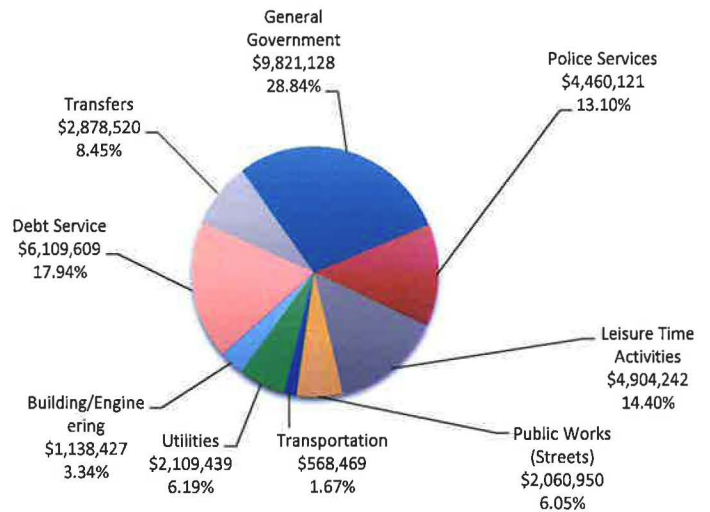

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



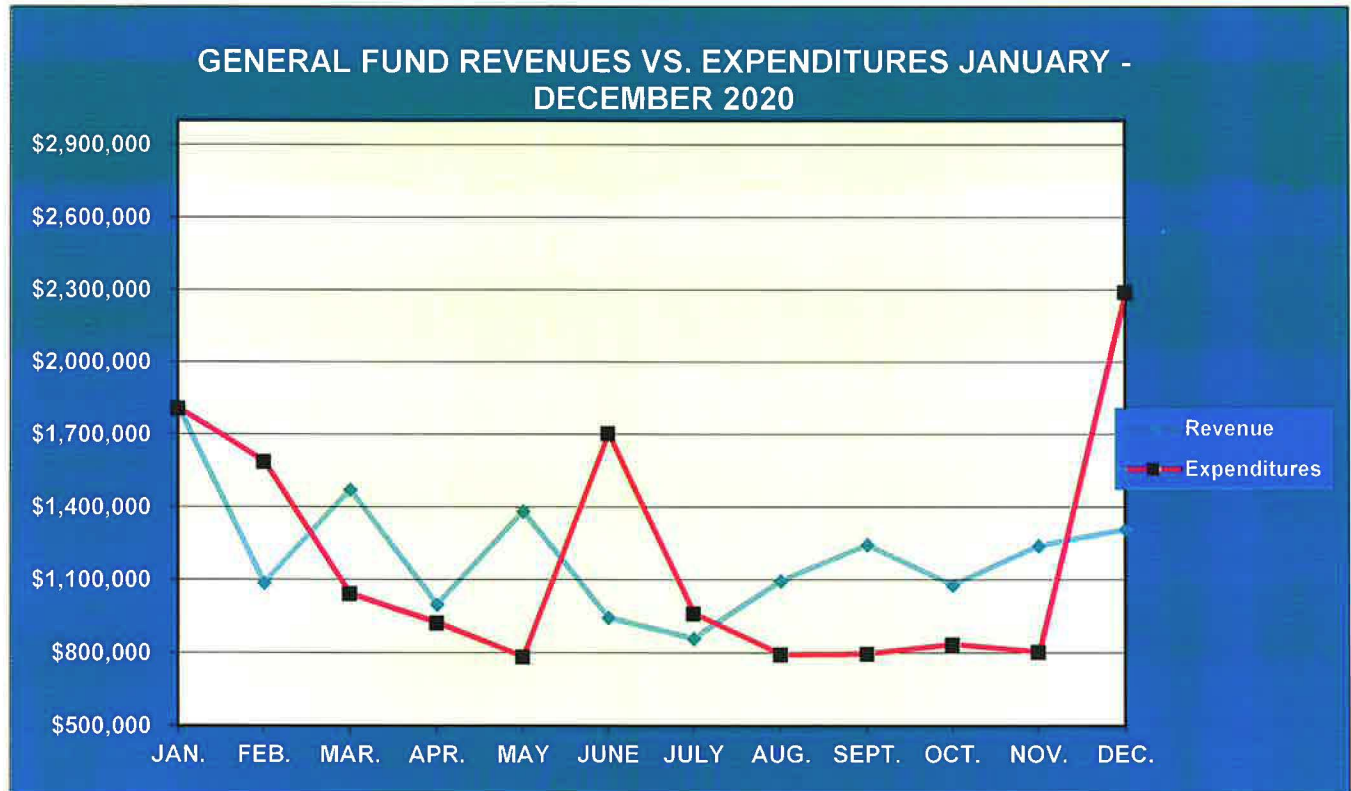
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$4,063,608 higher when compared to YTD December 2019 which relates the refunding of debt and capital improvement projects.

GENERAL FUND

Through December 2020, General Fund revenues and expenditures were lower by \$1,364,681 and \$650,610, respectively, when compared to YTD December 2019.



General Fund cash balance was \$3,986,961 YTD December 31, 2020 which was \$220,857 higher compared to the same period last year. Unencumbered cash (cash less outstanding encumbrances) was \$3,651,266.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2020:
