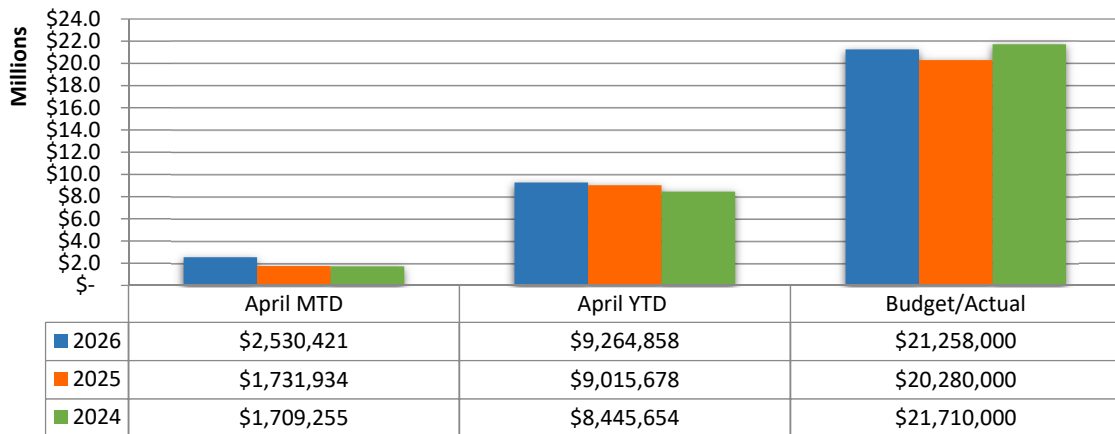

The following is a summary of financial activity for the year-to-date (YTD) April 30, 2026:

FINANCIAL SUMMARY

- General Fund balance was \$28,835,351 at April 30, 2026, or \$7,142,608 higher than April 30, 2025.
- The Recreation Fund and Golf Course have historically operated at losses. In order to “break-even” annual transfers from the General Fund are necessary. Through the YTD April 2026, Recreation Fund operational receipts were higher by \$61,307.90 and Golf Course Fund receipts were higher by \$25,515.92 when compared to the prior year.
- Investments totaling \$749,259.17 matured and proceeds of \$788,301.59 were invested at an average interest rate of 3.875%. Interest earnings for April 2026 were \$565,694, or \$79,565 higher than prior year of \$486,129.

INCOME TAX COLLECTIONS – ALL FUNDS



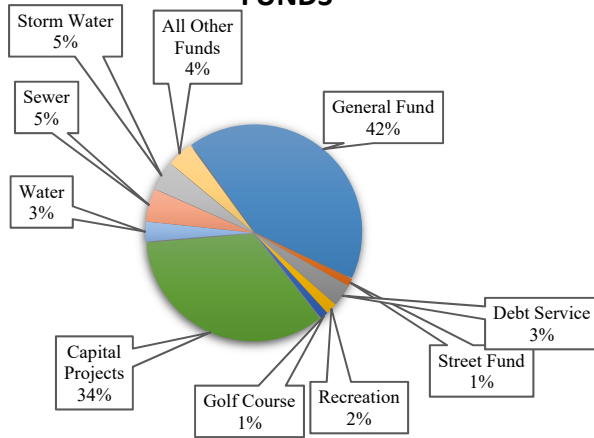
Income tax collections for the year-to-date April 30, 2026 were \$9,264,858, or 43% of the 2026 budget and were \$549,308, or 8% lower when compared to the prior year. Income tax allocations to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund were \$7,832,629, \$50,000, \$460,743, and \$921,486, respectively.

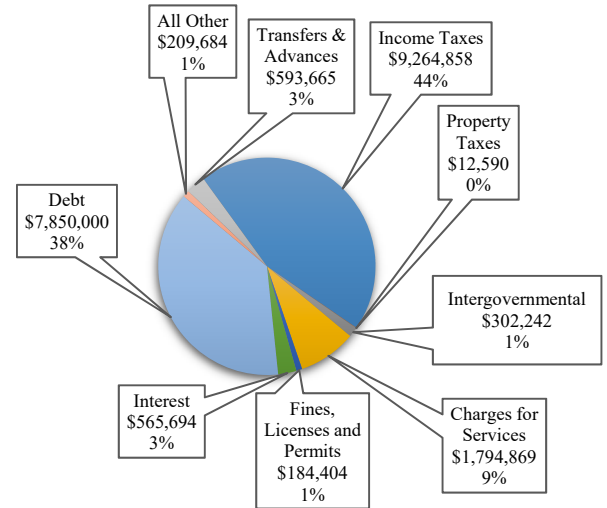
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 72% of all revenues exclusive of debt proceeds. Revenues were \$832,328 higher when compared to YTD April 2025 primarily attributed to higher bond anticipation note proceeds (\$7,850,000 vs. \$6,000,000) off-set by lower real estate taxes based on delayed distribution from the Franklin County Auditor for 1st half 2026 settlement.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

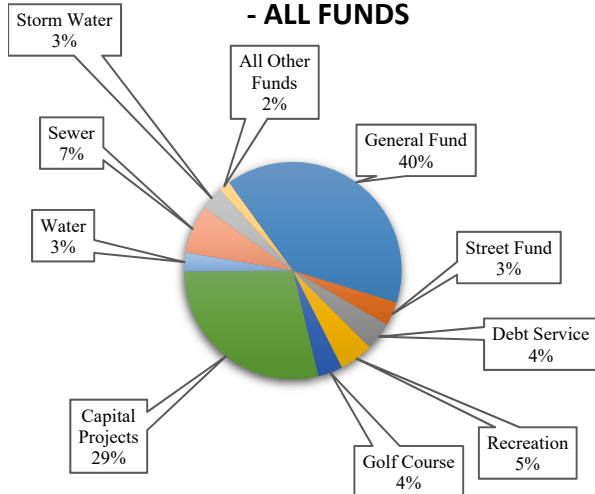


TOTAL YTD REVENUES BY TYPE

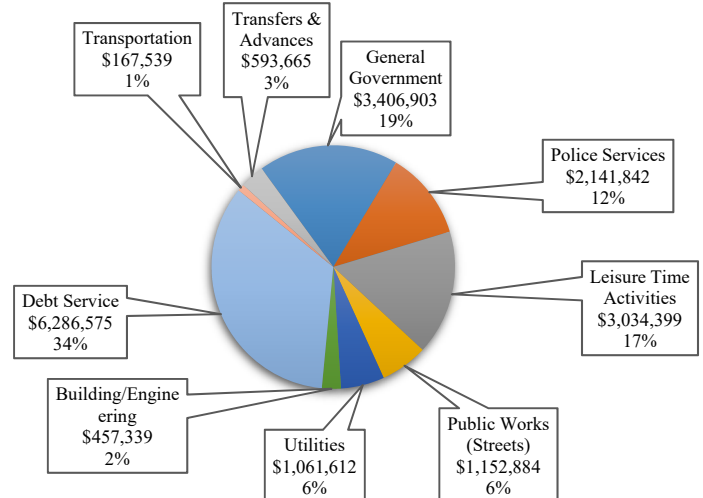

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



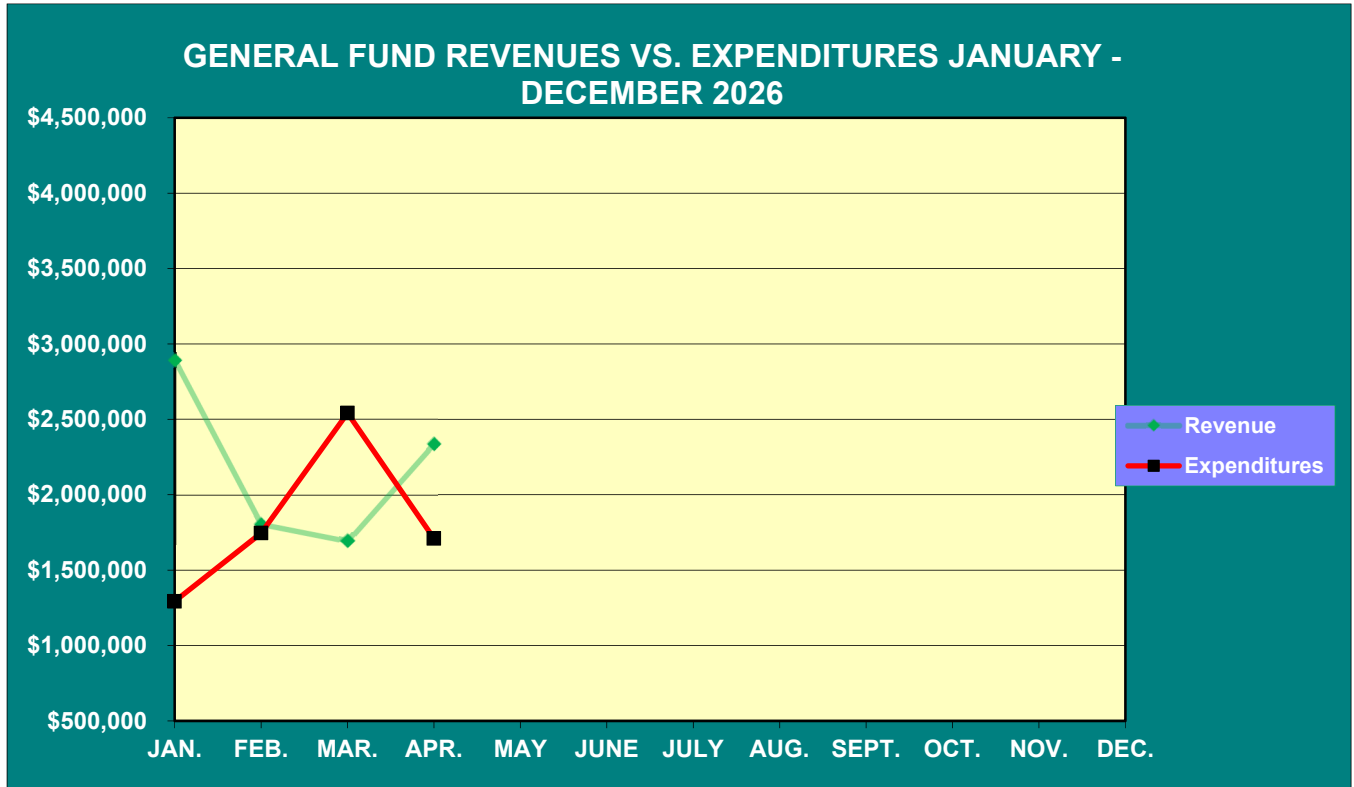
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$2,027,787 higher when compared to YTD April 2025 which is based on timing of debt expenditures (\$6,286,575 vs. \$2,684,795) off-set by lower tax incentive payments (\$1,667,263 vs. \$1,976,505) and capital project expenditures for the Recreation Center and Golf Course (lower by \$557,722).

GENERAL FUND OPERATIONS

Through YTD April 2026, General Fund revenues and expenditures were \$331,649 and \$251,492 lower, respectively when compared to YTD April 2025.



General Fund balance was \$28,835,351 at April 30, 2026, or \$7,142,608 higher than April 30, 2025. Unencumbered cash (cash less outstanding encumbrances) was \$27,124,170.

OPERATING PROFIT/(LOSS) – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2026:
