*Finance Director Jason Carr relayed that the purpose of the tax budget is to furnish information to the County Budget Commission in order that it may adjust tax levies to conform to the limitations of law and to fix the limitations of appropriations and expenditures by various political subdivisions and taxing units, including villages and cities, during the ensuing year. The attached exhibit shows the 2016 to 2020 information represents actual audited numbers of receipts and expenditures. The 2021 information is an estimate of the City's receipts and expenditures based on the 2021 budget. The 2022 numbers are estimates based on what the City expects to receive. Noting in general that staff has projected a 3% increase in both revenues and expenditures for purposes of completing the tax budget.*
