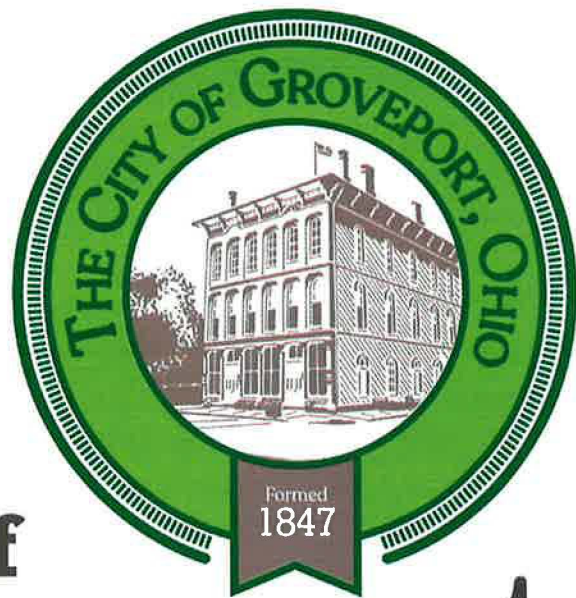

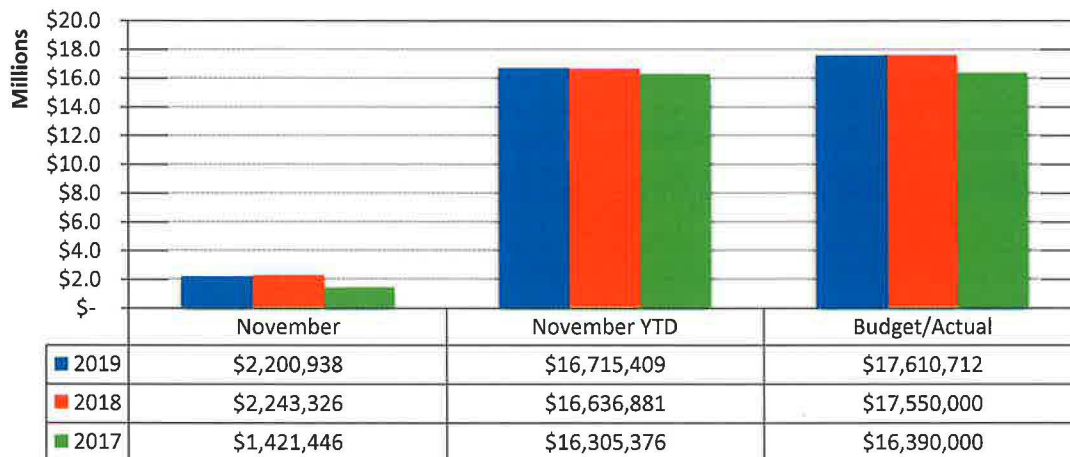
The following is a summary of financial activity for the year-to-date (YTD) November 30, 2019 highlighting the City's total and most significant funds.

FINANCIAL SUMMARY

The City's financial activity year-to-date November 30, 2019 noted total fund balances increased \$1,293,275 from the previous month noting the largest increase within the General and Debt Service Funds of \$860,160 and \$420,525, respectively. The funds with the largest decreases were the Street Maintenance and Repair and Employee Withholding Funds of \$77,757 and \$57,563, respectively. The City has collected 88.72% of total budgeted revenue and expended 61.58% of budgeted expenditures.

The City's investment portfolio is currently yielding 1.94% compared to Star Ohio 1.90% at November 30, 2019.

INCOME TAX COLLECTIONS – ALL FUNDS

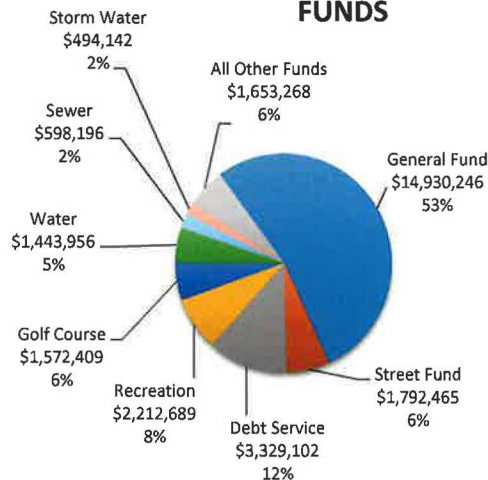


Income tax collections for the year-to-date November 30, 2019 were \$16,715,409, or 94.92% of the 2019 budget and were \$78,528, or 0.47% higher when compared to the prior year. Income taxes allocated to the General Fund, Rainy Day Fund, and Debt Service Fund totaled \$13,262,327, \$137,500 and \$3,315,582, respectively.

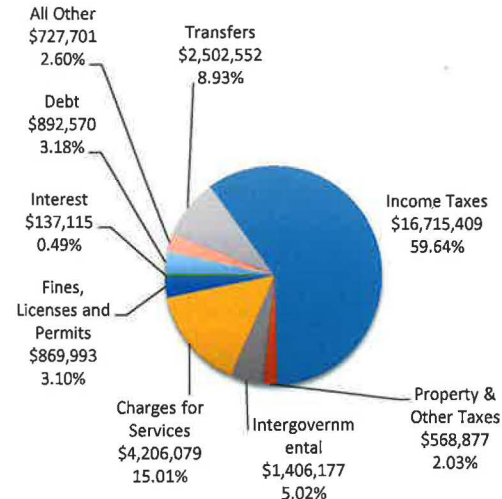
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 59.64% of all revenues. Total revenues were \$1,205,214 lower when compared to YTD November 2018 noting the decrease was primarily attributed to lower loan proceeds recorded in the Street, Water Capital and Storm Water Funds for OPWC projects.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

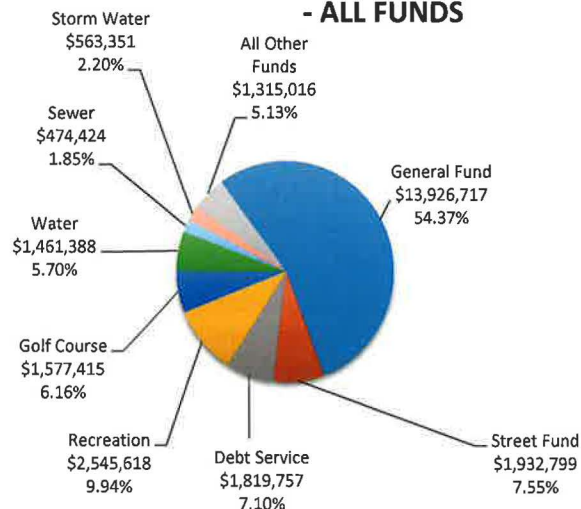


TOTAL YTD REVENUES BY TYPE

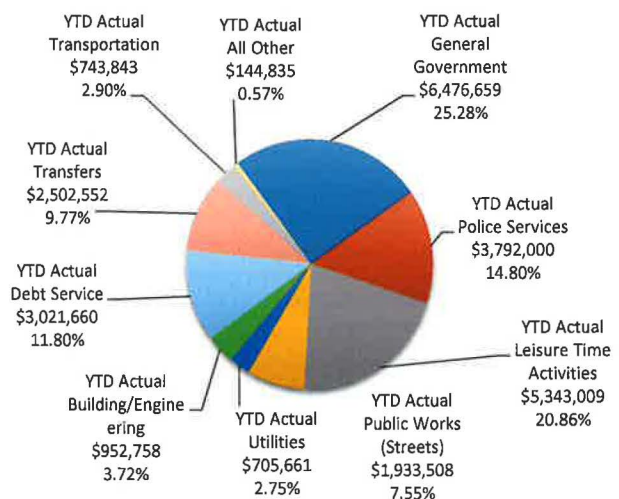


EXPENDITURES

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



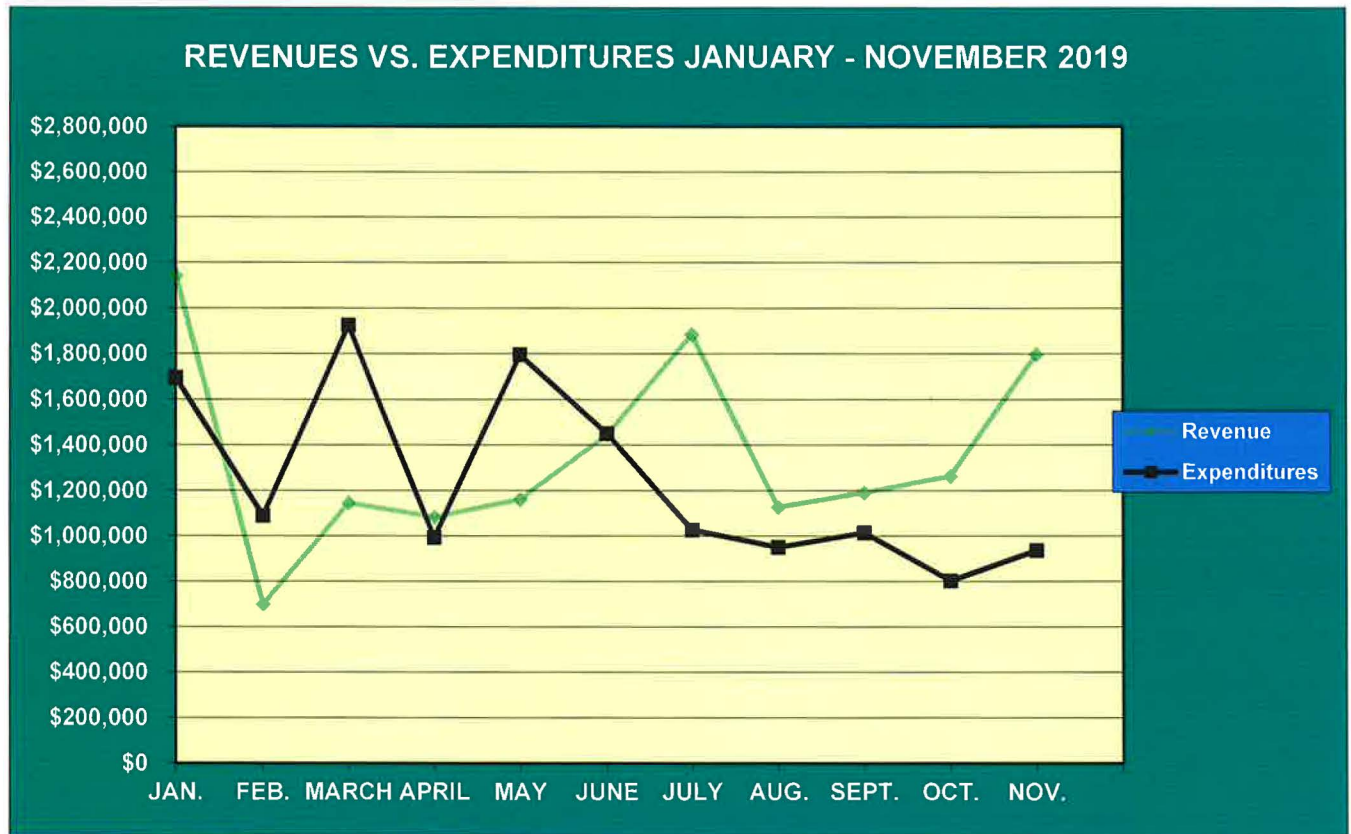
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$1,484,112 lower when compared to YTD November 2018. This fluctuation is primarily attributed to completion of Ohio Public Works Commission projects in 2018 that are not recognized in 2019. General government (administrative operational related costs) and Leisure Time expenditures (Community Affairs, Parks, Recreation and Golf Course) comprise the largest portion of City expenditures.

GENERAL FUND

Through YTD November 2019, General Fund revenues were \$187,465 higher and expenditures were \$782,412 lower, respectively, when compared to YTD November 2018.



The General Fund cash balance was \$4,076,533 for the year-to-date November 30, 2019 which was \$904,910 higher compared to the same period last year. Unencumbered cash (cash less outstanding encumbrances) was \$3,752,729.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through November 30, 2019:
