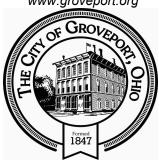

Development Director Jeff Green met with the Project Manager for Construction One. He was given a 13-week project timeline for the interior build-outs of the two new buildings. Administrator King asked for a date for the construction to begin. Mr. Green would start the 13-week timeline on September 26, when the plumbers are on site. The General Contractor will need to schedule many subcontractors; the plumbers are to begin on September 26, 2022. Mayor Westcamp suggested that Mr. Green relay to the Project Manager that it would be helpful it Construction One parked their equipment in the rear of the public lot. So it won't take up the designated parking spaces for Ace Hardware. Mr. Green has a meeting this afternoon to go over site-related issues. The City will ensure that Construction One meets the same consideration as during the construction of the building. The 13 weeks would put the opening of the facilities at Christmas time. The kitchen areas are more complex, with a six-week turnaround period. The rest of the spaces are simpler and will take place while work is going on in the kitchen areas.
