Legislation

Ord. 18-047 Water Rate Increase (2nd Reading)

At staff's recommendation there was no water rate increase for 2018. While we are currently holding our own for our projected balance (contingency) in the Water Fund for operations of our water plant, our projected expenses for 2019 are also less than 2018 expenses, so any unforeseen large expense would result in a much lower balance going into 2020.

In addition, the Ohio legislature adopted Senate Bill 2 which requires that all water systems develop an Asset Management Plan that includes a long-term (five year) funding strategy that determines the estimated cost per year to adequately fund, repair and replace our water assets. We are currently completing this plan that is due to be submitted to OEPA yet this year.

With expenses continuing to increase due to inflation, a small increase of 3% is being recommended for 2019 in order to stay at least current with our balance in the Water Fund.

As an aside and for your information, the City of Columbus Sewer and Water Advisory Board is recommending a 2% water rate increase and 3% sanitary sewer rate increase for 2019 to Columbus City Council.

Ord. 18-048 Change to Pay Scale – Cost of Living Adjustment (2nd Reading)

The City's Compensation Plan is on a three-year calendar basis. The first year the City does a salary survey, which was done in 2017. The other two years the City determines whether there is a cost-of-living adjustment based on any number of factors. 2018 included a 2% cost-of-living increase. Social Security, one of our factors used, has announced that there is a 2.8% cost-of-living increase for 2019. For that reason we are recommending a 2.8% increase to our pay scale for 2019.

<u>Ord. 18-049 2019 Contract for Health Services with the Health Department (2nd Reading)</u> This is our annual health department contract, including plumbing inspection services, for 2019. The cost to us will be \$49,877.73. This is a 6.8% increase from 2018.

Ord. 18-050 Amending Golf Rates (1st Reading)

Attached to the ordinance are the changes to golf rates recommended by the Director of Golf.

Ord. 18-051 Accept a Sanitary Sewer Easement from Bixford Green Association (1st Reading)

An easement from the Bixford Green Homeowners Association is needed for the Bixford Green Sanitary Pump Station Stand-by Generator Project (see Ord. 18-062). The association has agreed to donate this easement to the City for this useful project.
