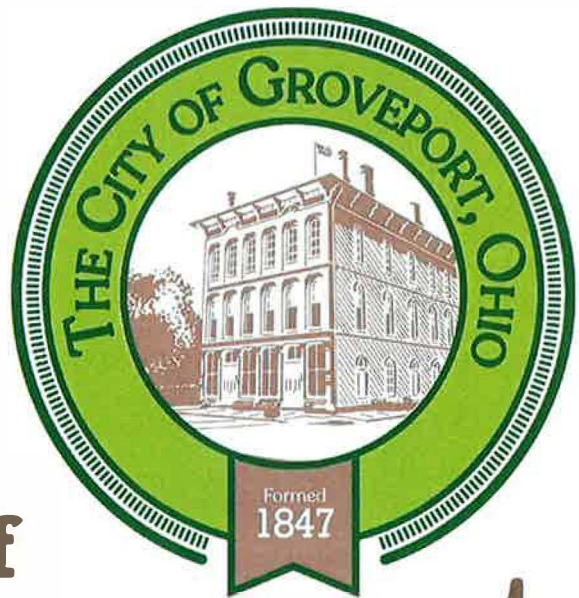

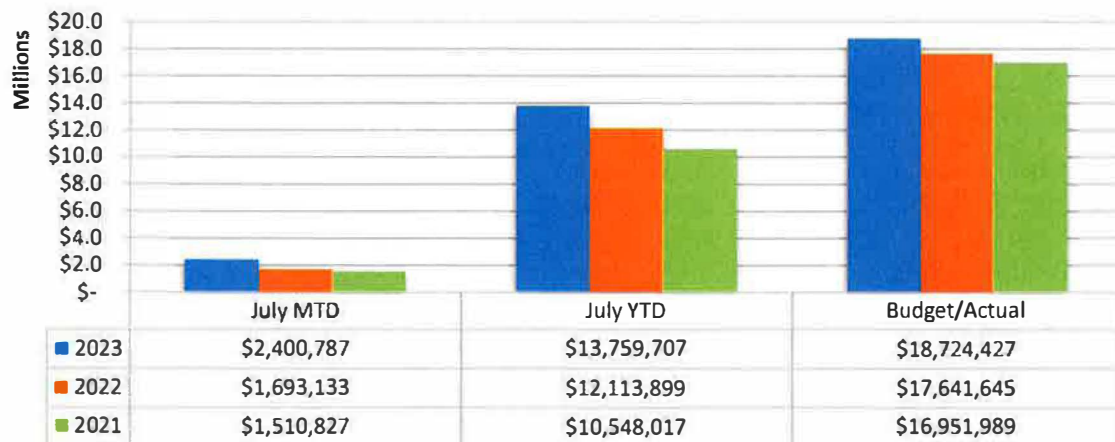

The following is a summary of financial activity for the year-to-date (YTD) July 31, 2023:

FINANCIAL SUMMARY

- General Fund balance was \$12,825,571 at July 31, 2023, or \$5,924,993 higher than July 31, 2022.
- The Recreation & Aquatic Fund balance was \$85,623, or \$30,869 lower than July 2022 based on the timing of transfers from the General Fund;
- The Storm Water Fund balance was lower by \$21,203 higher when compared to July 2022 and is primarily attributed to the proportionate share of public works employees' salaries and benefits and higher maintenance and repair costs and lower receipts;
- The Sewer Fund balance was \$2,910 lower from July 2022 as receipts and expenses are consistent between years.

INCOME TAX COLLECTIONS – ALL FUNDS



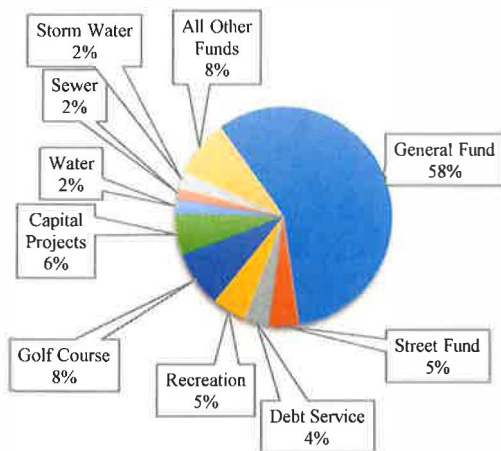
Income tax collections for the year-to-date July 31, 2023 were \$13,759,707, or 73% of the 2023 budget and were \$1,645,808, or 14% higher when compared to the prior year. Income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$11,621,376, \$87,500, \$683,610 and \$1,367,221, respectively.

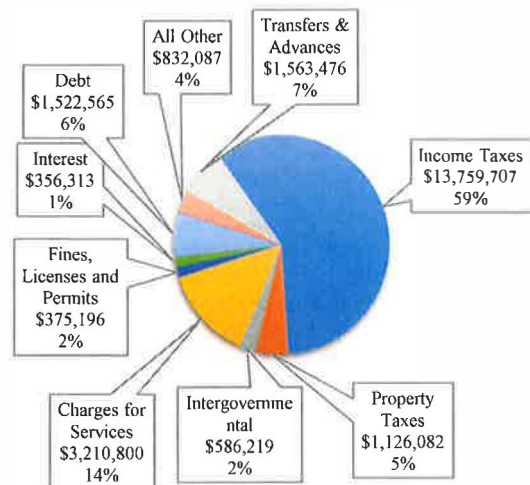
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 59% of all revenues. Revenues were \$1,246,811 higher when compared to YTD July 2022 primarily attributed to the timing of transfers/advances between funds, capacity fees received by the Sewer Capital Fund, and income tax revenues.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

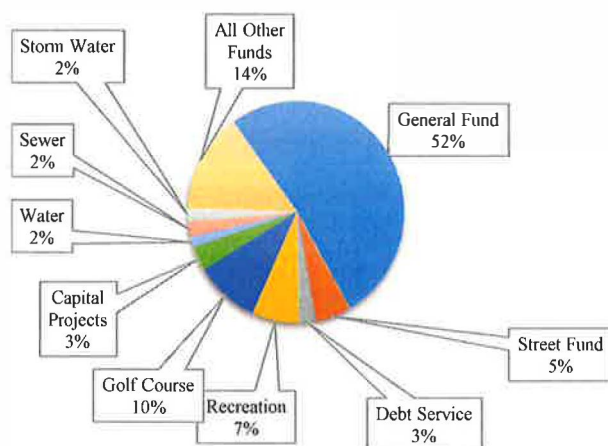


TOTAL YTD REVENUES BY TYPE

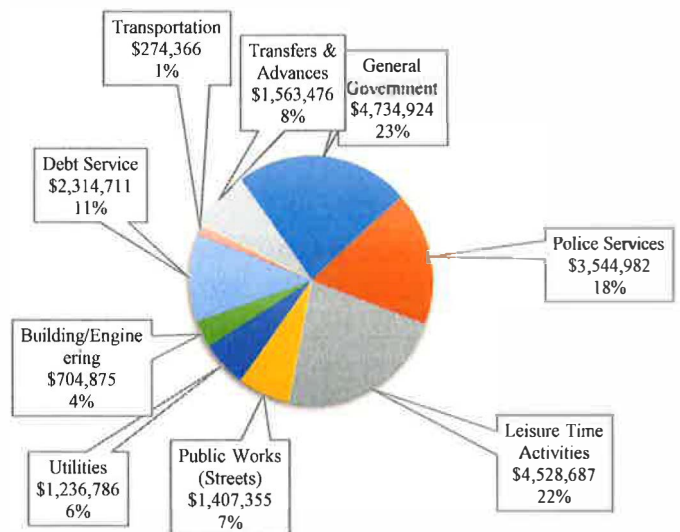

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



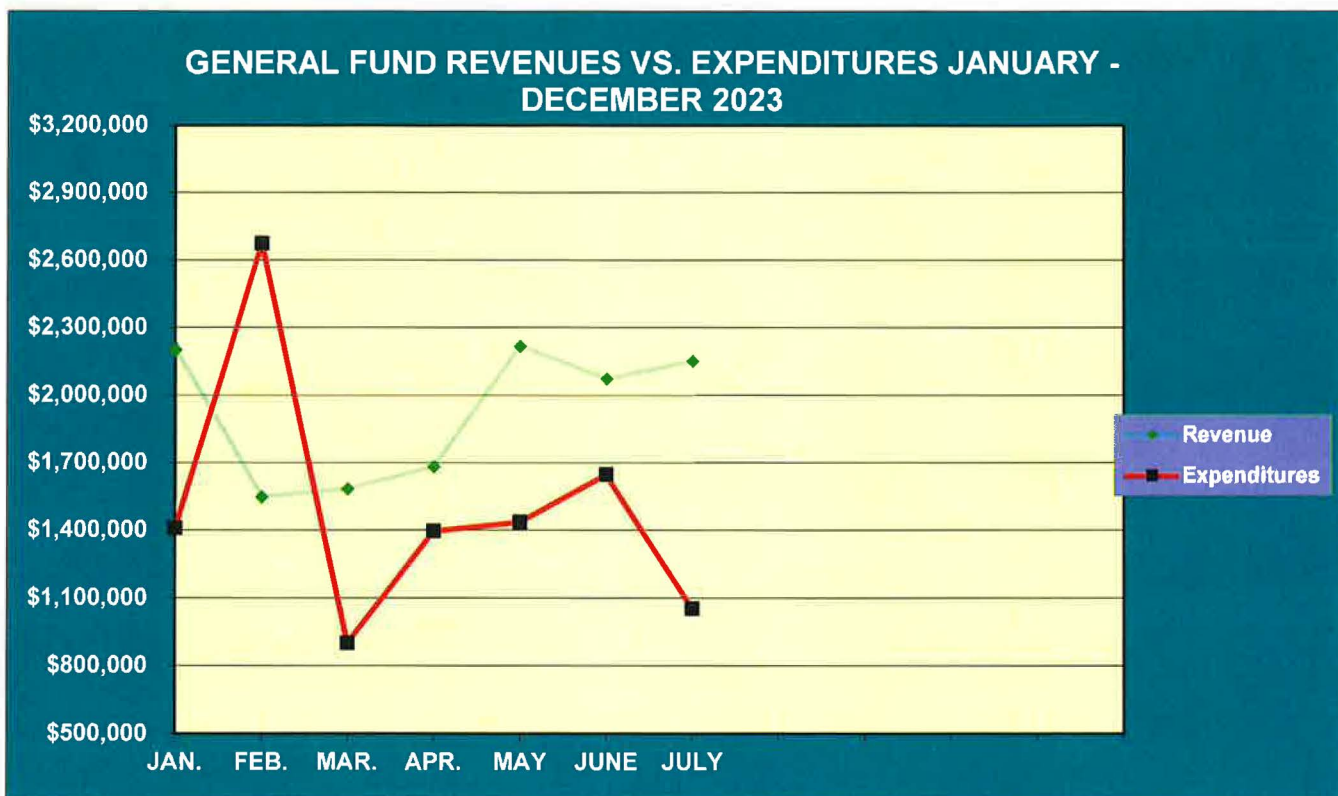
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$242,830 lower when compared to YTD July 2022 which was primarily attributed to the timing of the bond anticipation note principal and interest payment from the Golf Course, Debt Service and Street Funds of \$1,849,500 offset by lower economic incentive payments, construction costs associated with the Rarey's Port and Wert's Grove Buildings as well as transfers between funds.

GENERAL FUND

Through July 2023, General Fund revenues were \$1,961,480 higher while expenditures were \$7,078 lower when compared to YTD July 2022.



General Fund balance was \$12,825,571 at July 31, 2023, or \$5,924,993 higher than July 31, 2022. Unencumbered cash (cash less outstanding encumbrances) was \$11,801,546.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2023:

The Recreation Fund and Golf Course have historically operated at losses. In order to "break-even" annual transfers from the General Fund are necessary. Through the YTD July 2023, Recreation Fund operational receipts were higher by \$18,498.26 and Golf Course Fund receipts were higher by \$130,106.30 when compared to the prior year.

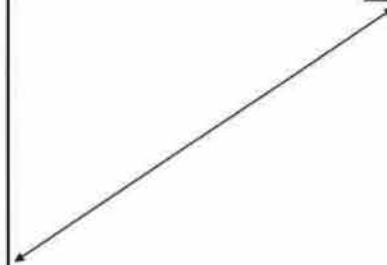
