Grant Funding-

The Groveport Police Department has received confirmation on (2) two Ohio Department of Public Safety Office of Criminal Justice Services Grants. These grants will help cover the cost of Equipment and Services on Body Worn Cameras, First Aid Trauma Packs, Rifle Rated Ballistic Shields, Radio Related Equipment for the police department. In total, we have been awarded \$74,301.27 (Body Worn Camera Funding-\$35,736; Edward Byrne Memorial Justice Assistance -\$38,565.27).

The big positive to this funding, the new radio system that will be utilized by the Police Department, will be funded by the grant funding, our patrol vehicles will now be issued a ballistic shield to carry on duty, and all officers will be issued individual trauma first aid packs, while the supervisor vehicles will have large medic packs.

Training-

Sgt. Josh Guiler has finished his second week of the Police Executive Leadership College that is held by the Ohio Association Chiefs of Police. This training is to expand the networking and knowledge base of the students, and push the student to create a project reference the policing community and our community. Sgt. Guiler will conclude this training in March.

Det. Danny Amabile just returned back from Alabama from a week of training with the United States Secret Service. The training that was paid in full by the Secret Service was teaching the participants new computer technology with software related equipment. As part of the training, each participating agency receives a (1) one-year free license of computer software that can work its way through security and firewalls on cell phones and computer related equipment, and this software is valued annually at \$30k. As being a participating member in the US Secret Service Computer Crimes Task Force, we agree to utilize any equipment and software provided to us in Cyber Crimes to other outside law enforcement agencies, we will have to obtain search warrants, and any agency in the Central Ohio who obtains a search will be able to have our Detective Bureau run a search of potential evidence in a cyber related crime that is being investigated.

Ptl. Gregrey Martin has completed a 16 Hour Criminal Interdiction Course at the Ohio State Highway Patrol Academy. This training gives an officer training on what to look for when they conduct a traffic stop, and the possible indicators of criminal activity associated with the individual operating the vehicle, along with the vehicle being used to transport illegal contraband.



Heavy Hauler Transport Loads-

Sgt. John Westhoven has been planning our response to the Heavy Haulers coming through the City of Groveport. His focus was making sure we have proper coverage to patrol the areas of the city affected by the oversized load transport path, he also looked at having units available in case the Ohio State Highway Patrol and the Columbus Police Department Commercial Vehicle Enforcement needed assistance within our city limits to block off roadways or direct traffic to keep traffic patterns moving as smoothly as possible. Finally, Sgt. Westhoven wanted to keep track of any possible traffic control devices that may be damaged during the hauler moving through our community, and he will be conducting photo documentation if any damage is discovered after each transport leaves Groveport.

Damage to Groveport Police Cruiser-

On Monday, February 26, 2024 in the early afternoon, Sgt. Josh Gilbert was on State Route 317, just North of Williams Road. While operating a marked patrol vehicle, a driver struck the patrol car's rear end, which caused substantial damage to the vehicle, but Sgt. Gilbert escaped the auto accident without injury.

The at fault driver has been found not to have valid vehicle insurance, which means the damaged patrol vehicle will be covered under our city's vehicle insurance carrier. The at fault driver was issued a citation by Columbus Police Department for Assured Clear Distance Ahead which is a Minor Misdemeanor Violation, which carries a maximum fine of \$150 if convicted/pleads guilty.

At this point and time, the estimates to repair Patrol Car 05 is over \$12,000, without getting to deep into the damaged areas of the vehicle. The vehicle has been taken out of service due to the damage to the rear end and bent frame components of the vehicle. Patrol Car 05 is a 2018 Ford Police Interceptor Utility, with over 87,000 miles on the odometer. Currently our insurance is evaluating the options of repairing or preparing to lose the vehicle as a total loss.



Tornado Warning-

On February 28, 2024, around 4:45 am, the National Weather service issued a Tornado Warning for the Franklin County area, I was able to communicate with Rec Center Director Seth Bower in order to prepare his staff for the storm front moving through the Southern portion of the Franklin County area. Seth and his staff were able to bring in the members waiting for the Rec Center to open at 5:30 am and have them shelter in the locker rooms until the storm front pushed through our community. As you may know, the National Weather Service has concluded that Lithopolis Road around the Metro Parks entrance had an EF0 twister land and cause damage to several trees surrounding the Metro Parks property.

I want to recognize Seth and his staff for their quick actions and decision making to ensure our Rec Center Members were safe during this abnormally early severe weather storm. It is my hope before any other storms like this one occurs, we will have our new radio communication equipment up and running to have a direct line of communications between the different city departments.

First Responders Luncheon-

July Festivities: Regarding the planned Groveport July celebrations. Your Command staff, comprising Lieutenant Josh Short, Sergeant John Westhoven, and myself, have diligently convened multiple planning sessions throughout this month to meticulously outline the arrangements for the upcoming July 3rd-4th celebration. With clear objectives in mind, our strategic planning endeavors are coalescing seamlessly, we are excited to be such a big part of this event.

Chaplains: I am thrilled to share some wonderful news with you all. I am delighted to announce that we have made significant strides in enhancing access and communication with our esteemed departmental Chaplains, Christi Hall and Rick Jones. Their enthusiastic response and eagerness to become more involved have been truly inspiring.

Recently, I had the pleasure of meeting with both Chaplains individually to discuss the implementation of our Wellness objectives [Policy] and its primary goals. Our discussions were incredibly productive, and I am confident that their involvement will greatly contribute to our wellness initiatives.

I am truly excited about the prospect of working closely with Chaplains Hall and Jones as we continue to prioritize the well-being of our Police Officers and foster a supportive work environment, ideally not within our own microcosm, but city-wide in allegiance to the adopted slogan – One City – One Team.

Peer Support Team: Related to the above topic, The Peer Support Team convened with Chaplain Christi Hall at the conclusion of this month. This inaugural gathering served to introduce the objectives and mission of peer support for the Groveport Police Officers, helping to explain its integration within the Wellness Policy framework. Chaplain Christi Hall discussed invaluable insights and resources, recommending immediate training initiatives. The primary aim of peer support is to furnish emotional and practical assistance to our public safety personnel during personal or professional crises, while also proactively addressing potential challenges. The peer support program will be implemented in accordance with a structured written policy, ensuring organizational adherence. Recognition of support across all Police organizational levels is instrumental in fostering the efficacy of a peer support program. These guidelines aim to offer information and recommendations for establishing and sustaining a peer support framework for both sworn and civilian personnel within law enforcement agencies, inclusive of our esteemed Administrative Assistant. While not authoritarian in nature, these guidelines aim to establish a flexible and confidential system capable of providing layered support to Officers facing difficulties, tailored to individual and agency-specific circumstances. The team found the meeting encouraging and eagerly anticipates advancing their mission.

Temporary Holding Facility: The two small rooms repurposed for a Temporary Holding area have been approved this month by Bureau of Adult Detention / Dept. of Rehabilitation & Corrections. This process will be repeated annually. Chief Adams has worked hard on the initial groundwork regarding this objective. We are happy to be able to utilize these high-tech rooms for Officer Safety and Detainee's well-being.

Incidents:

On February 14, 2024 at Sgt. Bell made a traffic stop for Speed. The driver was slow to stop and would not pull over until she got to the Waffle House and parked in a parking spot. The driver was found to be driving under suspension and had a total of 7 active arrest warrants. She was placed under arrest, and advised many times to let us know if she had anything that would be considered contraband, drugs, weapons, etc, as it would be a felony. She stated many times she had nothing. While slating at the jail, it was found that the suspect had a bundle of drugs (suspected Fentanyl) hidden in her vagina. The drugs were confiscated and sent to the crime lab and the suspect will be charged when the results come back.

Notable Activity for the Month:

The month of February has been consumed by PELC training where I have been unable to do much patrolling. And most likely this will be the same for the next two months.

Reserve Officer Ghafoor Nasir completed a total of 17 hours of service for February. 8 hours on patrol 9 hours of training. This includes CPT – Lexipol







The Groveport Detective Bureau processes countless search warrants and subpoenas each month to complete our cases. With these court orders being needed for nearly every investigation, it would be very difficult to keep an exact number processed each month.

Notable Cases:

- On 2/2/2024, Detectives investigated a 5-year old Groveport residence who arrived at school with medical issues. The investigation concluded the child had ingested "gummies" that contained THC. The child was hospitalized for 3-days and released. The father of the child, 28-yr Groveport male, was charged with endangering children for negligently leaving the THC gummies out.
- On 2/9/2024, Detective Gilbert responded to Children's Hospital on a report of an 18-month child exposed to an opioid. Detectives worked closely with medical staff and children services. No conclusive narcotics were located during drug testing. The case will have no criminal charges as we cannot confirm if the child fell ill from anything illegal. Children Services has a safety plan in place with the family.
- On 2/9/2024, Detectives and Franklin County SWAT members took a 41-year old Columbus female into custody who had been breaking into vehicles in Groveport. The female has been charged with stealing numerous items as well as using the victims credit cards.
- On 2/12/2024, Detective Amabile began investigating nearly \$2,000 in fraudulent transactions to a Groveport residents credit card. The investigation is ongoing.
- On 2/15/2024, Detective Gilbert was called in to assist with an operating a vehicle under the influence arrest. A 54-year old Groveport male had been taken into custody for OVI and refused to perform any tests being asked of him. Due to the male's extensive conviction history for OVI, the male was transported to the hospital and a search warrant was execute for the male's blood. The male was slated into the Franklin County Jail.
- As the Ohio Revised Code, 2903.18, has added new case law on strangulation when it comes to domestic violence, the Detective Bureau has been reading felony level domestic violence by strangulation cases to the grand jury.
