City Administrator Report to Council BJ King, City Administrator February 13, 2023

Legislation

Ord. 2023-005 - Purchase of Tractor of Public Works

Approval of this ordinance would authorize, via Sourcewell Competitive Bid Program, a New Holland tractor for use by the Public Works Department. This tractor will be used for roadside mowing and other tasks as needed. The cost to purchase this tractor is \$87,637.19. The approved 2023 budget includes \$155,000 for this purchase and the associated mowing assembly (Ord. 2023-006 – see below). If approved, this tractor will replace an aged 1986 model that is becoming increasingly unreliable and difficult to repair. The new tractor will have a boom arm mower, making it possible to mow behind guardrails. As with other vehicles and equipment, time is short to assure we can receive this equipment due to availability. Therefore, the Administration requests passage of his ordinance as an emergency.

Ord. 2023-006 Public Works Tractor Mowing Assembly

This is a companion ordinance to Ordinance 2023-005 (above). Approval of this ordinance would authorize the purchase of a mowing deck assembly, for use on the tractor presented in Ordinance 2023-005, for the amount of \$65,474.04. This purchase will be made thru the State of Ohio Cooperative Purchase Plan. The approved 2023 budget includes \$155,000 for the purchase of this mower assembly and related tractor. As with other vehicles and equipment, time is short to assure we can receive this equipment due to availability. Therefore, the Administration requests passage of his ordinance as an emergency.

Ord. 2023-007 – Reserved Parking Spaces for the Birch Tavern Carryout Customers

The Birch Tavern has requested two parking spots in the Municipal Parking Lot, behind the business, be designated for carryout order parking. Approval of this ordinance would authorize the designation of two parking spots for this requested purpose. This ordinance should be referred to the February 20th Committee of the Whole meeting.
