

6. Zoning Ordinance for 3rd Reading:

Chief Building Official Stephen Moore informed Council that the applicant

is requesting not to install landscaping along the west property line. There are about fifteen Junipers there that are required for screening against residential. He said Dr. Carroll and adjacent property owner Mr. Fout are asking that it not be required to install those plants. It's really there to protect those neighbors. The fence goes around part of the west side, along the back, and then there's landscaping along the east side. He said all but those fifteen Juniper plants have been installed, so it's a pretty small ask for this. When the second development comes in, you could always ask for additional screening there. That second lot is still a residential property right now, and it sounds like they're not quite sure when they're going to do that second development. Council Member Rupp confirmed that if the resident changed or phase two came in, at that point we could require the screening.

Aaron Carroll approached the podium and expressed how neither he nor Mr. Fout were desirous of the screening between the two properties. He said 325 Main street is residential. We originally had aspirations of maybe putting something more similar to the building that we have at 337 Main Street, preferably another medical building. There are no plans to do anything like that any time soon. We have a nice family living in the house now on a long-term lease, so we plan on keeping it residential for the foreseeable future. He said he understands that if Mr. Fout were to leave or if something were to change with the development of that property, we might have stipulations and zoning requirements.

Ted Fout greeted Council and stated that he agrees with everything Dr. Carroll has said. The building looks nice and is lit well at night. We actually feel a lot safer at night with all the lighting he has, and we just don't want the bushes at all. We feel the screening would be unsightly and not good for Groveport. They tend to collect leaves and trash in them. He said he and his wife prefer the openness and really don't want the screening at all.

Council Member Cleary thanked both gentlemen for coming in to speak.
