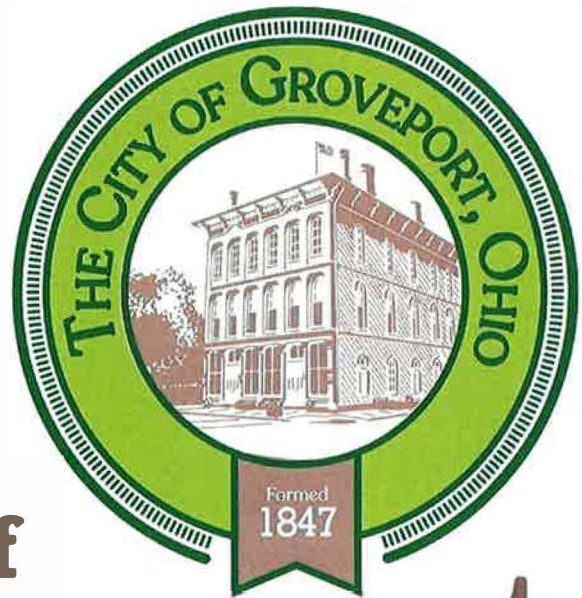

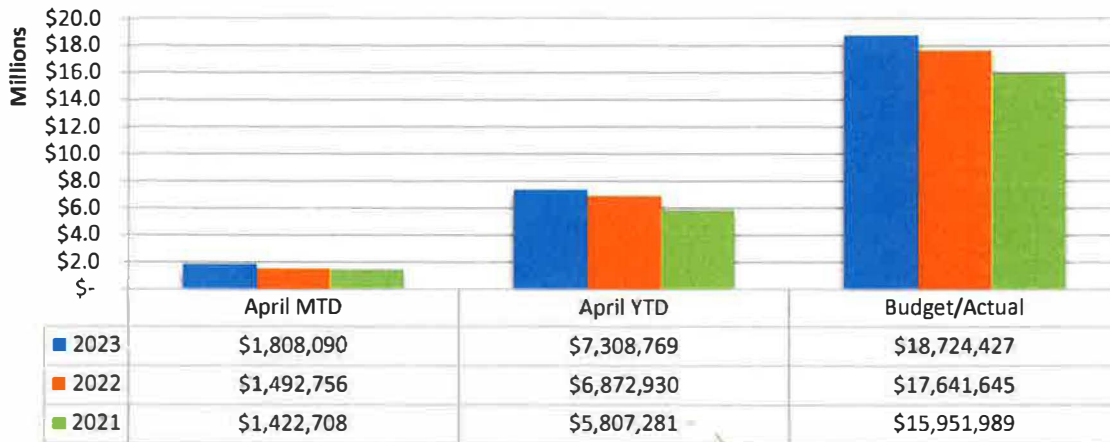

The following is a summary of financial activity for the year-to-date (YTD) April 30, 2023:

FINANCIAL SUMMARY

- General Fund balance was \$10,528,095 at April 30, 2023, or \$5,181,816 higher than April 30, 2022.
- The Recreation & Aquatic Fund balance was \$19,331, or \$334,298 lower than April 2022 based on the timing of transfers from the General Fund;
- The Storm Water Fund balance was lower by \$46,653 lower when compared to April 2022 and is primarily attributed to the proportionate share of public works employees' salaries and benefits and higher maintenance and repair costs and lower receipts;
- The Sewer Fund balance was lower by \$130,774 compared to April 2022 which is based on the timing of payments to the City of Columbus and also timing of deposits paid at month-end.

INCOME TAX COLLECTIONS – ALL FUNDS



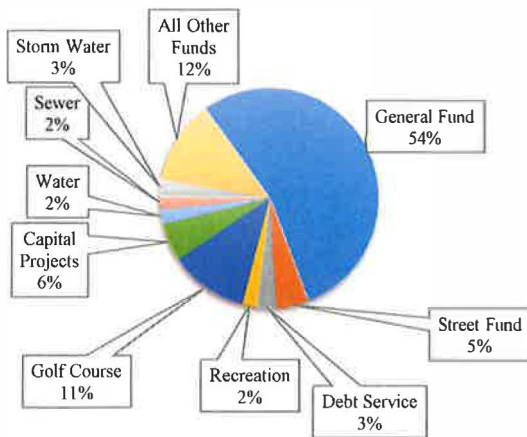
Income tax collections for the year-to-date April 30, 2023 were \$7,308,769, or 39% of the 2023 budget and were \$435,839, or 6% higher when compared to the prior year. Income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$6,169,954, \$50,000, \$362,938 and \$725,877, respectively.

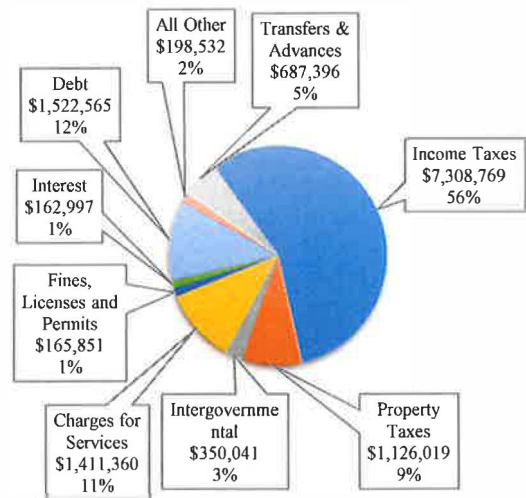
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 56% of all revenues. Revenues were \$223,398 higher when compared to YTD April 2022 primarily attributed to the timing of transfers between funds, capacity fees received by the Sewer Capital Fund, and income tax revenues.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

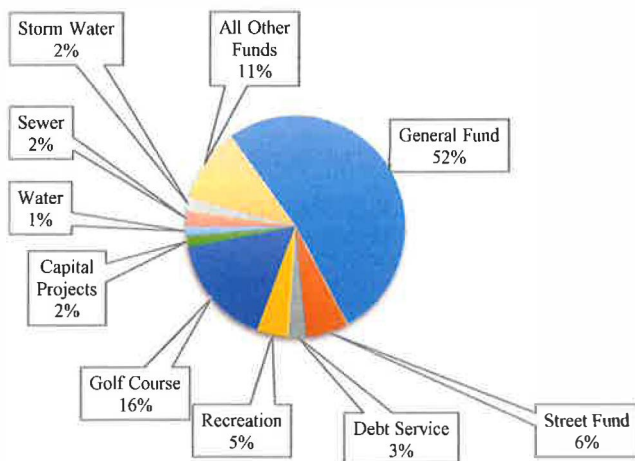


TOTAL YTD REVENUES BY TYPE

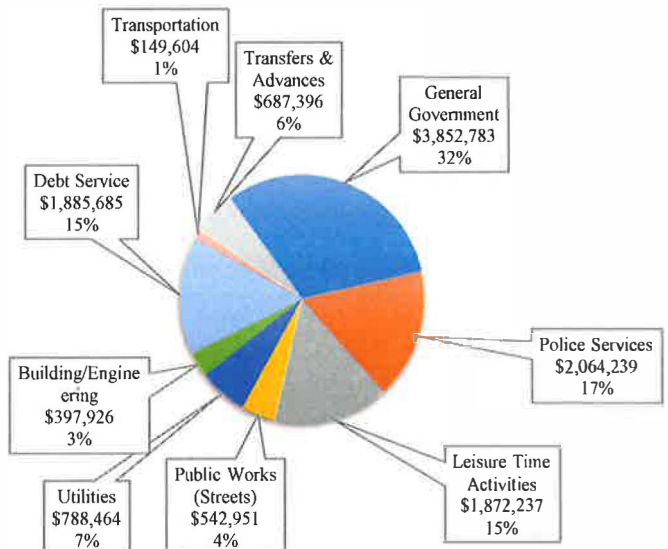

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



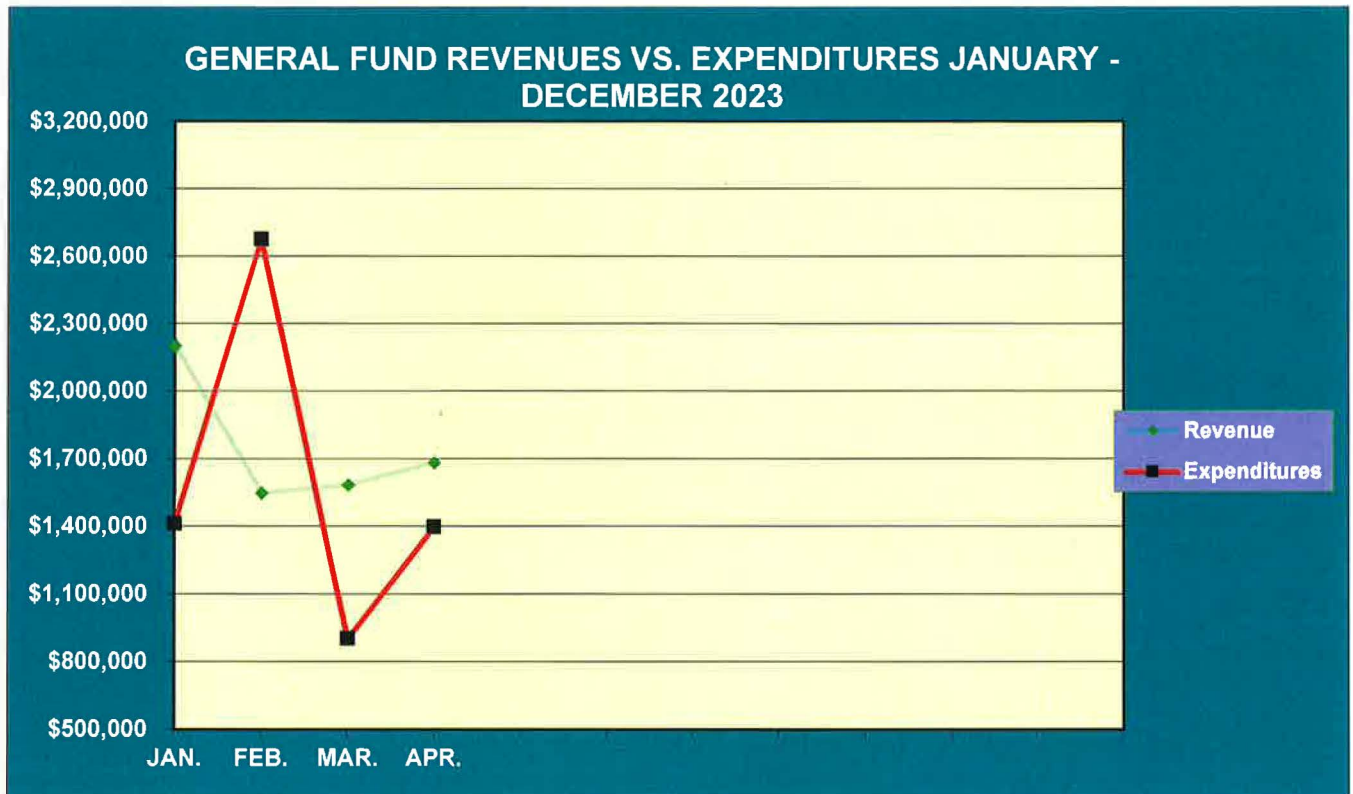
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$468,847 lower when compared to YTD April 2022 which was primarily attributed to the timing of transfers between funds, lower economic incentive payments, and lower construction costs for the Rarey's Port and Wert's Grove buildings.

GENERAL FUND

Through April 2023, General Fund revenues were \$595,635 higher while expenditures were \$629,746 lower when compared to YTD April 2022.



General Fund balance was \$10,528,095 at April 30, 2023, or \$5,181,816 higher than April 30, 2022. Unencumbered cash (cash less outstanding encumbrances) was \$9,076,647.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2023:

The Recreation Fund and Golf Course have historically operated at losses. In order to “break-even” annual transfers from the General Fund are necessary. Through the YTD April 2023, Recreation Fund operational receipts were higher by \$44,186.86 and Golf Course Fund receipts were higher by \$57,814.67 when compared to the prior year.

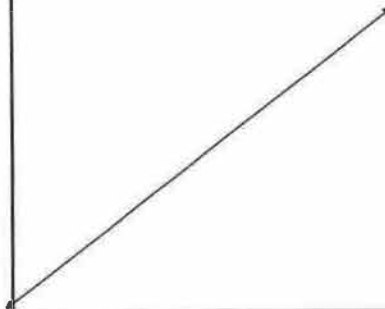
