### **Grant Funding Update-**

The Groveport Police Department has been informed that we are eligible to receive funding for three (3) different Ohio Office of Criminal Justice Services (OCJS) Grants that were applied for in 2022 and 2023. During the month of January, Pre-Award Condition per the OCJS were reviewed and completed by me, and submitted back to the OCJS office for final review by the grant review team. The following grants are currently in this stage:

### > PSN-Project Safe Neighborhoods 2022

- Original Funding Request-\$94,188
- Revised Pre-Award Conditions Amount from OCJS-\$58,388

### **Edward Byrne Memorial Justice Assistance Grant 2023**

- Original Funding Request-\$117,500
  - (City 25% Match \$40,000 Payment)
- Revised Pre-Award Conditions Amount form OCJS-\$40,500
  - (City 25% Match \$10,125)

#### Body Worn Camera Grant 2024

In regards to the adjustments from the original request and the revised amounts in the grant proposals, the Pre-Award Conditions are descriptive on what can be purchased when or if the funding is issued to the Groveport Police Department. It is my hope that this process will be completed between the Groveport Police Department and OCJS within the next 90 days.



#### **Guest Appearance Instruction-**

Lt. Josh Short and myself attended the Fairfield Career Center on Tuesday, January 30th, 2024. The reason for our visit to the Law Enforcement Program at the Fairfield Career Center was to guest instruct the law enforcement student on Traffic Stop Tactics, we instructed over 50 students during this time, and we conducted practical exercises with all the students.

It is our opinion that these students who are attending a career center program, and looking to make the law enforcement profession a career as they turn the legal age to becoming a police officer, permits us to begin a recruiting process. We want these students to first have a realistic view of a basic job function in policing, then be able to apply what they have learned in the law enforcement program, and then give us the opportunity to further instruct and give the students constructive criticism as the event concludes. The students want real life practical examples, but also be able to ask questions as they evolve in the program. We see this engagement creates a conducive environment to not only influence their future goals and career aspirations, but also give these students a positive view in policing as a whole.

#### **Shift Adjustments-**

As the new year began, the Groveport Police Department has seen some of the officers move to other shifts. Sgt. Ernie Bell has moved to the Mid-Night Shift, where he has already seen increases in traffic enforcement, where Speed Violations have been the common violation on this shift. Sgt. Josh Guiler is now working the Relief Shift, where he covers the Afternoon Shift Sergeant and Mid-Night Shift Sergeant days off, and this gives us a Patrol Sergeant coverage on a more consistent basis 7 days a week.

Sgt. Guiler is also currently attending the Police Executive Leadership College (PELC) training, this police training is highly regarded by the Ohio Association Chiefs of Police organization, along with police organizations across the State of Ohio.

### INTEL Oversize Transports-

The Intel Oversize Transports have been a constant topic of discussion within the City of Groveport Directors meetings, along with the virtual meetings between the City of Groveport, the transport haulers, and the State of Ohio Department of Transportation. What we have discovered is the information that is provided changes almost daily. Currently the Manchester, Ohio site where the shipments will be off loaded from the barges to the haulers is currently under water and the shipments are being delayed to the end of February to early March.

#### Other information provided:

- Shipments totals 20 to 40 total shipments.
- Multiple Haulers will be utilized to bring these shipments from Manchester, Ohio to the Intel site.
- Each shipment can take from 10 to 14 days to complete the transport by the hauler, and only one shipment can be on the roadway during the transport timeline.
- At this point, no permits to move the shipments have been approved by the State of Ohio.
- (6) State Highway Patrol and (13) Columbus Police Department units will be utilized to escort the haulers through Franklin County.
- New shipments arriving every other weekend through at least the end of this year. (if not into 2025)
- Shipment sizes will vary from 200 ft in length, up to 270 foot in length, with a 20ft height to each load
- Weights from 400K lbs to 900k lbs.
- Saturday shipments will be parked on Old Bixby Road @ Bixby Road.
- State Route 317 between Bixby Road to Saltzgaber Road will require temporary road closures as the shipment operates on the roadway.
- Weather conditions can determine if a load will be moved from staging area to each daily check point.

As I have discussed in the City Council Meetings, there are more unknowns to this project, than knowns when it comes to the shipments and time lines. The State of Ohio Department of Transportation Public Relations Office has communicated that they will be posting press releases on their website when a shipment leaves and is approaching a jurisdiction. It will be my goal to relay these messages from the State of Ohio to our print media partners and social media outlets, in order to inform our community of these shipments.

#### **Captain Kurt Blevins-**

- JANUARY saw the completion of evaluations for Lieutenant Bary Murphy and Patrol Lieutenant Josh Short. As well as the transition from 2023 files to 2024. We were fortunate not to be the recipient of any significant weather this month.
- TEMPORARY HOLDING FACILITY: Chief Adams has tasked me with getting the twin Temporary Holding rooms inspected and up to State code. The two room can be utilized to detain up two persons separately for a period of up to 6 hours. Generally, detention does not come close to that mark. The rooms are equipped with advanced audio and video surveillance, as well as a two-way communication system, these added features enable our Officers to communicate through speakers to provide individuals the means to signal for assistance if necessary.

Another key advantage is the separation of suspected criminal parties, enhancing their safety and ours while preventing potential collaboration. Additionally, these facilities offer a quiet environment, facilitating a space for individuals to better calm themselves and regain composer. The audio and visual recording capabilities serve as crucial tools, ensuring accurate documentation of interactions and interviews which can be invaluable for legal proceedings and maintaining transparency in law enforcement practices. Overall, our Temporary Holding Facility is designed to balance our security needs with the welfare of the individuals detained, promoting efficient, secure, and accountable processes.

POLICY REPORT: An annual Policy review of the entire Policy Manual was distributed to every officer. This annual review started by my office to keep the staff up to date and familiar with our policies. The Staff has until May 1, 2024 to complete their comprehensive review.

#### **Objectives:**

- In light of the preliminary July 4th general meeting, Patrol Lieutenant Josh Short and I are meticulously entering the planning phase for the upcoming parade and fireworks celebration. Our concerted efforts are directed toward exploring innovative strategies to overcome challenges identified from the previous year's event. Our paramount objective remains the safety and security of all attendees, ensuring an environment conducive to the enjoyment of the festivities.
- In December of last year, I proposed initiating a monthly or bi-monthly dialogue between the Chaplains and our members. This initiative aims to foster a deeper understanding and connection between the chaplains and our staff, promoting a supportive and a better cohesive working environment.

The primary objective of these regular communications is in concert with Chief Adams ultimate goals for the betterment of mental health. This is also to acquaint the chaplains with the various facets of our department, including its staff and ongoing current activities. This will provide an opportunity for our team members to interact with them if they so choose, establishing a more personal and meaningful connection.



I suggested the possibility of having the chaplains contribute a short paragraph or two via e-mail dialogue by authoring a monthly or even bi-monthly departmental email. This could serve as a platform for sharing insights, reflections, or words of encouragement with the entire team. Such communication could play a vital role in nurturing a sense of community and providing a source of inspiration for our dedicated staff. Establishing trust and familiarity is paramount for many in order to fully engage and take advantage of this opportunity.

I believe that these interactions will not only enhance the spiritual support within our department but also contribute to a positive and inclusive work environment. As of this report I have not heard back on any course of action regarding this suggested objective.

#### January Report: Lt. Josh Short-

On the 10<sup>th</sup> I had a zoom call with Rosetta Stone to set up language learning software for our officers. Chief Adams has authorized me to acquire licenses to Rosetta Stone's online program so that officers can learn languages, such as Spanish and French, that will assist us in communicating with non-English speakers that we regularly come into contact with. This program should be up and running by the middle of February.

On the 31<sup>st</sup> I attended the Groveport Madison District Safety Committee meeting. This is a regular meeting compromised of district officials and community volunteers. The purpose of these meetings is to discuss safety/security concerns around the district. This session focused on issues at the elementary schools and the fact that students often act out with immediate violence instead of talking through situations or seeking help.

During the first week of the month Chief Adams and I met with each shift and discussed the departmental goals and expectations and made sure the shift supervisors know what is expected.

Officers have been working special duty security for GM home basketball games. To date there have been no issues at these events. One adult student mother was charged with disorderly conduct after she told a ticket taker that the weapons detection system didn't work and she had brought a gun into the school. She was later confronted by school administrators, in the presence of an officer, and admitted that she did not bring a gun into the school but had a keychain that looked like a gun. She was issued a criminal summons and trespassed from school property.

Ofc Dillard has been released from field training status and is now assigned to third shift for his probationary time. He has received very positive scores and remarks from all of his coaches and supervisors.

Ofc Gregrey Martin was released from probationary status and is currently assigned to third shift.



### NON-HIGH SCHOOL ACTIVITY OF NOTE:

1/11 – Patrol officer dispatched to Groveport Elementary on report of identity theft. Incident had nothing to do with the school or district but ID theft alert came to victim's (staff member) district email.

1/28 – Patrol officer took report on alleged bullying/assault issue that had occurred at Middle School South. Incident still under investigation at this time.

No reported issues at any other GM school, Madison Christian School, Eastland Career Center, or Imagine School.

The City of Groveport owns 10-Flock cameras currently, but as a part of Flock we currently have access to 4,347 cameras nationwide.

#### Clearview Facial Recognition

Clearview Facial Recognition Scans - 60 searches in January, 2024 with 83% identifying rate.



The Groveport Detective Bureau processes countless search warrants and subpoenas each month to complete our cases. With these court orders being needed for nearly every investigation, it would be very difficult to keep an exact number processed each month.



#### Notable Cases:

- On 1/1/2024, officers responded to Rabid Customs (Ricart) on a breaking and entering. The male fled the scene on foot and left his vehicle/trailer at the scene unattended. Officers located tires, rims and misc. auto parts the suspect threw over the fence to steal. Officers discovered numerous packages inside the abandoned vehicle with various addresses on them. Detectives followed-up on the case and identified numerous victims from the apartment complex behind Giant Eagle had their packages stolen. These packages contained everything from clothing, electronics to hospice medical products. All packages were returned. Detectives learned the suspect had broken into the apartment complex's package room and stole the packages. Officer Martin's great observation skills observed a vehicle leaving the area behaving suspiciously and stopped it. Both occupants of the vehicle were identified and released. Detectives were later able to charge the 42-year old male passenger with two counts of breaking and entering.
- On 1/3/2024, Detective Amabile assisted a Greenhill Dr resident with getting \$1,100 back from a
  contractor she paid to due work, but never showed to start the job. The Detective Bureau persuaded the
  34- year old Hilliard male to return the money to the victim in lieu of being criminally charged. All
  money was returned.
- 1/16/2024, Detectives responded to the unexpected death of a 57-year old resident. The Detective
  Bureau has received assistance from the Bureau of Criminal Investigations and the Franklin County
  Coroner's office on the case. The case outcome is pending an official autopsy.
- On 1/16/2024, numerous windows were smashed from vehicles in the warehouse district. The suspect
  was driving a stolen vehicle and stole numerous credit cards from the victim's cars. The suspect used
  the victims credit cards numerous times. Detectives were able to identify the suspect and warrants have
  been issued for the arrest of a 40-yr female from Columbus.
- On 1/26/2024, Detectives began an investigation into an alleged sexual assault of a juvenile, at a school, by another juvenile. The investigation is ongoing.
- On 1/30/2024, Detectives assisted school resource officers and patrol officer with an 18-yr old
  Columbus male bringing a loaded gun to the High School. The .40 caliber Glock was loaded with 16rounds of ammunition in the magazine/chamber of the weapon. The male was slated into jail for illegal
  conveyance of a firearm on school grounds, a felony of the fifth degree.



- At the beginning of January, 2024, the Detective Bureau partnered with Worthington Police Department
  to investigate a group that were cutting catalytic converters in the warehouse area of Groveport and
  multiple other jurisdictions. The investigation has led to thefts from Groveport, Worthington, Ohio
  State, Reynoldsburg, Ohio Health Hospitals and Dublin from the same two suspects. At this time, the
  main "scrapper" of these converters has received excess of 1-million dollars from converters. The case
  is ongoing.
- Detectives assisted the U.S. Marshals with numerous violent fugitives with warrants being arrested in January. All these warrants are from the Columbus area.
