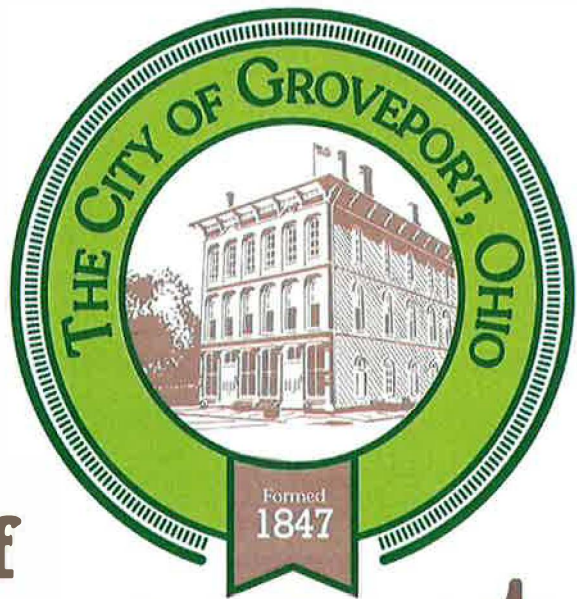

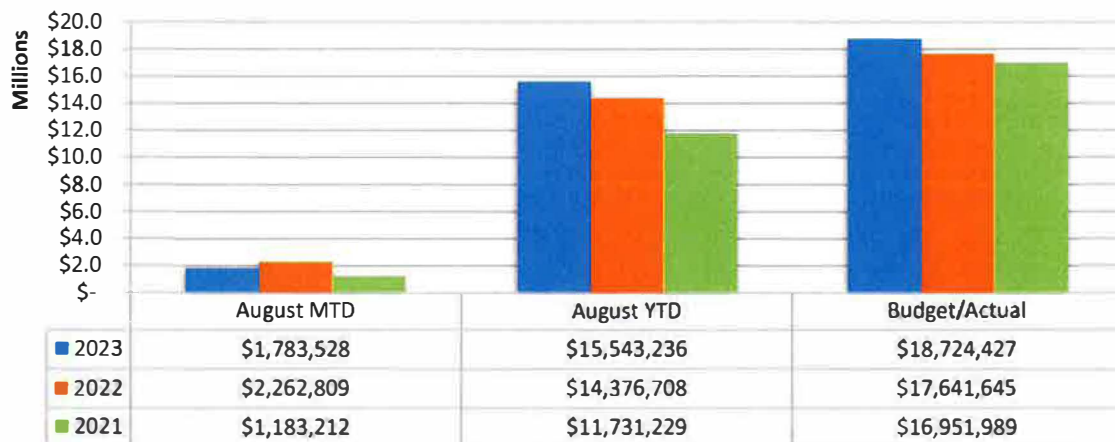

The following is a summary of financial activity for the year-to-date (YTD) August 31, 2023:

FINANCIAL SUMMARY

- General Fund balance was \$13,713,354 at August 31, 2023, or \$5,706,812 higher than August 31, 2022.
- The Recreation & Aquatic Fund balance was (\$118,398), or \$149,350 lower than August 2023 based on the timing of transfers from the General Fund;
- The Storm Water Fund balance was lower by \$6,803 higher when compared to August 2022 and is primarily attributed to the proportionate share of public works employees' salaries and benefits and higher maintenance and repair costs and lower receipts;
- The Sewer Fund balance was \$9,104 lower from August 2022 as receipts and expenses are consistent between years.

INCOME TAX COLLECTIONS – ALL FUNDS



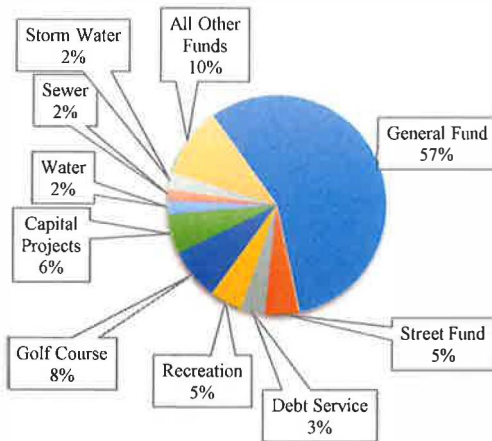
Income tax collections for the year-to-date August 31, 2023 were \$15,543,236, or 83% of the 2023 budget and were \$479,281, or 21% lower when compared to the prior year. Income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$13,126,750, \$100,000, \$772,162 and \$1,544,324, respectively.

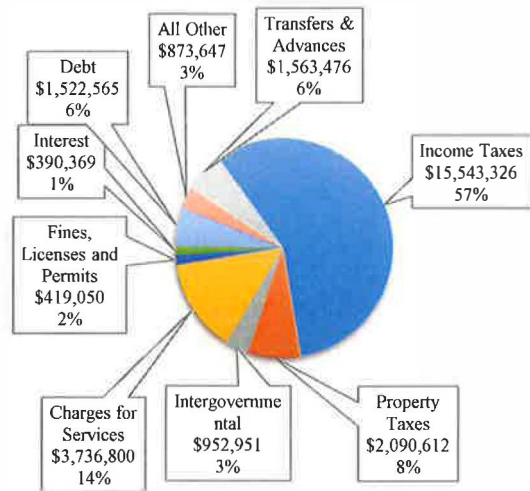
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 57% of all revenues. Revenues were \$1,186,060 higher when compared to YTD August 2022 primarily attributed to the timing of transfers/advances between funds, capacity fees received by the Sewer Capital Fund, and income tax revenues.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

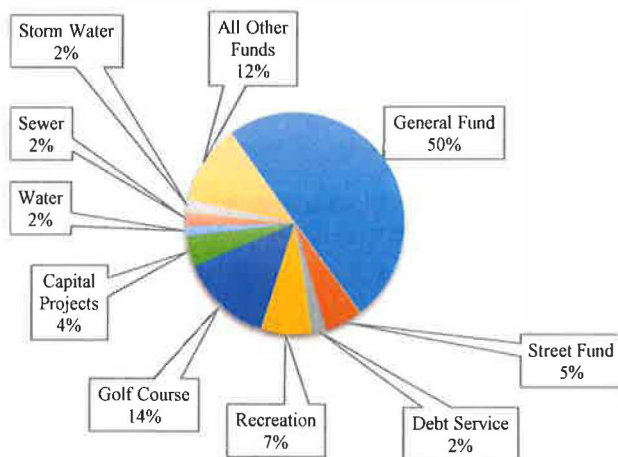


TOTAL YTD REVENUES BY TYPE

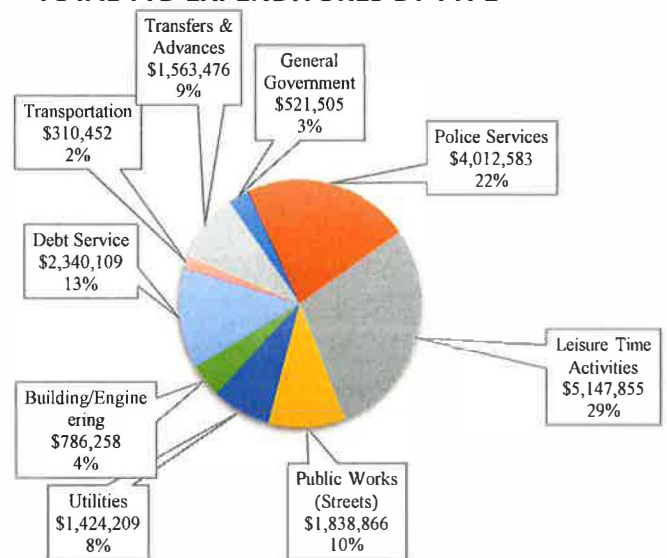

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



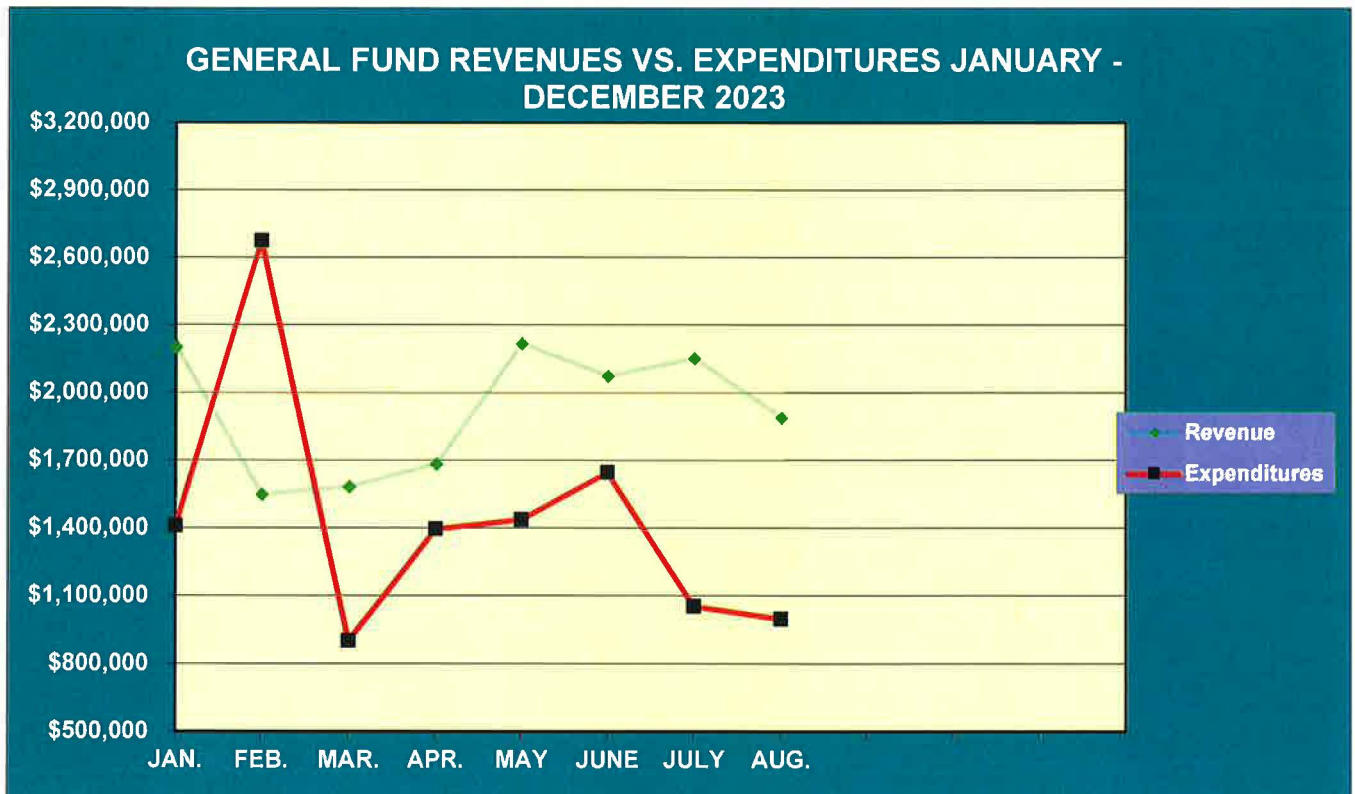
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$535,672 higher when compared to YTD August 2022 which was primarily attributed to the timing of the bond anticipation note principal and interest payment from the Golf Course, Debt Service and Street Funds of \$1,849,500. Increases also attributed to higher capital project costs, such as the purchase of new truck for public works and street maintenance paving project costs. City did not lower lower economic incentive payments, construction costs associated with the Rarey's Port and Wert's Grove Buildings as well as transfers between funds off-setting the total increase between years.

GENERAL FUND

Through August 2023, General Fund revenues were \$1,641,142 higher while expenditures were \$109,235 lower when compared to YTD August 2022.



General Fund balance was \$13,713,354 at August 31, 2023, or \$5,706,812 higher than August 31, 2022. Unencumbered cash (cash less outstanding encumbrances) was \$12,755,211.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2023:

The Recreation Fund and Golf Course have historically operated at losses. In order to "break-even" annual transfers from the General Fund are necessary. Through the YTD August 2023, Recreation Fund operational receipts were higher by \$30,514.49 and Golf Course Fund operational receipts were higher by \$120,640.96 when compared to the prior year.
