FEBRUARY POLICY REPORT:

Monthly Policy Review: Regular monthly reviews of

- **Policy 319 - Standards of Conduct:** This policy establishes standards of conduct that are consistent with the values and mission of the Groveport Police Department and are expected of all department members. The standards contained in this policy are not intended to be an exhaustive list of requirements and prohibitions but they do identify many of the important matters concerning conduct. In addition to the provisions of this policy, members are subject to all other provisions contained in this manual, as well as any additional guidance on conduct that may be disseminated by this department or the member's supervisors.
- **Policy 325 - Outside Agency Assistance:** The purpose of this policy is to provide guidance to members when requesting or responding to a request for mutual aid or when assisting another law enforcement agency.
- **Policy 326 - Major Incident Notification:** The purpose of this policy is to provide guidance to members of this department in determining when, how and to whom notification of major incidents should be made.
- **Policy 338 - Service Animals:** Service animals play an important role in helping to overcome the limitations often faced by people with disabilities. The Groveport Police Department recognizes this need and is committed to making reasonable modifications to its policies, practices and procedures in accordance with Title II of the Americans with Disabilities Act of 1990 (ADA) to permit the use of service animals that are individually trained to assist a person with a disability.
- **Policy 341 - Community Relations:** The purpose of this policy is to provide guidelines for community relationship-building.

SRO February Incidents

On 2/3, I witnessed a juvenile male walking in the rear of MS Central during 5th period. I made contact with the student. Student said he just walked out school with no permission to do so because he was upset and needed to cool down. Student was returned to Groveport Elementary.

On 2/5, I accompanied MS South 8th graders during a school tour to the High School. Two incidents occurred, one student was removed for being disruptive and rude to staff during the assembly. The second incident, a female attempted to fight another student. Student's parents were notified and were picked up. Students were disciplined by school admin.

On 2/12 at MS South a female student chased another student with a pencil and eventually poked that student in the hand. Student was seen by nurse and student was disciplined by school admin. Prosecution declined.

On 2/13 at MS South, four students were involved in a fight on the school bus during the bus drive home. During the fight the bus driver was injured while attempting to break up the fight. Students were disciplined by school admin. Bus driver declined prosecution.

On 2/13 at MS South, two female students were involved in a fight that injured three teachers. Medics responded and treated two of the three teachers. All teachers declined prosecution and students were disciplined by school admin, including recommendation for exploitation. School requested DOC Charges. Stay put was issued and released after the females involved were emergency removed from school grounds.

On 2/14 at MS Central rumors arise of a female student having liquor on her person. The student was searched and Staff did find a suspicious water bottle with a known label containing a clear substance and a fruity smell. Student was not intoxicated the time of questioning. Parents were notified and student was disciplined by school admin. School admin couldn't confirm the substance in the bottle. School declined prosecution.

On 2/14, MS Central admin and myself partnered for a practice run of a lock down drill. My observation was requested during the practice to point out any additional factors or answer questions that may help assist staff and students.

On 2/20 at MS South, a stay put was issued for three females attempting to fight one student. Staff was able to de-escalate the first incident involving two females who were about to fight. While attempting to separate those students, the second incident occurred, two more females attempting to fight the same girl from the first incident. Students were all emergency removed from school and were disciplined by school admin. Prosecution declined.

On 2/21 at MS South, a male student stated that a teacher pushed and cursed at him. School admin has started the investigation. Teacher was counseled by school admin multiple times for being unprofessional.

On 2/21 at MS South during dismissal, a student asked a teacher, "What would she do if someone knocked her out!" Teacher stated she felt threaten.

On 2/21 at MS South, a male student (6 grader) stated that another male student (7th grader) entered into his bathroom stall without his permission. The 6 grader stated the other student inched his pants down, not revealing anything. The 6 grader crawled on the floor to get away and student found a staff member. Report taken.

On 2/25 at MS South a special needs student injured a teacher by pulling and yanking her hair. Teacher did seek medical attention for neck and head pain. Student was removed from school. School admin and teachers are attempting to create a safety plan for student. Prosecution declined.

Perimeter checks were randomly conducted. Admin was made aware of my findings for correction:
