VI. Business of Guests

William Milton of 5103 Blossom Court addressed Council on the "Catch and Release for age 16 and over" rule at Palm's Pond in Heritage Park. Mr. Milton stated the City needs more adequate signage to be posted at the entrance to the pond and at the

shelter. No sign can be seen at the shelter/picnic area. People come to fish at night and not seeing the sign for the catch and release rule, they are taking the fish with them. The fish in the pond have been diminished and he asked if our police and the Ohio Department of Natural Resources could patrol the area more often to check for fishing licenses and if people are following the rules. Ohio Department of Natural Resources have not been seen in the area of the pond checking for fishing violations. Posting park hours would help keep people from fishing the pond during closed hours. Council Member Cleary inquired if the pond could be replenished sooner than the fall when it is re-stocked in time for Apple Butter Day. Council Member Hilbert directed Administrator Hall to have Dennis Moore look into the matter. Council Member Rarey commented there used to be more signage and remarked about the waterline receding. Finance Director Green explained for restocking purposes the pond needed to be drained for the release of the new fish. Mayor Westcamp inquired if Groveport Police could stop to ask people to produce a fishing license. Law Director Shannon advised to let the ODNR handle that issue but the police can patrol the area at night and enforce no trespassing laws for those fishing after hours.
