Legislation

Ord. 19-018 Amend Recreation Center Membership Fees (3rd Reading)

Changes include:

- 1) Amend the fees so that the Day Pass Fees for the Aquatic Center (Outdoor Water Park) and Recreation Center are the same. This has become more important when considering the popularity of our Birthday Party Packages;
- 2) One change to the **Annual Pass Rates**. Staff added "Infant (0 2 Years)" classification. Persons in this age group were never charged, but nothing ever shown on the rate schedule:
- 3) One change to the **30-Day Pass Rates**. "High School Summer Pass" was added to the Ordinance. It has been in place as a "special promotion" for years;
- 4) Three changes to **Daily Fees for Non-Pass Holders**. The Day Pass Fees now mirror the Day Pass Fees associated with the Groveport Aquatic Center;
- Youth (3-12 Years) classification was eliminated, as all day pass holders will pay the same rate regardless of age. It is difficult for staff to determine age of customers and customers are not always truthful about the age of children in their party;
- Adult (13 Years & Above) classification was eliminated, as all day pass holders will pay the same rate regardless of age. It is difficult for staff to determine age of customers and customers are not always truthful about the age of children in their party.
- 20 Day Passes (Group Rate) was eliminated.

Ord. 19-021 Elm Street Parking Restrictions (2nd Reading)

Two Council members asked if staff would look at the possibility of making the narrow, western portion of Elm Street one way because of the difficulty of traveling on that section of the street due to its narrowness. We have verified that all houses along that stretch have off street parking. Legislation is being considered to limit parking on Elm Street from College to West to the south side of the street.
