# Legislation

Ord. 19-006 and Ord. 19-008 Amendments to the Code of Personnel Practices and Procedures and Section 143 (2<sup>nd</sup> Reading)

A small committee made up of the Law Director, HR Director, Asst. Administrator, Recreation Director and I have reviewed the Personnel Policy and Section 143, and updated it as needed. The red-lined version and accompanying summary that explains the changes are included with the legislation.

# Ord. 19-009 Special Olympics Cash Drop (1st Reading)

This is the Groveport Special Olympics' annual request to allow collection of donations on Main Street. This year they are requesting to be allowed to be at a fourth intersection, Main and Front Streets.

# Ord. 19-010 Amend Classification Plan to Include Assistant Administrator/Development Director Job Description (1st Reading)

Until 2011 there were two positions; Economic Development Director and Finance Director. In 2011, the Economic Development Director was made the Interim Finance Director when the then-current Finance Director resigned. Directing the Finance Department was in addition to his other duties overseeing economic development and acting as assistant administrator when required. In 2012, those duties became permanent. As the City has made advances to concentrate on the downtown, office and the city's Gateway districts, we believe that it's in the city's best interest to once again go back to two positions so that development can have the attention it requires. The proposed Assistant Administrator/Development Director position will retain the current pay grade of 21 for an Assistant Administrator position. Because this particular combination of responsibilities is a new position, it is required to be approved by Council. The job description for the Finance Director just requires some minor adjustments, remains at the same pay grade, so therefore is not required to be approved by Council.
