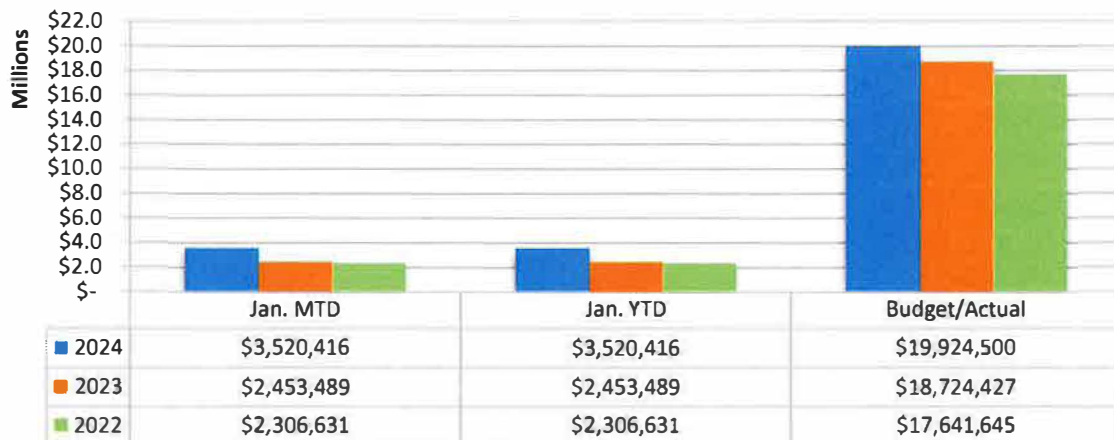

The following is a summary of financial activity for the year-to-date (YTD) January 31, 2024:

FINANCIAL SUMMARY

- General Fund balance was \$16,745,091 at January 31, 2024, or \$6,051,663 higher than January 31, 2023.
- The Recreation & Aquatic Fund balance was \$106,560, or \$99,666 lower than January 2023 based on a higher beginning balance at January 1, 2024;
- The City purchased non-callable certificates of deposit totaling \$4.5 million dollars, of which \$2 million mature in July 2027 and \$2.5 million mature in July 2026. Interest rates ranged from 4.05% - 4.45% noting all certificates of deposit are FDIC insured. Interest earned in the month of January 2024 was \$118,536.

INCOME TAX COLLECTIONS – ALL FUNDS



Income tax collections for the year-to-date January 31, 2024 were \$3,520,416, or 18% of the 2024 budget and were \$1,066,927, or 43% higher when compared to the prior year noting the increase is primarily attributed to estimated tax payments for calendar year 2023 totaling \$1,490,369 which is part of the increase. Income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$2,981,729, \$12,500, \$175,395 and \$350,792, respectively.

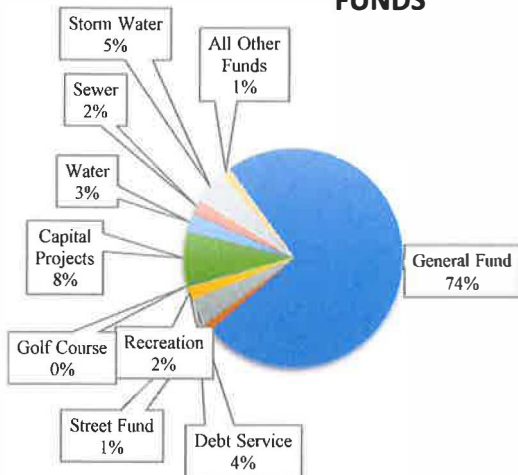

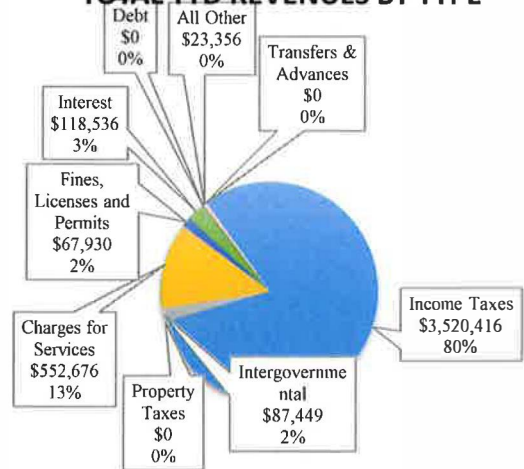
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 80% of all revenues. Revenues were \$1,116,526 higher when compared to YTD January 2023 primarily attributed to higher income tax revenues and transfers between funds.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

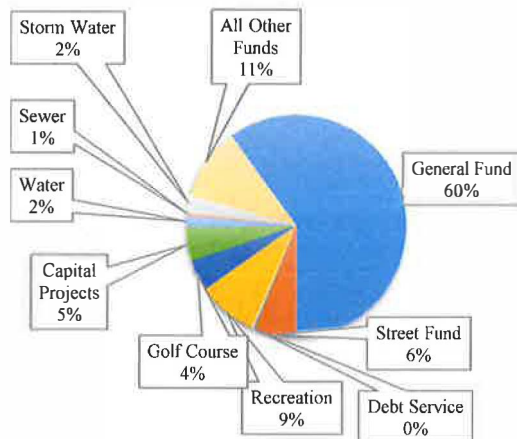


TOTAL YTD REVENUES BY TYPE

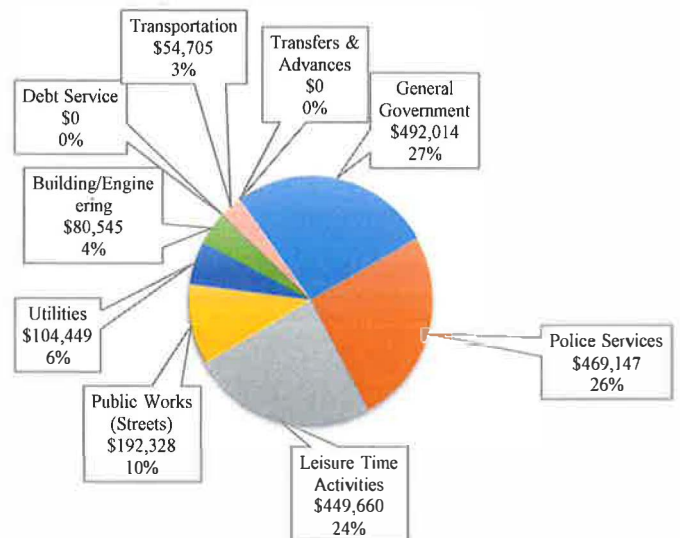

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



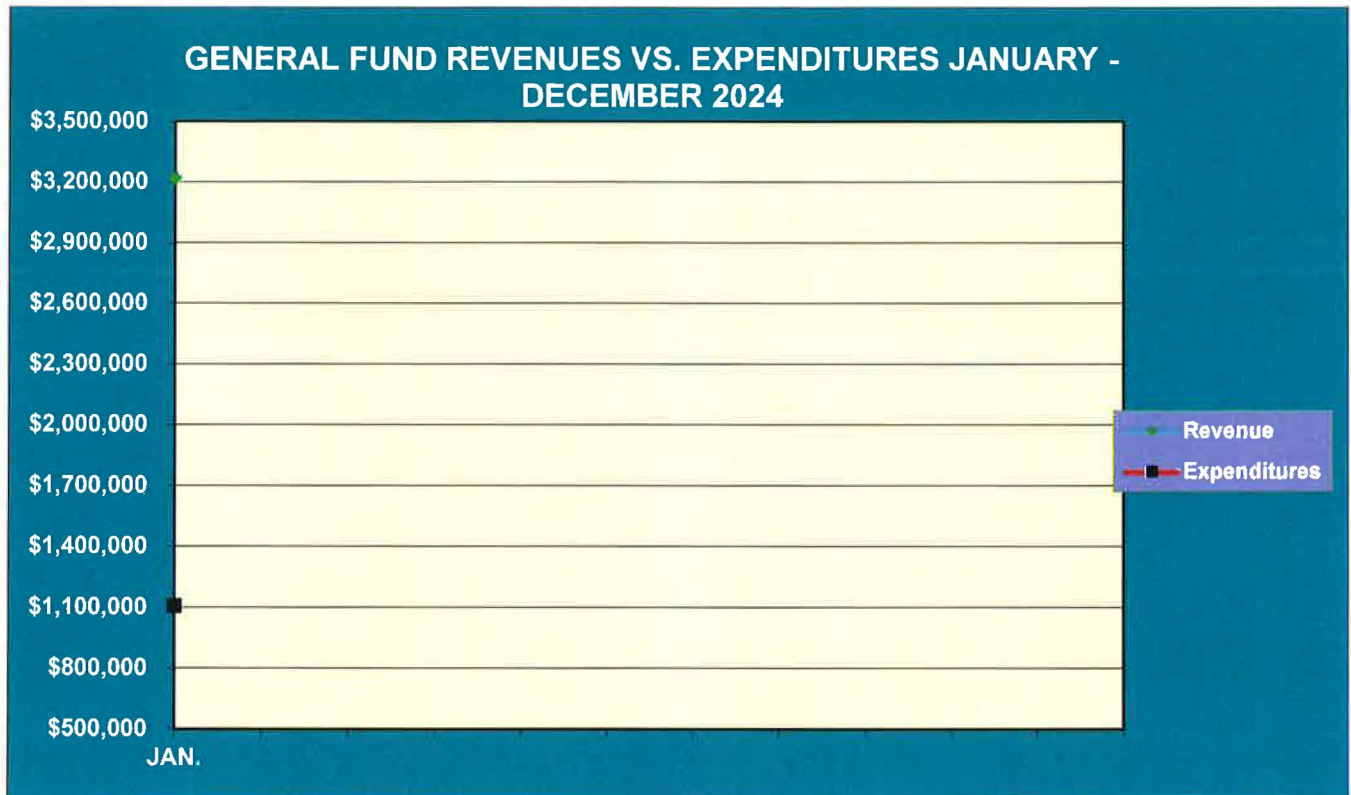
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$666,268 lower when compared to YTD January 2023 which was primarily attributed to lower salary and benefit costs and a large income tax refund paid in January 2023.

GENERAL FUND

Through January 2024, General Fund revenues were \$1,017,960 higher and expenditures were \$305,900 higher, respectively, when compared to YTD January 2023.



General Fund balance was \$16,745,091 at January 31, 2024, or \$6,051,663 higher than January 31, 2023. Unencumbered cash (cash less outstanding encumbrances) was \$15,126,138.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2024:

The Recreation Fund and Golf Course have historically operated at losses. In order to “break-even” annual transfers from the General Fund are necessary. Through the YTD January 2024, Recreation Fund operational receipts were higher by \$13,214.22 and Golf Course Fund receipts were lower by \$3,514.14 when compared to the prior year.
