DEFINITION:

Groveport Resident - defined as any individual residing within the corporate limits of the City of Groveport. This includes anyone within Taxing District 185. Persons are required at the time of purchase to provide a valid Ohio Driver's License or State Identification Card accompanied by a City of Groveport Water Bill, another utility bill or tax bill. NOTE: Although a person's address may state "Groveport", person may not actually live within the corporate limits of the City of Groveport.

Groveport Corporate Resident – defined as any individual that lives outside of the corporate limits of the City of Groveport, but is employed with the corporate limits of the City of Groveport. Individual is required to provide a recent pay stub (no more than 30 days old) showing the person's name, business address and proof that City of Groveport income tax is being withheld.

All other discounts, etc. currently received will continue to apply, as noted below.

- Current Groveport Recreation Center Annual Pass Holders, as well as Active Military, Police Officers and Fire Fighters are eligible to receive a 10% discount on the Season Pass of their choice.
- Persons that have a permanent disability (receiving Social Security Disability) are eligible to receive a 15% discount on their pass, depending on their individual classification.
- Non-Residents that purchase a Groveport Aquatic Center Season Pass shall be charged resident program fees for programs offered at the Groveport Aquatic Center.

RULES REGARDING DAY PASSES:

- 1. Group Rate (10-packs) will not be available for purchase for the remainder of the 2021 season.
- 2. Group Outings are not permitted. Group outings are defined as organized groups consisting of 6 or more persons.
- 3. Groveport Residents (as defined above) and their guests are eligible to purchase Day Passes. Groveport Resident must accompany guests to the Groveport Aquatic Center.
- 4. Season Pass Holders and their guests are eligible to purchase Day Passes. Season Pass Holder must accompany guests to the Groveport Aquatic Center.
- 5. Pre-Purchased and Pre-Issued Day Passes may be utilized provided conditions in #3 and/or #4 are met.

6. Persons who wish to utilize the Groveport Aquatic Center via Day Pass must first acquire a Groveport Recreation Department Issued Identification Card. GRD Issued ID Card must be presented and scanned at time of day pass payment and entry. ID Card Fees noted below.

- 7. Groveport Corporate Residents (as defined above) are not eligible to purchase a Day Pass, unless they are a guest of a Groveport Resident or Season Pass Holder.
- 8. The Director of Recreation, with the approval of the Administrator, shall have the authority to change classifications, definitions, rules & policies as needed.
