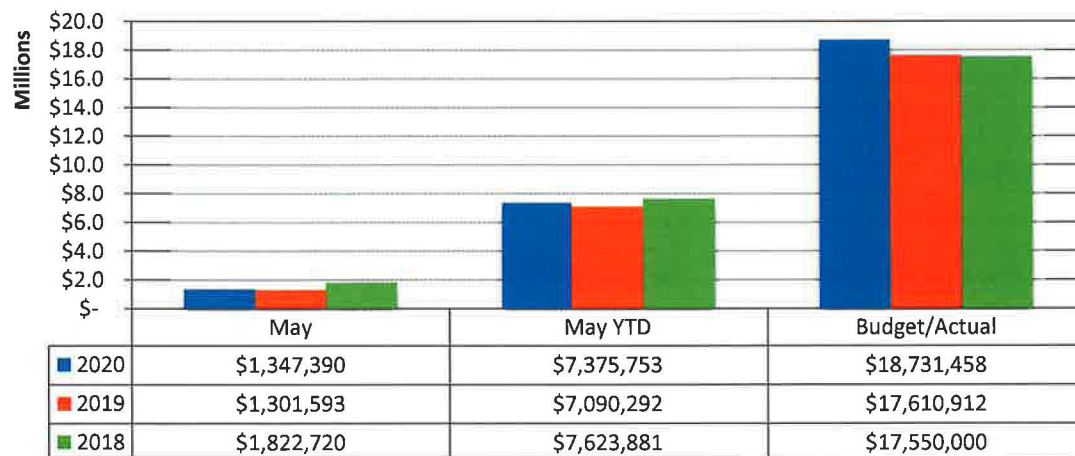

The following is a summary of financial activity for the year-to-date (YTD) April 30, 2020 highlighting the City's total and most significant funds.

FINANCIAL SUMMARY

The following is a summary of the City's financial activity year-to-date May 2020. Total fund balances through May 2020 totaled \$17,417,286, a decrease of \$47,113 from April 30, 2020. The City has collected 38.98% of total budgeted revenue and expended 34.61% of budgeted expenditures. Our current investment portfolio yield is 1.63% and duration is 0.968 years.

INCOME TAX COLLECTIONS – ALL FUNDS



Reconciled gross income tax collections for the year-to-date May 31, 2020 were \$7,375,753, or 39.4% of the 2020 budget and were \$285,461, or 4% higher when compared to the prior year. Gross income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$5,850,603, \$62,500, \$731,325 and \$731,325, respectively.

The change from the prior month is primarily attributed to timing of collections and payments when smoothed over a two-month period. The breakdown of collections is as follows:

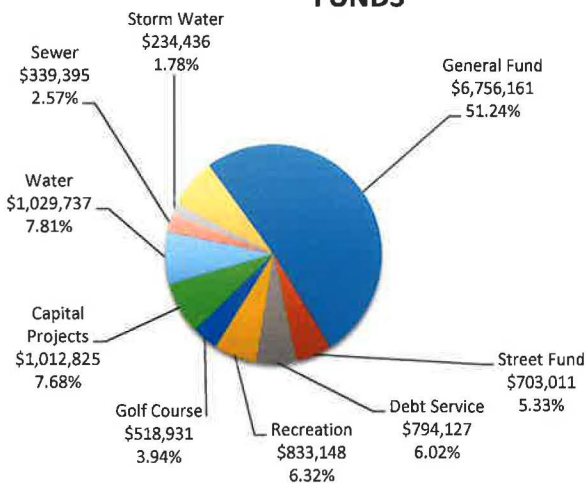

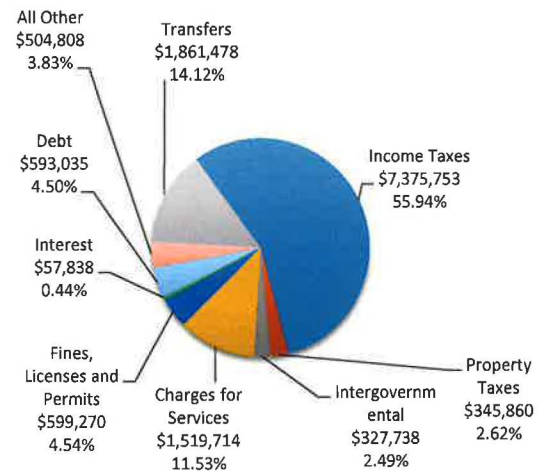
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 55.94% of all revenues. Revenues were \$563,844 lower when compared to YTD April 2020 primarily attributed the timing of transfers to the Street Fund, Recreation and Golf Course Funds.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

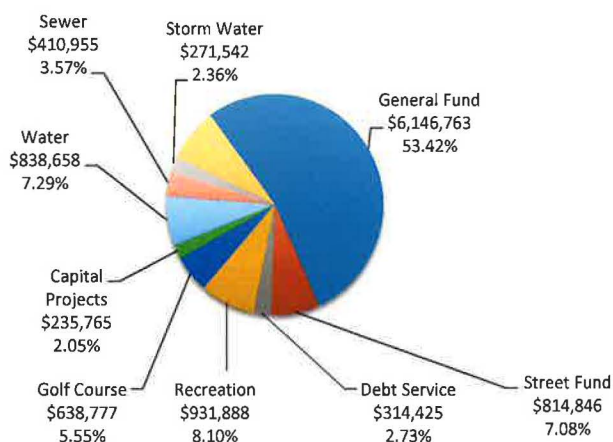


TOTAL YTD REVENUES BY TYPE

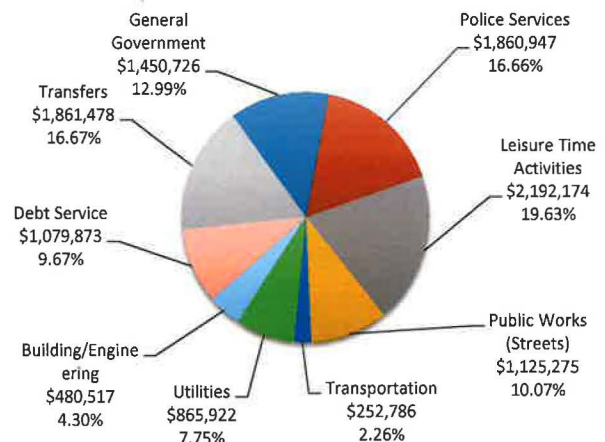

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



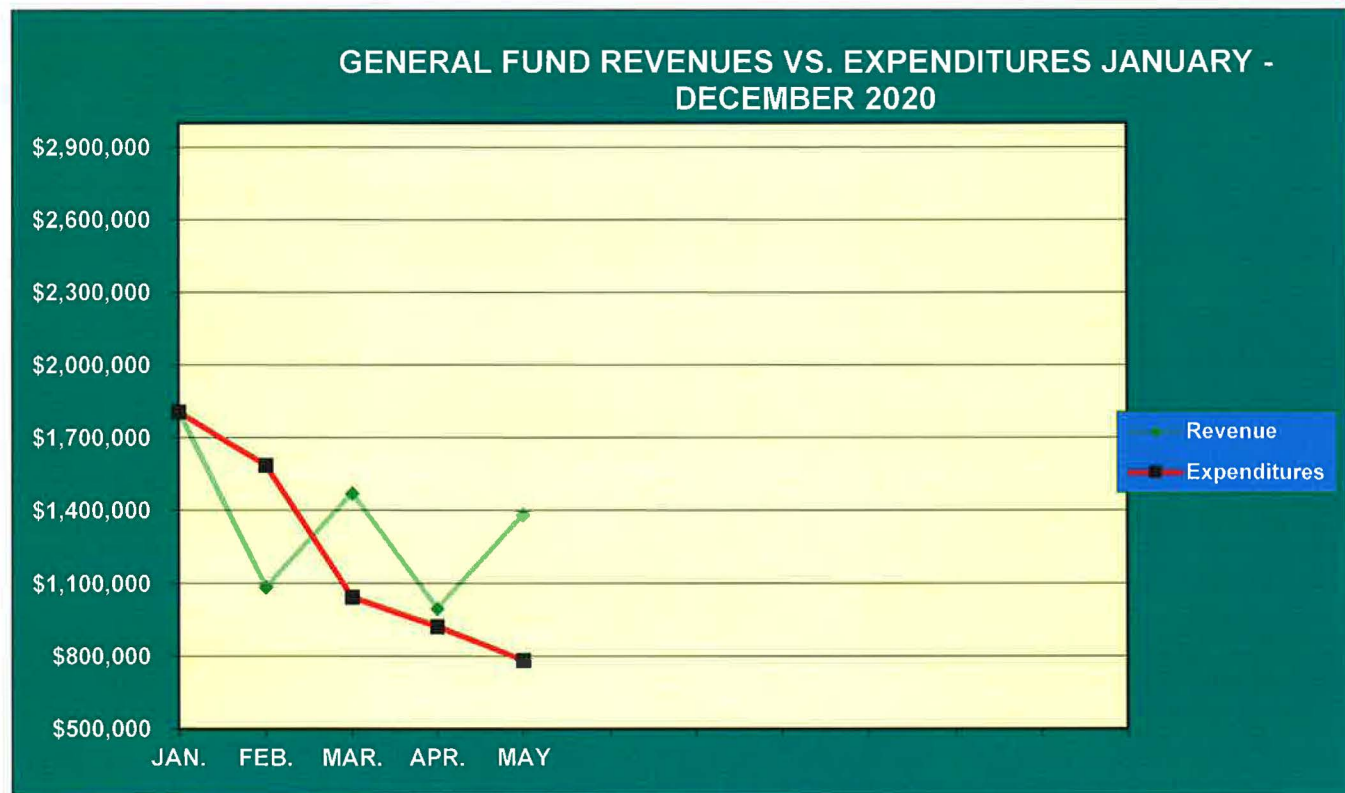
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$1,911,249 higher when compared to YTD April 2020 which relates to timing of debt service payments of \$299,684, capital projects paid of Street Fund (street projects completed in 2019 paid in 2020), and payments for capital related projects which were included in the 2020 capital improvement plan.

GENERAL FUND

Through May 2020, General Fund revenues were higher and expenditures lower by \$222,696 and \$975,546 higher, respectively, when compared to YTD May 2019.



General Fund cash balance was \$4,375,501 YTD May 30, 2020 which was \$2,820,032 higher compared to the same period last year. Unencumbered cash (cash less outstanding encumbrances) was \$2,563,575.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2020:

The Recreation Fund and Golf Course have historically operated at losses. In order to "break-even" annual transfers from the General Fund are necessary. Through the YTD May 2020, Recreation and Golf Course Funds operational receipts are down \$289,469.65 and \$158,380.73, respectively. Based on the current operating environment, we anticipate the need to increase budgeted transfers from the General Fund as these departments are unable to generate sufficient receipts from operations consistent with prior years.
