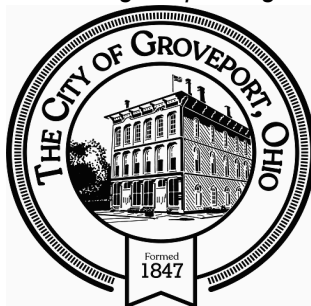

Also included is our outstanding indebtedness that we would have at the end of 2024. The amounts reported are estimates prepared as of today and will be used to help prepare the 2024 operating budget.
