Administrator BJ King explained that this ordinance would allow for remodeling of the administration wing of the municipal building to add additional office spaces, including space for the future City Engineer position. The preliminary estimate for the project is \$356,000. The construction would occur in spring 2026, but this legislation would allow for the purchase order to be issued this year. Leuko Construction has done previous work for the city, including the second floor, Choptank, and Lissy Bees projects.

VIII. Reports

A. Mayor - Lance Westcamp

Mayor Westcamp commented on the recent snowfall, noting it was the worst snow, blowing, and cold conditions he had experienced in his many years in Groveport. He praised the Public Services Department for their excellent snow removal efforts, stating that Groveport streets were clear by Sunday morning while neighboring communities still had snow-covered roads.

The Mayor made two appointments to the Planning and Zoning Commission:

- 1) Ed Dildine to replace Mr. Fridley who resigned
- 2) Jean Ann Hilbert to serve as Council's representative

B. Administrator - BJ King

Administrator King echoed the Mayor's comments about snow removal and thanked the Public Services Department for their excellent work. He mentioned that the staff luncheon on Friday was well-attended and appreciated by everyone. He wished everyone a Merry Christmas and noted that this was the last meeting of the year.

C. Chief of Police - Casey Adams

Chief Adams agreed that the roads were well-maintained during the snowstorm. He reported that police officers experienced only a couple of minor accidents over the weekend where cars slid into one another, with no injuries reported. He mentioned that officers had been assisting residents who locked themselves out of their cars and were checking on homeless individuals to ensure they stayed warm. The Chief noted that he would be out of town until the New Year.

D. Director of Finance - Jason Carr

Director Carr stated that the November financial report was included in Council's packets. He reported that \$1,400,000 in CDs had matured and were reinvested. In response to a question from Council about lower BWC refunds compared to last year, he explained that the refund amounts are determined by BWC based on money left in the pool and are not a reflection of any changes in the city's safety record, which remains good.

E. Director of Law - Kevin Shannon

Director Shannon wished everyone a Merry Christmas and Happy New Year.

F. Development Director - Michael Loges

Director Loges informed Council that a meeting with businesses affected by the Wirt Road reconstruction project was scheduled for the following morning. He noted that Wirt Road is slated to close on January 5, and they are working to ensure that residents and businesses are aware of the closure. Message boards have been in place for nearly two weeks along Main Street. The project is expected to last until the end of November next year.

Council member Rupp asked if the message board patterns could be changed as the closure date approaches to make them more noticeable to regular commuters. Steve Farst confirmed that signage would be updated throughout the project's five phases, including both electronic message boards and permanent signage.

Council member Cleary expressed frustration about Casto's lack of maintenance on the road over the years, which has contributed to the current need for repairs.

G. Council Members - Jean Ann Hilbert, Ed Dildine, Shawn Cleary, Becky Hutson, Scott Lockett and Jack Rupp

Mr. Rupp commented on the excellent turnout for the staff luncheon. He also reported that he attended a board meeting at another entity that lasted until 4:00 a.m., with a continuation meeting scheduled for the next day.

Mr. Lockett wished everyone a Merry Christmas and Happy New Year.

Mrs. Hutson wished everyone a Merry Christmas and Happy New Year. She noted that this could potentially be her last meeting and expressed that it had been an honor to serve.

Mr. Cleary asked about the city's plan to continue leaf collection, noting that the early snowfall had complicated the process. He suggested considering alternative approaches for dealing with leaf collection when complicated by snow. He praised the employee luncheon and thanked all participants, especially noting the contribution from the condo association and the success of the toy drive.

Mrs. Hilbert thanked the Mayor for the luncheon and expressed appreciation to all city departments for their work throughout the year. She noted that the recent snowfall was the worst she had experienced in 75 years.
