



The following is a summary of financial activity for the year-to-date (YTD) October 31, 2025:

FINANCIAL SUMMARY

- General Fund balance was \$29,185,761 at October 31, 2025, or \$7,532,031 higher than October 31, 2024.
- The Recreation Fund and Golf Course have historically operated at losses. In order to “break-even” annual transfers from the General Fund are necessary. Through the YTD October 2025, Recreation operational receipts were \$15,723.72 higher and Golf Course Fund operational receipts were lower by \$104,131.31 when compared to the prior year. Operating expenses for the Recreation Fund increased \$82,484.67 or 3% from October 2024 while Golf Course operating expenses decreased \$63,577 or 7% from October 2024.
- The City invested \$496,880 in certificates of deposit, federal securities of \$1,478,953 and U.S. Treasury Note of \$498,340. The average yield for new investments was 3.65%. Interest earnings year-to-date October 2025 were \$1,368,798, or \$134,071 higher than prior year of \$1,234,727.

INCOME TAX COLLECTIONS – ALL FUNDS




Income tax collections for the year-to-date October 31, 2025 were \$24,576,735, or 121% of the 2025 budget and were \$2,363,786, or 11% higher when compared to the prior year.


REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 64% of all revenues exclusive of debt proceeds. Revenues were \$6,917,449 higher when compared to YTD October 2024 primarily attributed to an increase in bond anticipation note proceeds of \$4,000,000 and higher income tax collections between years.

TOTAL YTD REVENUE BY FUND - ALL FUNDS




TOTAL YTD REVENUES BY TYPE




EXPENDITURES

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS




TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$2,636,855 higher when compared to YTD October 2024 which was primarily attributed higher salary and benefit costs and higher capital project fund (401) expenditures by \$2,192,186.

GENERAL FUND OPERATIONS

Through October 2025, General Fund revenues were \$2,292,510 higher and expenditures were \$289,938 higher, respectively when compared to YTD October 2024.



General Fund balance was \$29,185,761 at October 31, 2025, or \$7,532,031 higher than October 31, 2024. Unencumbered cash (cash less outstanding encumbrances) was \$28,096,180.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2025:
