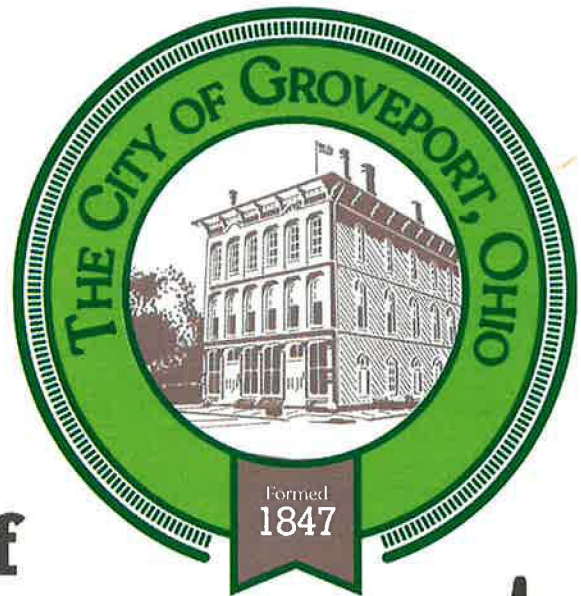

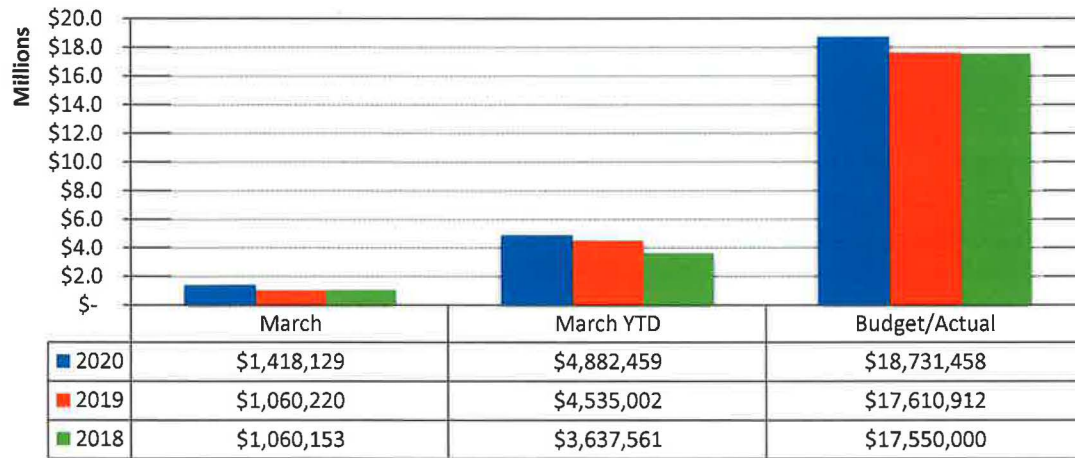

The following is a summary of financial activity for the year-to-date (YTD) March 31, 2020 highlighting the City's total and most significant funds.

**FINANCIAL SUMMARY**

The following is a summary of the City's financial activity year-to-date March 2020. Total fund balances through March 2020 totaled \$17,237,342, an increase of \$724,661 from February 29, 2020. The City has collected 25.92% of total budgeted revenue and expended 21.07% of budgeted expenditures. Our current investment portfolio yield is 1.47% and duration is 1.92 years.

**INCOME TAX COLLECTIONS – ALL FUNDS**



Gross income tax collections for the year-to-date March 31, 2020 were \$4,882,459, or 26.1% of the 2020 budget and were \$347,457, or 7.66% higher when compared to the prior year. Gross income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$3,875,968, \$37,500, \$484,496 and \$484,496, respectively.

The change from the prior month is primarily attributed to timing of collections and payments when smoothed over a two-month period. The breakdown of collections is as follows:

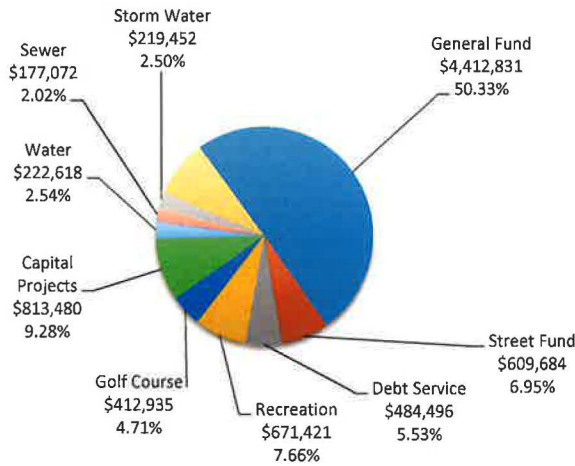

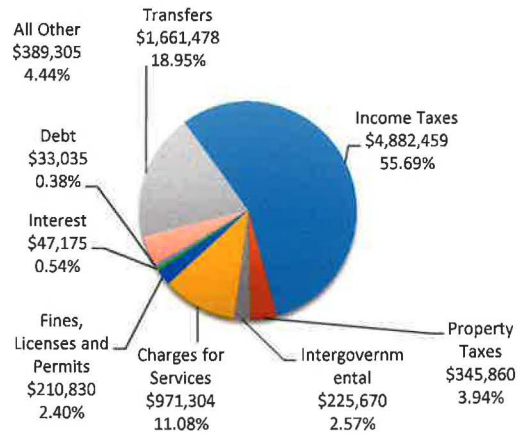
**REVENUES**

Income tax revenues comprised the largest portion of total revenues year-to-date, or 50.33% of all revenues. Revenues were \$1,115,908 higher when compared to YTD March 2020 primarily attributed to higher income taxes and timing of transfers to the Street Fund, Recreation and Golf Course Funds.

**TOTAL YTD REVENUE BY FUND - ALL FUNDS**

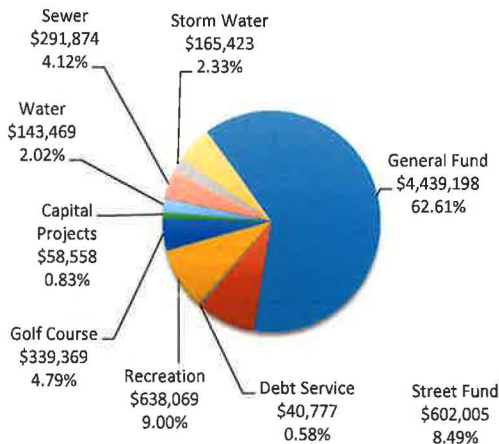


**TOTAL YTD REVENUES BY TYPE**

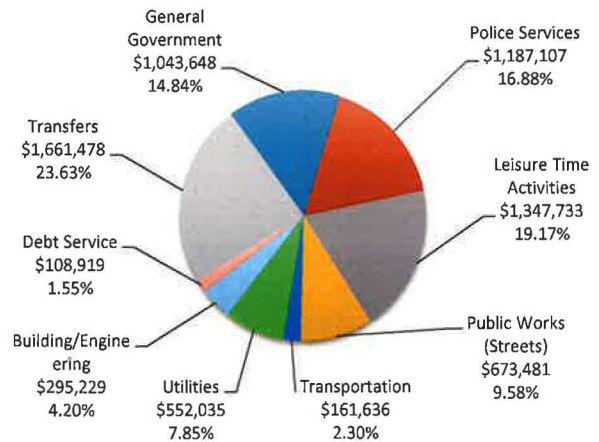

**TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS**



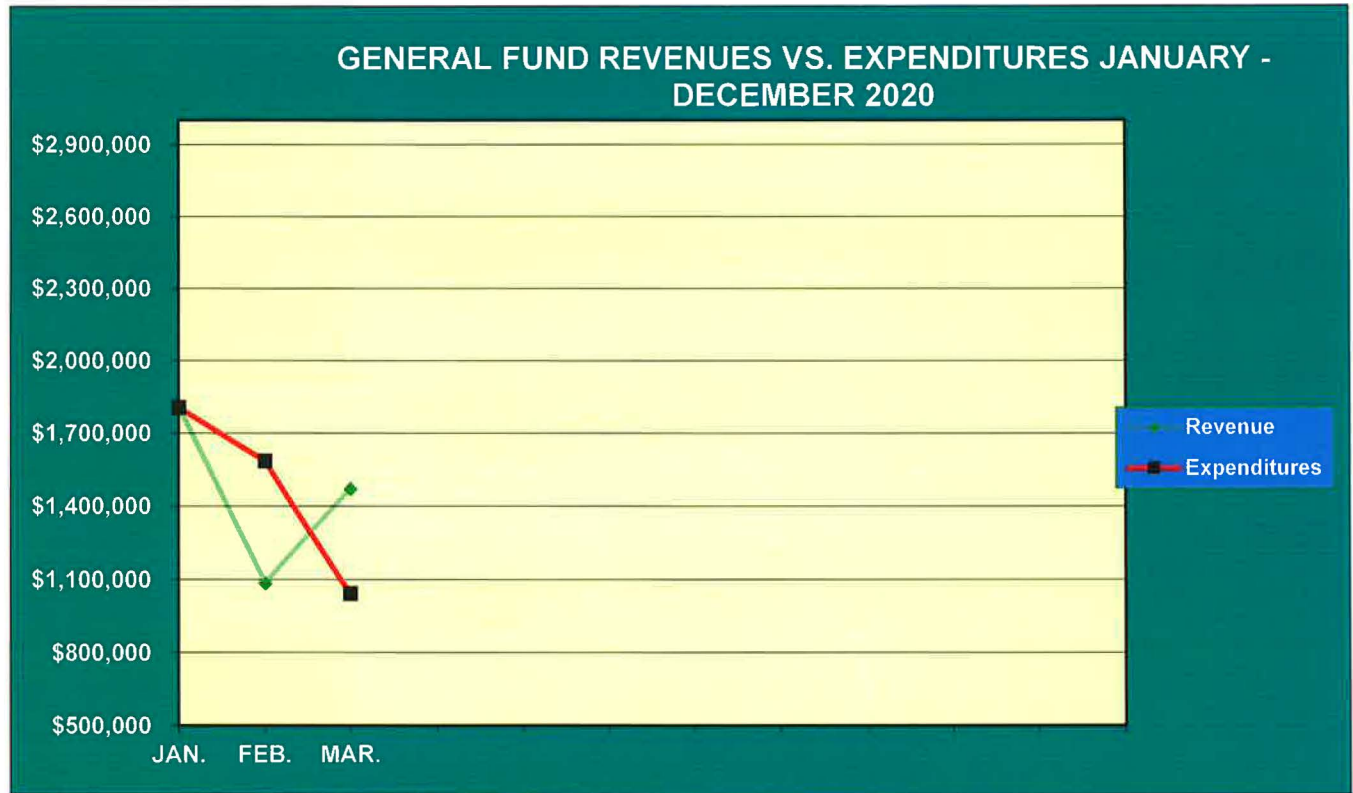
**TOTAL YTD EXPENDITURES BY TYPE**



Total expenditures were \$395,273 higher when compared to YTD March 2020 which relates to the General Fund (higher transfers out of \$600,000), Street Fund (street projects completed in 2019 paid in 2020), and payments for capital related projects which were included in the 2020 capital improvement plan.

**GENERAL FUND**

Through March 2020, General Fund revenues were higher and expenditures lower by \$300,532 and \$271,084 higher, respectively, when compared to YTD March 2019.



General Fund cash balance was \$3,702,237 YTD March 31, 2020 which was \$1,598,132 higher compared to the same period last year. Unencumbered cash (cash less outstanding encumbrances) was \$2,749,817.

**OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS**

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2020:
