B. Gary Johnson

Resident Gary Johnson expressed his frustration with a neighbor's truck having been parked in front of his house for thirty eight days now. He said that he has already spoken with Property Maintenance Inspector Shisler and Chief Adams about it and that he knows Mrs. Shisler has had problems with the neighbor in the past about excess junk in his yard. He further explained his grievances, including he and his wife having trouble seeing to come out of their own driveway because the truck is parked there and is stacked up with junk. He told Council that the neighbor has not been very agreeable and at times threatening when he tried to talk to him about moving the truck. He expressed his doubts as to whether the truck even runs and could be moved on its own. Council and staff asked questions for further details and continued conversation with Mr. Johnson about the situation and what could be done.

C. Cynthia Grim

Madison Township resident Cynthia Grim spoke about an OVI her son was charged with and how she disagrees with the type of field sobriety test that was conducted by the officer at the time of her son's accident. She expressed her thoughts on the modified Romberg test that was given and how she feels it is outdated and inaccurate. She claimed that in the midst of email correspondence with Chief Adams she had received a computer virus. She supplied Council with many emails where she had been in contact with the Ohio Attorney General's office and other entities about her complaints against the City. She informed Council that she is seeking legal action against the City. Council could make no comment because of the impending legal action.
