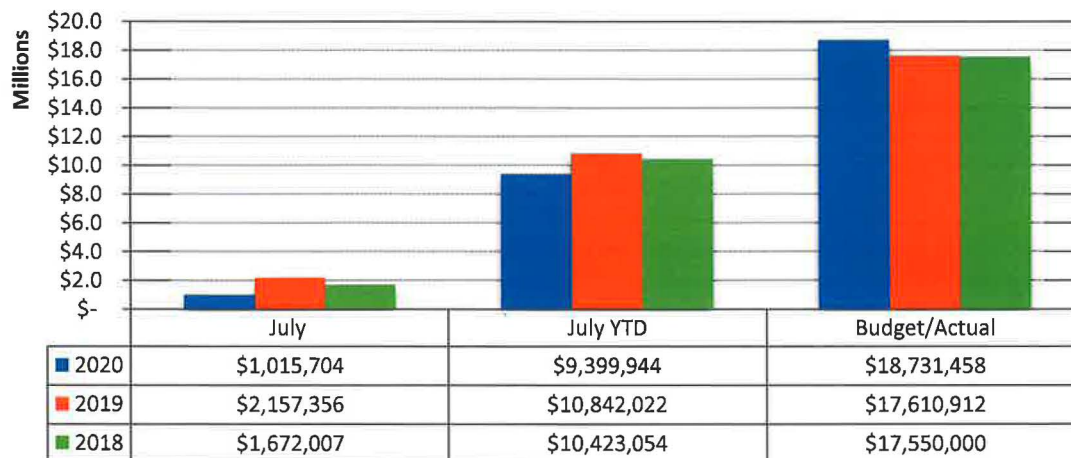

The following is a summary of financial activity for the year-to-date (YTD) July 31, 2020 highlighting the City's total and most significant funds.

FINANCIAL SUMMARY

The following is a summary of the City's financial activity year-to-date July 31, 2020. Total fund balances through July 2020 totaled \$15,742,412, a decrease of \$691,882 from June 30, 2020. The City has collected 50.49% of total budgeted revenue and expended 42.02% of budgeted expenditures. Our current investment portfolio yield is 1.02% and duration is 1.18 years.

INCOME TAX COLLECTIONS – ALL FUNDS



Reconciled gross income tax collections for the year-to-date July 31, 2020 were \$9,399,944, or 50.2% of the 2020 budget and were \$1,442,078, or 13.3% lower when compared to the prior year. Gross income taxes allocated to the General Fund, Rainy Day Fund, Debt Service Fund and Capital Projects Fund totaled \$7,449,956, \$87,500, \$931,244 and \$931,244, respectively.

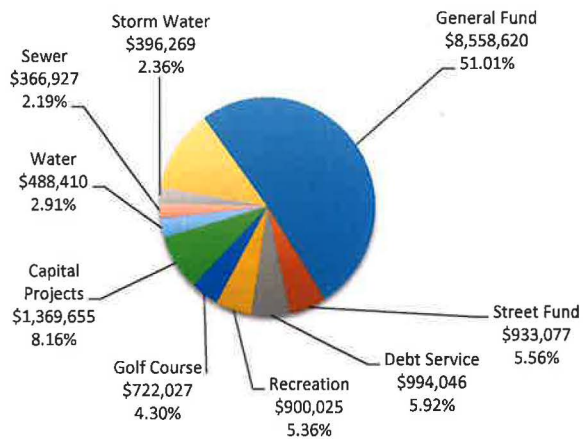
The change from the prior month is primarily attributed to a decrease in net profit payments. The breakdown of collections is as follows:

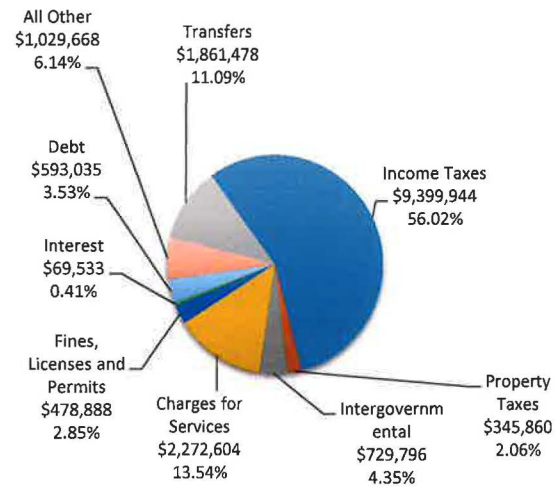
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 56.02% of all revenues. Revenues were \$1,614,297 lower when compared to YTD July 2019 primarily attributed a decrease in income tax collections.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

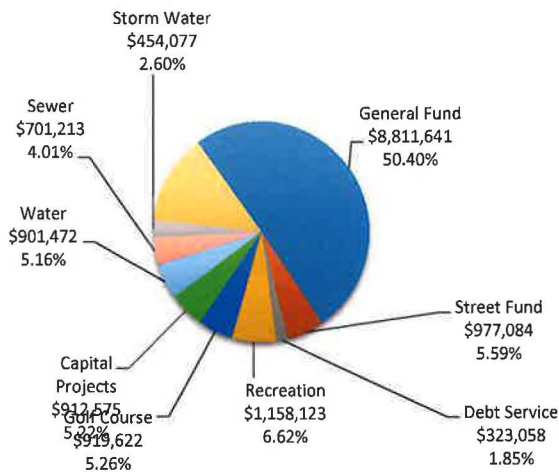


TOTAL YTD REVENUES BY TYPE

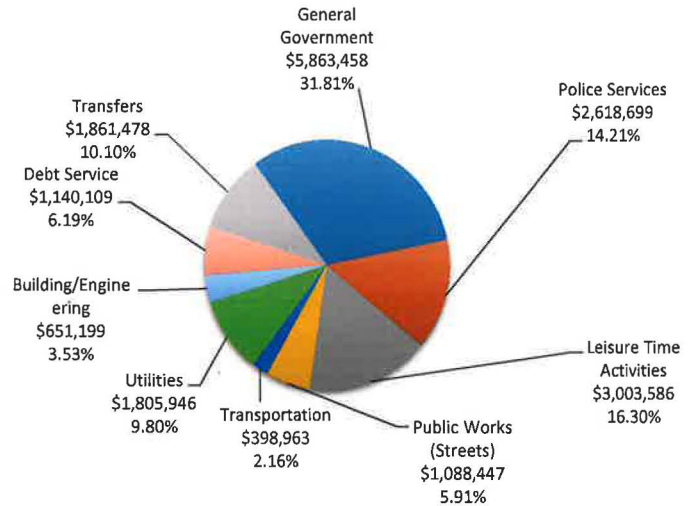

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



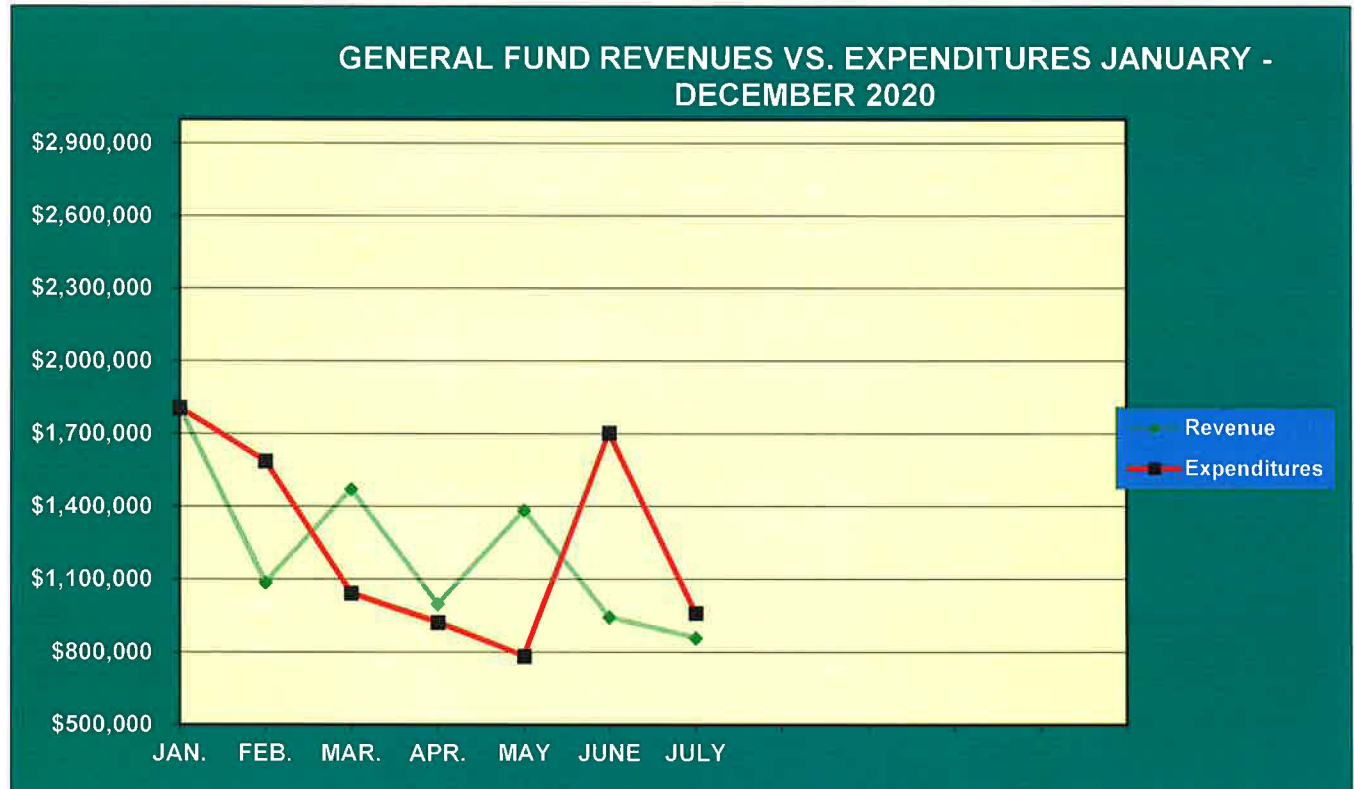
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$659,139 higher when compared to YTD July 2019 which relates to timing of debt service payments and the 2020 capital improvement plan.

GENERAL FUND

Through July 2020, General Fund revenues and expenditures were lower by \$1,393,321 and \$1,166,723, respectively, when compared to YTD July 2019.



General Fund cash balance was \$3,537,299 YTD July 31, 2020 which was \$1,132,547 higher compared to the same period last year. Unencumbered cash (cash less outstanding encumbrances) was \$2,786,289,

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2020:

The Recreation Fund and Golf Course have historically operated at losses. In order to "break-even" annual transfers from the General Fund are necessary. Through the YTD July 2020, Recreation and Golf Course Funds operational receipts are down \$708,999.68 and \$129,618.96, respectively. Based on the current operating environment, we anticipate the need to increase budgeted transfers from the General Fund as these departments are unable to generate sufficient receipts from operations consistent with prior years.
