City Administrator Report to Council BJ King, City Administrator June 13, 2022

Legislation

Res. 2022-001 - Tax Budget - 2023

Each year, the City is required to adopt a Tax Budget for the upcoming year. This resolution represents the 2023 Tax Budget. This resolution will have a public hearing on June 27th and should be read three times. Additionally, this legislation should be referred to the June 20th Committee of the Whole meeting.

Ord.2022-024 - Annual School Resource Officer Agreement

Approval of this ordinance would authorize the Administration to enter into a contract with GMSD for a School Resource Officer for school year 2022-2023. The proposed agreement mirrors the agreement that was in place for school year 2021/2022. The Administration requests passage of this ordinance as an emergency to have it in effect quickly.

Ord. 2022-025 - Code amendment related to fireworks by private residents

Approval of this ordinance would amend our code to prohibit fireworks to be shot by private residents to only the July 4th holiday. Governor Dewine signed House Bill 172, which permits residents to discharge consumer grade fireworks on nine different dates/holidays. House Bill 172 takes effect on July 1. Local municipalities have the authority to limit, via local codes, the discharge of consumer grade fireworks by residents. This ordinance would establish July 4th as the only holiday on which commercial grade fireworks were permitted to be discharged by residents. This ordinance should be referred to the June 20th Committee of the Whole meeting. The Administration will request emergency passage of this ordinance during the June 27th City Council meeting.

Ord. 2022-026 – Establishing employment position as Classified/Unclassified

This ordinance would update our list of Classified/Unclassified positions of employment with the City. There are different hiring practices that have to occur for Classified and Unclassified employees. Positions designated as Classified are subject to a competitive scoring system to establish an eligibility list, which must ultimately be approved by the Personnel Board of Review. With the addition, and abolishment, of positions, it is necessary to update this list, which will serve as a guide for the future when determining the correct hiring process for positions. This ordinance should be referred to the June 20th Committee of the Whole meeting.
