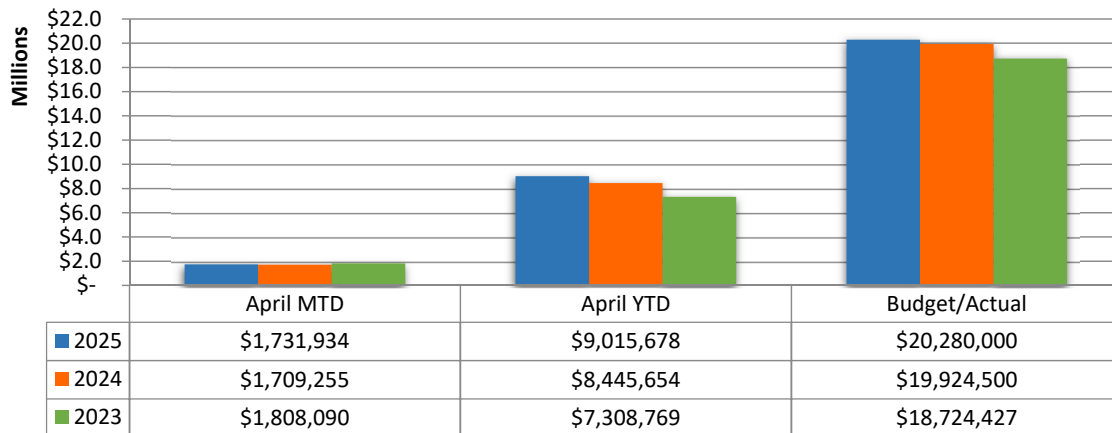

The following is a summary of financial activity for the year-to-date (YTD) April 30, 2025:

FINANCIAL SUMMARY

- General Fund balance was \$21,692,743 at April 30, 2025, or \$4,175,628 higher than April 30, 2024.
- The Recreation Fund and Golf Course have historically operated at losses. In order to “break-even” annual transfers from the General Fund are necessary. Through the YTD April 2025, Recreation and Golf Course Fund operational receipts were lower by \$1,651.11 and \$10,861.08, respectively, when compared to the prior year.
- The City invested an additional \$1,000,000 in StarOhio yielding 4.47% and \$1,316,462 in federal securities yielding 3.625%-4.74%. Interest earnings year-to-date April 2025 were \$486,129, or \$20,830 higher than prior year of \$465,299.

INCOME TAX COLLECTIONS – ALL FUNDS



Income tax collections for the year-to-date April 30, 2025 were \$9,015,678, or 44% of the 2025 budget and were \$570,024, or 7% higher when compared to the prior year.

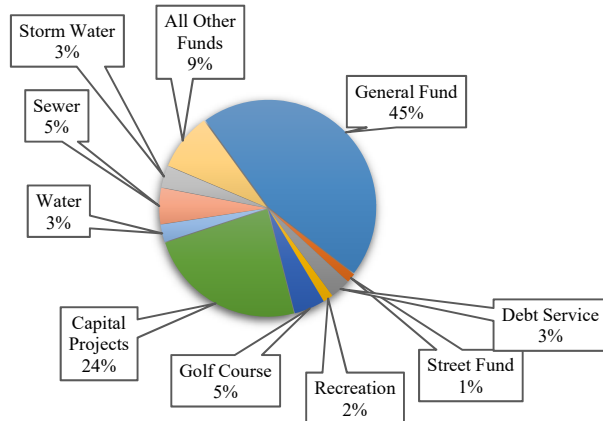

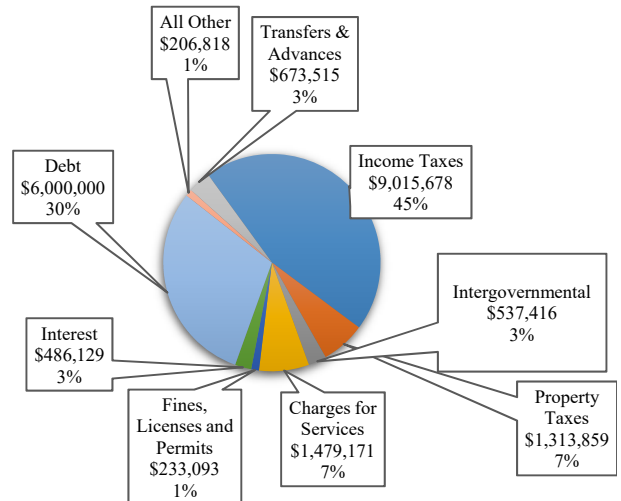
REVENUES

Income tax revenues comprised the largest portion of total revenues year-to-date, or 65% of all revenues exclusive of debt proceeds. Revenues were \$4,155,294 higher when compared to YTD April 2024 primarily attributed to an increase in bond anticipation note proceeds of \$4,000,000 and higher income tax collections between years.

TOTAL YTD REVENUE BY FUND - ALL FUNDS

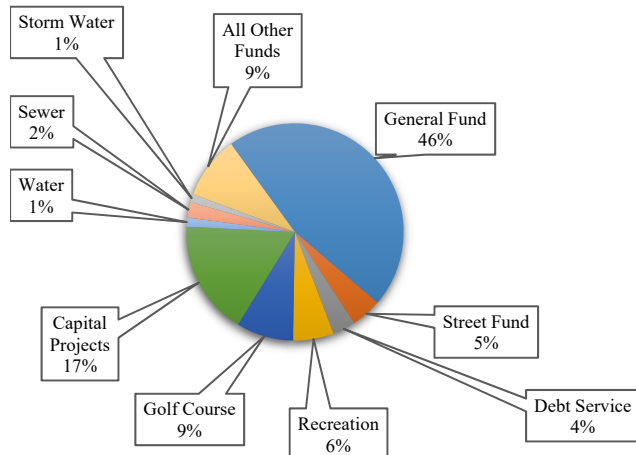


TOTAL YTD REVENUES BY TYPE

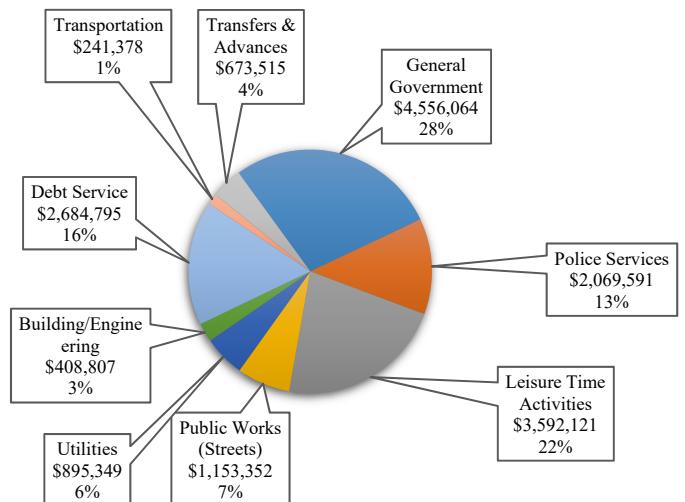

TOTAL YTD EXPENDITURES BY FUND - ALL FUNDS



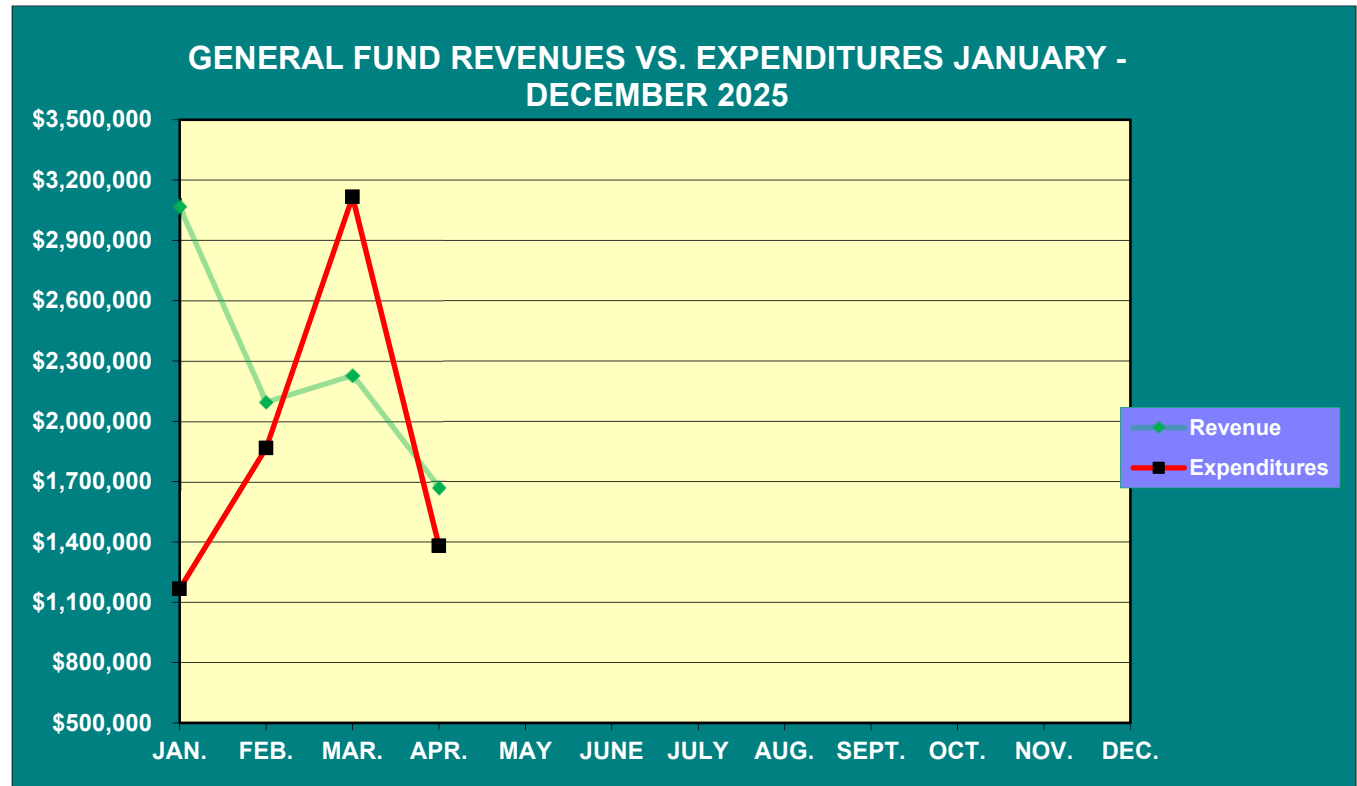
TOTAL YTD EXPENDITURES BY TYPE



Total expenditures were \$2,651,042 higher when compared to YTD April 2024 which was primarily attributed higher salary and benefit costs and higher capital project fund (401) expenditures by \$1,779,807.

GENERAL FUND OPERATIONS

Through April 2025, General Fund revenues were \$602,217 higher and expenditures were \$627,037 higher, respectively when compared to YTD April 2024.



General Fund balance was \$21,692,743 at April 30, 2025, or \$4,175,628 higher than April 30, 2024. Unencumbered cash (cash less outstanding encumbrances) was \$19,890,762.

OPERATING PROFIT/LOSS – SIGNIFICANT FUNDS

The City provides certain services to the community where the revenues generated by these departments are not sufficient to cover operating costs. In order to maintain positive fund balances (and maintain compliance with the Ohio Revised Code) the General Fund transfers revenues received (primarily income taxes) to address these deficits. The following is a summary of financial activity through December 31, 2025:
