SUBJECT: Chief's Award For Excellence

On behalf of the leadership of the Criminal Investigations Division, Detective Josh Gilbert is hereby commended for his exemplary service as part of the successful investigation and prosecution involving drug trafficking in Franklin County.

On June 20, 2014, subsequent to an investigation led by Detective Josh Gilbert, while assigned to the Franklin County Drug Task Force, a search warrant was executed on the residence of Mario Crumpler. As a result, investigators found \$142,000 in cash, an assault rifle bearing a 100-round drum, multiple handguns, marijuana and cocaine. Crumpler was later charged with several counts of trafficking and possession of drugs, with applicable firearm specifications.

The proficiency and dedication displayed throughout this particular case by Detective Gilbert is indicative of the caliber of personnel employed to serve the Franklin County community.
