Administrator Marsha Hall reported the City was able to reduce the medical insurance premium increase through Medical Mutual from 15% to 9.9%. The 2017 Appropriations cover the amount of this increase. Dental insurance premiums will remain the same. Vision premiums increased 5% with no additional increases until 2021.

Trick or Treat night went very well thanks to the Police Department and Town Hall. Moving everything off Main Street by closing off a portion of Front Street made the well-attended event much safer.

Ms. Hall reminded everyone the municipal offices will be closed on Thursday, November 24 and Friday, November 25 for the Thanksgiving holiday.
