AN ORDINANCE AMENDING PART FIVE - GENERAL OFFENSES CODE, CHAPTER 505 ANIMALS AND FOWL, OF THE CODIFIED ORDINANCES OF THE CITY OF GROVEPORT

*Council Member Hilbert clarified that this Ordinance covers situations when animals are part of a City sponsored/supported event. Council Member Hutson commented Blystone Farm no longer allows animals (pets) on their farm due to a recent incident involving the owner's dog's aggressiveness to a patron's dog. Council Member Lockett opposed the legislation. He gave the example of someone bringing their dog to the Arbor Day ceremony the City has each year with the Groveport Elementary children. Mr. Lockett said technically the City would make the person leave since it was a City event. If a person was in the park with their dog while the children planted trees and they just wanted to watch, technically they would have to be asked to leave. He thinks these situations will make it tough to enforce and to ask the City's police officers to enforce it will put them in bad situations. Mr. Lockett thinks this Ordinance is overkill. He thinks the City needs to pick specific events such as, Apple Butter Day, where the event is more self-contained. Administrator Marsha Hall explained this Ordinance does not apply to the City parks; Groveport allows pets in its parks. What it does apply to is the following specific events: the 4th of July celebration, not the parade just the immediate area closed-off for the festivities; Apple Butter Day and KidsFest. As to the Arbor Day event, even though it is City supported, there is no closed-off area. Ms. Hall stated the events this Ordinance is referring to are events where hundreds of people attend within a small closed-off area. Law Director Kevin Shannon interjected the Ordinance states: **The City Administrator shall define the designated event areas at the City sponsored or City supported event where the prohibition set forth in (a) above applies.** Signs would be posted at the entrances prohibiting pets from the closed-off area. Event areas prohibiting pets would be looked into on an individual basis. Applying this statute would be at the discretion of the Administrator. Council Member Beidler asked what recourse the police department has now when situations occur. Chief Portier responded nothing other than asking them to leave. Mr. Shannon noted the City does have a statute regarding pets being on a leash, and another statute regarding owners cleaning up after their pets, which are both enforceable. If someone does not clean up after their pet they could*

be issued a minor misdemeanor citation.

A motion was made by Council Member Hilbert, seconded by Council Member Dildine, to adopt. The motion carried by the following vote:
