#### Legislation

Ord. 18-26 Amend Park Rules to Authorize the Administrator to Permit Food Trucks to be Present at City-sponsored Events in City Parks (2<sup>nd</sup> Reading)

Currently our Zoning Code only permits food trucks as a Conditional Use in the Community Commercial District (see Retail Sales – Mobile Vendors). Both the recreation center and community affairs have expressed an interest in allowing food trucks during certain City-sponsored events. Last year Council approved by motion permitting food trucks, under the discretion of the Administrator, during the Farmers Market season. None of the properties potentially used (Groveport Park, Heritage Park, etc.) reside in a Community Commercial district. We are requesting that Council adopt legislation to amend the Parks Rules to allow food trucks at City-sponsored events in City parks.

## Ord. 18-027 Updating the List of Classified and Unclassified Employees (1st Reading)

This legislation updates the list of unclassified employees, as defined in the City Charter, to include the Personnel Director, Engineer, Director of Transportation, and interns.

## Ord. 18-028 Participation in the ODOT Winter Salt Contract (1st Reading)

We recently received an email from ODOT changing their salt contract process and deadline. The current ordinance language is now the only language that will be acceptable for this contract. We are requesting all three reading of this emergency legislation because the new ordinance must be submitted to ODOT electronically no later than May 18.
