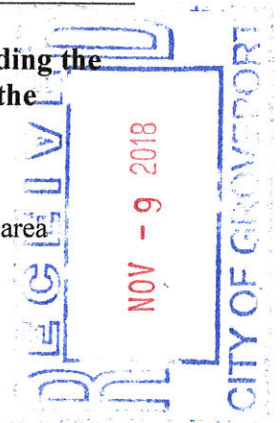

DESCRIPTION

0.346 ACRES

Situated in the Northwest Quarter, Section 21, Township 11, Range 21, Mathews Survey of the Congress Lands, County of Franklin, State of Ohio, City of Groveport, and being part of the 2.296 acres of land (Tract II), conveyed to William Ray McCullough & Doreen McCullough, as recorded in Instrument Number 201611030152213, all references are the records of the Franklin County Recorder, said parcel being further described as follows:

Commencing at a 3/4" O.D. iron pipe found, at the southeast corner of Lot 48 of Founders Bend, Section 2, subdivision, as recorded in Plat Book 95, Page 78-79, said point being the **True Point of Beginning** for the parcel herein described;

Thence, North 04° 05' 38" E, 157.64 feet, along the east line of said Lot 48 and east lines of Lots 47 & 46, of said Founders Bend, Section 2, to an iron pin set;

Thence, across said McCullough parcel, South 85° 54' 22" East, 45.00 feet, to an iron pin set;

Thence, across said McCullough parcel, South 04° 05' 38" West, 335.00 feet, to an iron pin set on the north line of the Russell W. & Susan L. Herr's 42.918 acre parcel, as recorded in Instrument Number 201312160205465;

Thence, North 85° 54' 22" West, 45.00 feet, along the north line of said Herr parcel, to a 3/4" O.D. iron pipe found;

Thence, North 04° 05' 38" East, 177.36 feet, along the east line of said Herr parcel, and east line of Lot 49 of said Founders Bend, Section 2, to the **True Point of Beginning**.

Containing 0.346 acres, more or less, subject to all legal highways, all limitations of public access to highways, leases, zoning regulations, easements of record and restrictive covenants.

Bearings are based on the aforementioned Founders Bend, Section 2, east line being North 04° 05' 38" E
