## **Administrative items**

## - Capital Projects Tracker

Attached to this report is the Capital Projects Tracker. The information included is current as of 4/22/2021. An updated copy of this progress tracker will be included with my report for the second Council meeting of each month.

# - Annual street program

The annual street program is underway. The preconstruction meeting was held on April 20<sup>th</sup> and the contractor started the next day. The schedule provided by the contractor shows the entire program completed by the end of May. This is the second year in a row that we have been able to get the road program completed early in the year.

## **Legislative items**

#### • Ord. 2021-015 - Golf Course - Credit Card Convenience Fees

The Administration requests that this ordinance be amended during the second reading to change the credit card convenience fee to be charged at the golf course to "not to exceed 3%."

## • Ord 2021-017 - C.A. Ventures Economic Development Agreement

C.A. Ventures is pursuing the purchase, and annexation into Groveport, of land located at the intersection of Hayes and Pontius Roads. C.A. Ventures plans to build a 640,000 SF warehouse on the property. Related to this warehouse development, C.A. Ventures has requested a CRA property tax abatement. Approval of Ordinance 2021-017 would authorize the City Administrator to execute an economic development agreement, including the CRA tax abatement, with C.A. Ventures dependent on the successful annexation and rezoning of the subject property.
