The event will be held at the Groveport Madison High School Auditorium with Mr. Lance Westcamp as the Keynote Speaker. He invited all of Council and Groveport High graduates to attend. It would be an honor to him for them to be present at the event.

Council Member Cleary commented he visited the cemetery early to make sure nothing had been missed in the preparations for the event and reported it was very well laid out. He also had visited the cemetery on Hendron Road to find it has been well maintained.
