VI. Business of Guests**a. Deborah Franks - Banning of Dogs**

Deborah Franks of 3710 London-Lancaster Road, Groveport, Ohio addressed Council regarding an article in the Southeast Messenger about someone allowing their dog to do its business in the cemetery and they didn't clean up after their dog during the Apple Butter Day Event. Ms. Franks, a professional dog trainer and canine behavior expert who has taught many seminars on dog training, agreed the act was 100% unacceptable and very disrespectful. What concerns her is that the City of Groveport's Council is considering banning all dogs from City events. Ms. Franks pointed out that City Council has had one letter from one person, the offender should be fined and how does the City keep it from happening when the City is not having an event. Banning dogs from all events will not cure this problem. Ms. Franks

didn't find any laws on dogs for Groveport by doing a Goggle search and thought maybe Groveport was governed by Franklin County's dog laws. Law Director Kevin Shannon advised the City of Groveport has its own criminal code, general offense code, under section 505 of the Groveport Codified Ordinances which specifically addresses the issue that occurred during Apple Butter Day. She was advised to go to Groveport's website and look in the Codified Ordinances for the City of Groveport. She suggests free training seminars could be offered at Town Hall as a public service on the responsibility of canine ownership, understanding canine behavior, and training obedience and behavior. She doesn't know what kind of turn out these courses would attract but she would rather educate the people than ban the dogs. Committee Chair Shawn Cleary stated there was not just one letter. He sits on the Cemetery Committee that had received more than one complaint on the matter. Council Member Dildine commented the classes are a good idea but wants to err on the side of caution. He would never consider taking his 107 pound dog, who has no behavioral issues, to an event such as Apple Butter Day. Council Member Hutson remarked she witnessed two dogs squaring off in the gravel. Neither owner could control their dog where children, food and vendors' wares were present. The situation had the potential to turn ugly. Ms. Franks stated she and her clients take their dogs everywhere. They take the dogs any place that doesn't serve food. Council Member Hilbert commented Ms. Franks made the statement where food is not served and Apple Butter Day is a lot about the food. Ms. Franks said it is not like a Kroger, a restaurant or that type of thing. She thinks it is a mistake to ban all dogs. If the City is going to monitor anyway, monitor the people who are irresponsible and not punish the people who are responsible. Mr. Cleary stated the City has time to look into the matter but he agrees with Mr. Dildine. The event has a lot of food and a lot of people and it only takes one dog to get a bad situation started. Council will settle the matter before the 4th of July Celebration.
