**VI. Business of Guests****a. Marc Studley - Access Storage Ohio Inc.**

*Marc Studley, Access Storage, 5625 Groveport Road, addressed Council on the matter of notices he has received from the Building & Zoning Department regarding a vehicle parked in violation of Groveport's Property Maintenance Code. He moved the vehicle in question to one of his rental properties across the street. After moving the vehicle, the City's Property Maintenance*

Inspector, Courtney Shisler, visited him in his office to inform him the vehicle is parked in the grass and is still in violation of the City's Property Maintenance Code. Last year, Mr. Studley received letters about the weeds and grass growing in the graveled area where the vehicle was originally parked. He cleaned up the graveled area and thought it would be okay to move the truck to the residential property across the street. Then, he not only received a letter for that violation but he was to address a matter of a boat parked in the yard. He has moved the vehicle back to the original spot where it was parked when he received the first letter. Mr. Studley does not want this issue to keep going back and forth between himself and the Building & Zoning Department. Mr. Studley has had no problems for years, which is why he came to address Council. Administrator Marsha Hall will look into the matter and follow up with Mr. Studley.

**b. Roger Studley - Access Storage Ohio Inc.**

While in town, Roger Studley wanted to thank Council Member Ed Rarey for all he has done for the City of Groveport. He thinks Mr. Rarey is a great guy. Mr. Studley stated across the street from Marc Studley's storage business, they have three pieces of property, the largest being approximately 8 acres. At one time, Groveport contemplated putting a truck garage on the lots but eventually found a better location. His concern now is that the people who have looked at the properties for purchase have passed on the lots because the City of Groveport has such strict ordinances on deceleration and acceleration lanes. Mr. Studley was wondering when they get the next purchase offer, if they and City staff could get together and look into why the buyers are going to Obetz or the next community over. Buyers wanted the property but couldn't afford it because of the constraints. Mayor Westcamp assured Mr. Studley the matter will be looked into and staff will follow up with him. Mr. Studley's accolades for Council Member Rarey will be relayed to Mr. Rarey.
