*Mayor Lance Westcamp thanked Chief Portier and Sgt. Casey Adams for the "Stranger Danger" class held at the Town Hall. There were 67 children who participated in the class. Mayor Westcamp asked Sgt. Adams to speculate on the number of people at the Marshmallow Drop. Sgt. Adams reported he would estimate 300 to 400 people. There were cars parked everywhere in the vicinity of Cruiser Park. It meant a lot to Mayor Westcamp to see families from the Newport neighborhood attend the event with their children. Mayor Westcamp announced the 2017 Grand Marshall for the 4th of July Parade will be Terri Christensen.*

*Council Member Hutson commented on the field across from Cruiser Park where the Marshmallow Drop event was held on April 8th. She had been approached by a resident about the City looking into extending parking in that field. During soccer games, cars are parking down in the dip where there are now "no parking" signs. Administrator Hall stated the field can be looked into as a temporary fix, but Columbia Gas will be going through the area with their big pipeline project. Once Columbia Gas completes their pipeline, the City can look into adding extended overflow parking.*

*Council Member Beidler thanked Administrator Hall for taking the time to give him a wonderful tour of Groveport. He noted the very impressive facilities and the incredible positive attitudes of all the employees he had met during the day.*

*Council Member Cleary raised the matter of the COTA sign by the Birch Tavern that reads "This stop will no longer be in service as of May 1, 2017." He believes the sign is misleading, the route is not being discontinued, they are just moving the route's stops. Ms. Hall affirmed COTA has moved some signs; that is also when they will extend the route to stop at the breakfast restaurant.*

*Council Member Dildine commented on the Facebook group "Groveport Neighbors". The group was created for keeping the Groveport community informed on what is happening in their neighborhoods. The page has posted a lot of positive things about the City's workers, projects going on in the City and the Annual Report. The group keeps everyone up-to-date on events such as the two (2) city-wide yard sales, as well as school, church or sports and other non-profit organizations that benefit our children. The page allows City*

*staff to answer questions and/or concerns about anything going on in Groveport. It acts like a watchdog for the community.*
