VI. Business of Guests**a. Dennis Smith - Moose Lodge 1245**

Dennis Smith, 3221 Brice Road, Canal Winchester, thanked Council for the opportunity to come before them. Council is well aware of Mr. Smith's involvement with the Moose Lodge 1245 in Groveport. A couple of weeks ago, the members of the lodge had a vote to change the name from Whitehall Moose Lodge to Groveport Moose Lodge. Mr. Smith and another member were out of state on a Florida relief effort at the time. The result of the vote was not to his satisfaction and, once he returned home, he found out the vote was held illegally per Moose International. When a letter is put out calling for a special meeting only one item can be discussed. That item was to change the name from Whitehall 1245 to Groveport 1245. Someone at the meeting changed the item to naming the lodge to anything they wanted. Mr. Smith said they couldn't just name it anything they wanted. A new meeting will be held for another vote. Mr. Smith feels to name the lodge anything other than Groveport 1245 would be a direct smack in the face to the City of Groveport. The City of Groveport bent over backwards for this lodge when they opened in Groveport and the City has supported the lodge. Mr. Smith is also a member of the Groveport American Legion Post 486. The two organizations have been working together on various events to show that two fraternal organizations can work hand in hand within the same community to benefit Groveport. Hopefully, within the next few months, the lodge will be known as Groveport Moose Lodge 1245. Members will be notified 30 days before the date of the meeting.
