VIII. Reports

A. Mayor - Lance Westcamp

The City's first on-line auction is set to end on this coming Thursday and Friday. Mr. King talked to Brian Strayer and most of the City's items had bids. It will clear up some room in the City's storage facilities. Administration looks to do the on-line auctions on a continual basis. Brian Strayer will setup the auctions and be the point of contact for other departments wanting to dispose of City surplus. Council Member Dildine commented the livestreaming is a big step for a small community like Groveport to provide transparency. He gave a big kudos to everyone who worked on making it happen and to today's technology.
