AN ORDINANCE AUTHORIZING THE ADMINISTRATOR TO APPLY FOR AND ACCEPT A GRANT FROM THE FRANKLIN COUNTY COMMISSION ON AGING SENIOR OPTIONS GRANT PROGRAM FOR THE SENIOR TRANSPORTATION PROGRAM, AND FURTHER AUTHORIZING THE ADMINISTRATOR TO EXECUTE ANY AGREEMENT NECESSARY TO RECEIVE SAID GRANT FUNDING

WHEREAS, the City is desirous of applying for and accepting a grant for the Senior Transportation Program from the Franklin County Commission on Aging Senior Options Grant Program; and,

WHEREAS, it is necessary for the Administrator to execute the Grant Agreement as soon as possible to assure the continued operation of the Senior Transportation Program.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVEPORT, FRANKLIN COUNTY, OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

Section 1: That the Administrator is hereby authorized to apply for and accept a grant from the Franklin County Commission on Aging Senior Options Grant Program and execute any agreement with the Franklin County Commission on Aging necessary to receive said grant funding.

Section 2: That this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
