AN ORDINANCE AUTHORIZING THE ADMINISTRATOR TO ENTER INTO A LEASE AGREEMENT WITH HUNTINGTON PUBLIC CAPITAL CORPORATION TO FINANCE THE PURCHASE OF A STARCRAFT ALLSTAR 12 + 2 SHUTTLE FOR THE TRANSPORTATION DEPARTMENT

WHEREAS, to facilitate the purchase of a Starcraft Allstar 12 + 2 Shuttle from the vendor it is necessary to enter into the stated lease agreement.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVEPORT, FRANKLIN COUNTY, OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

<u>Section 1</u>: That the Administrator is hereby authorized to enter into a Lease Agreement with Huntington Public Capital Corporation to finance the purchase of a Starcraft Allstar 12 + 2 Shuttle for the Transportation Department which will be shared by multiple City departments for various activities.

<u>Section 2</u>: That for the reasons stated in the preamble hereto, which are made a part hereof, this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
