AN ORDINANCE APPROVING THE FINAL PLAT FOR 5770 SALTZGABER ROAD, PAUL HEMMER COMPANIES, APPLICANT (PARCEL NUMBER 185-002541)

WHEREAS, it is necessary that the final plat for 5770 Saltzgaber Road, Paul Hemmer Companies, Applicant (Parcel Number 185-002541) be accepted.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVEPORT, FRANKLIN COUNTY, OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

<u>Section 1</u>: That the final plat for 5770 Saltzgaber Road, (Parcel Number 185-002541) a copy of which is attached hereto and made a part hereof by reference, is hereby approved provided that all of the following conditions set forth by the Planning & Zoning Commission are satisfied:

- 1. Sufficient right-of-way and highway easement shall be dedicated to the City and County, as determined by these agencies, to facilitate City- and County-approved improvements to Saltzgaber Road and the intersection of Saltzgaber Road and Groveport Road.
- 2. Developer shall dedicate by separate deed (in fee simple) to Madison Township the portion of the subject tax parcel PID 185-002541, currently located outside of the City of Groveport corporate limit and within Saltzgaber Road by use. Franklin County Engineer's office shall approve such dedication under separate instrument.
- 3. Final plat shall be signed and sealed by a professional surveyor licensed in the State of Ohio.
