WHEREAS, Council has deemed it necessary to construct an elevated water tank, and;

WHEREAS, it is necessary for the City to issue Requests for Qualifications for the engineering, designing and the estimating of costs for said elevated water tank.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVEPORT, FRANKLIN COUNTY, OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:

<u>Section 1</u>: That the Administrator is hereby authorized to issue requests for qualifications and enter into a contract with the most desirable company or firm, to engineer, design and estimate construction costs for the construction of an elevated water tank.

<u>Section 2</u>: That for the reasons stated in the preamble hereto which are made a part hereof, this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.
