AN ORDINANCE APPROVING THE RECODIFICATION, EDITING, AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF GROVEPORT, OHIO AND THE DECLARATION OF AN EMERGENCY

**WHEREAS**, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Groveport, Ohio; and,

WHEREAS, numerous sections in the Traffic and General Codes need to be updated or enacted in order to comply with State law.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GROVEPORT, FRANKLIN COUNTY, OHIO, A MAJORITY OF ITS MEMBERS CONCURRING:
